DIGEST OF SB 157 (Updated January 22, 2026 2:55 pm - DI 154)

**Citations Affected:** IC 27-1.

**Synopsis:** Disclosures related to prescription drugs. Requires certain pharmacists or pharmacies to provide the amount of the national average drug acquisition cost for a generic drug on the written materials provided to an individual at the point of sale of the generic drug.

**Effective:** July 1, 2026.

## SENATE BILL No. 157

A BILL FOR AN ACT to amend the Indiana Code concerning insurance.

*Be it enacted by the General Assembly of the State of Indiana:*

1       SECTION 1. IC 27-1-24.6-6, AS ADDED BY P.L.216-2025,  
2       SECTION 41, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3       JULY 1, 2026]: Sec. 6. **(a)** A health plan must provide the amount of  
4       the national average drug acquisition cost for a generic drug to the plan  
5       sponsor.  
6       **(b) This subsection does not apply to a hospital licensed under**  
7       **IC 16-21-2, a federally qualified health center (as defined in 42**  
8       **U.S.C. 1396d(l)(2)(B)), or a health facility licensed under IC 16-28.**  
9       **A pharmacist (as defined in IC 27-1-24.5-9) or pharmacy (as**  
10      **defined in IC 27-1-24.5-11) must provide the amount of the**  
11      **national average drug acquisition cost for a generic drug on the**  
12      **written materials provided to an individual at the point of sale of**  
13      **the generic drug.**
