SENATE BILL No. 160

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 35-31.5-2-195.5 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2026]: **Sec. 195.5. "Mask", for purposes of**
4 **IC 35-38-1-7.1, means a covering that obscures or is worn over a**
5 **person's nose or mouth. However, the term does not include the**
6 **following:**
7 (1) **A theater costume worn by a person participating in a**
8 **theater production.**
9 (2) **A covering worn for religious purposes.**
10 (3) **A covering worn for the purposes of occupational safety.**
11 (4) **A medical device, if prescribed by a physician.**
12 (5) **A helmet or similar protective device, if worn by a person**
13 **operating or riding on a motorcycle, a bicycle, a scooter,**
14 **roller skates, or a similar device.**
15 (6) **Equipment worn by a law enforcement officer while**

3 SECTION 2. IC 35-38-1-7.1, AS AMENDED BY P.L.218-2025,
4 SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5 JULY 1, 2026]: Sec. 7.1. (a) In determining what sentence to impose
6 for a crime, the court may consider the following aggravating
7 circumstances:

13 (2) The person has a history of criminal or delinquent behavior.
14 (3) The victim of the offense was less than twelve (12) years of
15 age or at least sixty-five (65) years of age at the time the person
16 committed the offense.

17 (4) The person:

21 (i) was less than eighteen (18) years of age at the time
22 the person committed the offense; and
23 (ii) is not the victim of the offense.

24 (5) The person violated a protective order issued against the
25 person under IC 34-26-5 (or IC 31-1-11.5, IC 34-26-2, or
26 IC 34-4-5.1 before their repeal), a workplace violence restraining
27 order issued against the person under IC 34-26-6, or a no contact
28 order issued against the person.

(6) The person has recently violated the conditions of any probation, parole, pardon, community corrections placement, or pretrial release granted to the person.

32 (7) The victim of the offense was:

33 (A) a person with a disability (as defined in IC 27-7-6-12),
34 and the defendant knew or should have known that the
35 victim was a person with a disability; or
36 (B) mentally or physically infirm.

37 (8) The person was in a position having care, custody, or control
38 of the victim of the offense.

38 of the victim of the offense.
39 (9) The injury to or death of the victim of the offense was the
40 result of shaken baby syndrome (as defined in IC 16-41-40-2) or
41 abusive head trauma.



1 (10) The person threatened to harm the victim of the offense or
2 a witness if the victim or witness told anyone about the offense.

3 (11) The person:

4 (A) committed trafficking with an inmate under
5 IC 35-44.1-3-5; and
6 (B) is an employee of the penal facility.

(12) The person committed the offense with bias due to the victim's or the group's real or perceived characteristic, trait, belief, practice, association, or other attribute the court chooses to consider, including but not limited to an attribute described in IC 10-13-3-1.

12 (13) The person is or has been an alien (as defined by 8 U.S.C.
13 1101(a)) unlawfully present in the United States. A
14 determination by the United States Department of Homeland
15 Security that an alien has come to, entered, or remained in the
16 United States in violation of law is evidence that the alien is or
17 has been unlawfully present in the United States.

18 (14) The offense involved dealing in a controlled substance
19 under IC 35-48-4 and the person distributed the controlled
20 substance to at least three (3) different individuals in a one
21 hundred eighty (180) day period.

(15) The person committed the offense while wearing a mask.

23 (b) The court may consider the following factors as mitigating
24 circumstances or as favoring suspending the sentence and imposing
25 probation:

26 (1) The crime neither caused nor threatened serious harm to
27 persons or property, or the person did not contemplate that it
28 would do so.

29 (2) The crime was the result of circumstances unlikely to recur.
30 (3) The victim of the crime induced or facilitated the offense.
31 (4) There are substantial grounds tending to excuse or justify the

32 crime, though failing to establish a defense.

33 (5) The person acted under strong provocation.
34 (6) The person has no history of delinquency or criminal activity,
35 or the person has led a law-abiding life for a substantial period

36 before commission of the crime.
37 (7) The person is likely to respond affirmatively to probation or
38 short term imprisonment.

39 (8) The character and attitudes of the person indicate that the
40 person is unlikely to commit another crime.

10 (12) The person was convicted of a crime relating to a controlled
11 substance and the person's arrest or prosecution was facilitated
12 in part because the person:
13 (A) requested emergency medical assistance; or
14 (B) acted in concert with another person who requested
15 emergency medical assistance;
16 for an individual who reasonably appeared to be in need of
17 medical assistance due to the use of alcohol or a controlled
18 substance.
19 (13) The person has posttraumatic stress disorder, traumatic
20 brain injury, or a postconcussive brain injury.
21 (14) The person is a person described in IC 31-30-1-4(d) who
22 committed the offense while the person was a child but is now
23 at least twenty-one (21) years of age.
24 (15) The offense involved a controlled substance under
25 IC 35-48-4 and the person:
26 (A) sought treatment:
27 (i) in the three hundred sixty-five (365) day period
28 preceding the date of the commission of the offense; or
29 (ii) on or after the date on which the person committed
30 the offense, but before sentencing; and
31 (B) successfully completed treatment:
32 (i) in the three hundred sixty-five (365) day period
33 preceding the date of the commission of the offense; or
34 (ii) on or after the date on which the person committed
35 the offense, but before sentencing.
36 (c) The criteria listed in subsections (a) and (b) do not limit the
37 matters that the court may consider in determining the sentence.
38 (d) A court may impose any sentence that is:
39 (1) authorized by statute; and
40 (2) permissible under the Constitution of the State of Indiana;
