SENATE BILL No. 160

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 35-31.5-2-195.5 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2026]: **Sec. 195.5. "Mask", for purposes of**
4 **IC 35-38-1-7.1, means a covering that obscures or is worn over a**
5 **person's nose or mouth. However, the term does not include the**
6 **following:**

7 (1) **A theater costume worn by a person participating in a**
8 **theater production.**
9 (2) **A covering worn for religious purposes.**
10 (3) **A covering worn for the purposes of occupational safety.**
11 (4) **A medical device, if prescribed by a physician.**
12 (5) **A helmet or similar protective device, if worn by a person**
13 **operating or riding on a motorcycle, a bicycle, a scooter,**
14 **roller skates, or a similar device.**
15 (6) **Athletic equipment, if worn by a person participating in**

an athletic contest.

(7) Equipment worn by an emergency medical services provider (as defined by IC 16-41-10-1) while acting within the scope of the provider's professional responsibilities.

(8) Equipment worn by a law enforcement officer while acting within the scope of the officer's professional responsibilities.

SECTION 2. IC 35-38-1-7.1, AS AMENDED BY P.L.218-2025,

SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 7.1. (a) In determining what sentence to impose for a crime, the court may consider the following aggravating circumstances:

(1) The harm, injury, loss, or damage suffered by the victim of an offense was:

(A) significant; and

(B) greater than the elements necessary to prove the commission of the offense.

(2) The person has a history of criminal or delinquent behavior.

(3) The victim of the offense was less than twelve (12) years of age or at least sixty-five (65) years of age at the time the person committed the offense.

(4) The person:

(A) committed a crime of violence (IC 35-50-1-2); and

(B) knowingly committed the offense in the presence or within hearing of an individual who:

(i) was less than eighteen (18) years of

the person committed the offense; and

(ii) is not the victim of the offense.

(5) The person violated a protective order issued against the person under IC 34-26-5 (or IC 31-1-11.5, IC 34-26-2, or IC 34-4-5.1 before their repeal), a workplace violence restraining order issued against the person under IC 34-26-6, or a no contact order issued against the person.

(6) The person has recently violated the conditions of any probation, parole, pardon, community corrections placement, or pretrial release granted to the person.

(7) The victim of the offense was:

(A) a person with a disability (as defined in IC 27-7-6-12),

and the defendant knew or should have known that the victim was a person with a disability; or

(B) mentally or physically infirm.

(8) The person was in a position having care, custody, or control

1 of the victim of the offense.
2 (9) The injury to or death of the victim of the offense was the
3 result of shaken baby syndrome (as defined in IC 16-41-40-2) or
4 abusive head trauma.
5 (10) The person threatened to harm the victim of the offense or
6 a witness if the victim or witness told anyone about the offense.
7 (11) The person:
8 (A) committed trafficking with an inmate under
9 IC 35-44.1-3-5; and
10 (B) is an employee of the penal facility.
11 (12) The person committed the offense with bias due to the
12 victim's or the group's real or perceived characteristic, trait,
13 belief, practice, association, or other attribute the court chooses
14 to consider, including but not limited to an attribute described in
15 IC 10-13-3-1.
16 (13) The person is or has been an alien (as defined by 8 U.S.C.
17 1101(a)) unlawfully present in the United States. A
18 determination by the United States Department of Homeland
19 Security that an alien has come to, entered, or remained in the
20 United States in violation of law is evidence that the alien is or
21 has been unlawfully present in the United States.
22 (14) The offense involved dealing in a controlled substance
23 under IC 35-48-4 and the person distributed the controlled
24 substance to at least three (3) different individuals in a one
25 hundred eighty (180) day period.
26 (15) **The person:**
27 (A) committed the offense while wearing a mask; and
28 (B) wore the mask with the intent to intimidate the
29 victim, a witness, or any other person.
30 (b) The court may consider the following factors as mitigating
31 circumstances or as favoring suspending the sentence and imposing
32 probation:
33 (1) The crime neither caused nor threatened serious harm to
34 persons or property, or the person did not contemplate that it
35 would do so.
36 (2) The crime was the result of circumstances unlikely to recur.
37 (3) The victim of the crime induced or facilitated the offense.
38 (4) There are substantial grounds tending to excuse or justify the
39 crime, though failing to establish a defense.
40 (5) The person acted under strong provocation.
41 (6) The person has no history of delinquency or criminal activity,
42 or the person has led a law-abiding life for a substantial period

2 (7) The person is likely to respond affirmatively to probation or
3 short term imprisonment.
4 (8) The character and attitudes of the person indicate that the
5 person is unlikely to commit another crime.
6 (9) The person has made or will make restitution to the victim of
7 the crime for the injury, damage, or loss sustained.
8 (10) Imprisonment of the person will result in undue hardship to
9 the person or the dependents of the person.
10 (11) The person was convicted of a crime involving the use of
11 force against a person who had repeatedly inflicted physical or
12 sexual abuse upon the convicted person and evidence shows that
13 the convicted person suffered from the effects of battery as a
14 result of the past course of conduct of the individual who is the
15 victim of the crime for which the person was convicted.
16 (12) The person was convicted of a crime relating to a controlled
17 substance and the person's arrest or prosecution was facilitated
18 in part because the person:
19 (A) requested emergency medical assistance; or
20 (B) acted in concert with another person who requested
21 emergency medical assistance;
22 for an individual who reasonably appeared to be in need of
23 medical assistance due to the use of alcohol or a controlled
24 substance.
25 (13) The person has posttraumatic stress disorder, traumatic
26 brain injury, or a postconcussive brain injury.
27 (14) The person is a person described in IC 31-30-1-4(d) who
28 committed the offense while the person was a child but is now
29 at least twenty-one (21) years of age.
30 (15) The offense involved a controlled substance under
31 IC 35-48-4 and the person:
32 (A) sought treatment:
33 (i) in the three hundred sixty-five (365) day period
34 preceding the date of the commission of the offense; or
35 (ii) on or after the date on which the person committed
36 the offense, but before sentencing; and
37 (B) successfully completed treatment:
38 (i) in the three hundred sixty-five (365) day period
39 preceding the date of the commission of the offense; or
40 (ii) on or after the date on which the person committed
41 the offense, but before sentencing.
