SB 169 # 3

DIGEST

Implementation. Specifies rules for treating certain statutory and administrative rule references. Provides for the continuing effect of administrative rules adopted under prior law.

1 Page 85, between lines 17 and 18, begin a new paragraph and insert:

2 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
3 repealed and replaced in the same or a different form in the
4 recodification act of the 2026 regular session of the general
5 assembly is treated after the effective date of the new provision as
6 a reference to the new provision.

7 (b) A citation reference in the recodification act of the 2026
8 regular session of the general assembly to another provision of the
9 recodification act of the 2026 regular session of the general
10 assembly is treated as including a reference to the provision of the
11 first lien mortgage lending law that is substantively equivalent to
12 the provision of the recodification act of the 2026 regular session
13 of the general assembly that is referred to by the citation
14 reference."

15 Page 129, between lines 32 and 33, begin a new paragraph and
16 insert:

17 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
18 repealed and replaced in the same or a different form in the
19 recodification act of the 2026 regular session of the general
20 assembly is treated after the effective date of the new provision as
21 a reference to the new provision.

22 (b) A citation reference in the recodification act of the 2026
23 regular session of the general assembly to another provision of the
24 recodification act of the 2026 regular session of the general
25 assembly is treated as including a reference to the provision of the
26 uniform consumer credit code that is substantively equivalent to
27 the provision of the recodification act of the 2026 regular session

1 of the general assembly that is referred to by the citation
2 reference.".

3 Page 263, between lines 26 and 27, begin a new paragraph and
4 insert:

5 **"Sec. 0.7. (a) A reference in a statute or rule to a statute that is**
6 **repealed and replaced in the same or a different form in the**
7 **recodification act of the 2026 regular session of the general**
8 **assembly is treated after the effective date of the new provision as**
9 **a reference to the new provision.**

10 **(b) A citation reference in the recodification act of the 2026**
11 **regular session of the general assembly to another provision of the**
12 **recodification act of the 2026 regular session of the general**
13 **assembly is treated as including a reference to the provision of the**
14 **small loans law that is substantively equivalent to the provision of**
15 **the recodification act of the 2026 regular session of the general**
16 **assembly that is referred to by the citation reference."**

17 Page 277, between lines 1 and 2, begin a new paragraph and insert:

18 **"Sec. 0.7. (a) A reference in a statute or rule to a statute that is**
19 **repealed and replaced in the same or a different form in the**
20 **recodification act of the 2026 regular session of the general**
21 **assembly is treated after the effective date of the new provision as**
22 **a reference to the new provision.**

23 **(b) A citation reference in the recodification act of the 2026**
24 **regular session of the general assembly to another provision of the**
25 **recodification act of the 2026 regular session of the general**
26 **assembly is treated as including a reference to the provision of the**
27 **law concerning mortgage rescue protection fraud that is**
28 **substantively equivalent to the provision of the recodification act**
29 **of the 2026 regular session of the general assembly that is referred**
30 **to by the citation reference."**

31 Page 283, between lines 17 and 18, begin a new paragraph and
32 insert:

33 **"Sec. 0.7. (a) A reference in a statute or rule to a statute that is**
34 **repealed and replaced in the same or a different form in the**
35 **recodification act of the 2026 regular session of the general**
36 **assembly is treated after the effective date of the new provision as**
37 **a reference to the new provision.**

38 **(b) A citation reference in the recodification act of the 2026**
39 **regular session of the general assembly to another provision of the**
40 **recodification act of the 2026 regular session of the general**

1 **assembly is treated as including a reference to the provision of the**
2 **law concerning home loan practices that is substantively equivalent**
3 **to the provision of the recodification act of the 2026 regular session**
4 **of the general assembly that is referred to by the citation**
5 **reference."**

6 Page 303, delete lines 31 through 42, begin a new paragraph and
7 insert:

8 **"SECTION 99. [EFFECTIVE JULY 1, 2026] (a) As used in the**
9 **recodification act of the 2026 regular session of the general**
10 **assembly, a reference to rules adopted under any provision of**
11 **IC 24-4.4, IC 24-4.5, IC 24-5.5, or IC 24-9 or under any other**
12 **provision of the recodification act of the 2026 regular session of the**
13 **general assembly refers to either:**

14 **(1) rules adopted under the recodification act of the 2026**
15 **regular session of the general assembly; or**

16 **(2) rules adopted under the prior law until those rules have**
17 **been amended, repealed, or superseded.**

18 **(b) Rules adopted under prior law continue in effect after June**
19 **30, 2026, until the rules are amended, repealed, or suspended.**

20 **(c) Before January 1, 2028, the department of financial**
21 **institutions and the secretary of state shall amend its rules to**
22 **comply with the changes made by this act.**

23 **(d) This SECTION expires June 30, 2028."**
