MR. SPEAKER:

*Your Committee on Financial Institutions, to which was referred Senate Bill 169, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 85, between lines 17 and 18, begin a new paragraph and insert:
- 2 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
- 3 repealed and replaced in the same or a different form in the
- 4 recodification act of the 2026 regular session of the general
- 5 assembly is treated after the effective date of the new provision as
- 6 a reference to the new provision.
- 7 (b) A citation reference in the recodification act of the 2026
- 8 regular session of the general assembly to another provision of the
- 9 recodification act of the 2026 regular session of the general
- 10 assembly is treated as including a reference to the provision of the
- 11 first lien mortgage lending law that is substantively equivalent to
- 12 the provision of the recodification act of the 2026 regular session
- 13 of the general assembly that is referred to by the citation

1 reference.".

2 Page 129, between lines 32 and 33, begin a new paragraph and
3 insert:

4 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
5 repealed and replaced in the same or a different form in the
6 recodification act of the 2026 regular session of the general
7 assembly is treated after the effective date of the new provision as
8 a reference to the new provision.

9 (b) A citation reference in the recodification act of the 2026
10 regular session of the general assembly to another provision of the
11 recodification act of the 2026 regular session of the general
12 assembly is treated as including a reference to the provision of the
13 uniform consumer credit code that is substantively equivalent to
14 the provision of the recodification act of the 2026 regular session
15 of the general assembly that is referred to by the citation
16 reference.".

17 Page 263, between lines 26 and 27, begin a new paragraph and
18 insert:

19 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
20 repealed and replaced in the same or a different form in the
21 recodification act of the 2026 regular session of the general
22 assembly is treated after the effective date of the new provision as
23 a reference to the new provision.

24 (b) A citation reference in the recodification act of the 2026
25 regular session of the general assembly to another provision of the
26 recodification act of the 2026 regular session of the general
27 assembly is treated as including a reference to the provision of the
28 small loans law that is substantively equivalent to the provision of
29 the recodification act of the 2026 regular session of the general
30 assembly that is referred to by the citation reference.".

31 Page 277, between lines 1 and 2, begin a new paragraph and insert:

32 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
33 repealed and replaced in the same or a different form in the
34 recodification act of the 2026 regular session of the general
35 assembly is treated after the effective date of the new provision as
36 a reference to the new provision.

37 (b) A citation reference in the recodification act of the 2026
38 regular session of the general assembly to another provision of the

1 recodification act of the 2026 regular session of the general
 2 assembly is treated as including a reference to the provision of the
 3 law concerning mortgage rescue protection fraud that is
 4 substantively equivalent to the provision of the recodification act
 5 of the 2026 regular session of the general assembly that is referred
 6 to by the citation reference."

7 Page 283, between lines 17 and 18, begin a new paragraph and
 8 insert:

9 "Sec. 0.7. (a) A reference in a statute or rule to a statute that is
 10 repealed and replaced in the same or a different form in the
 11 recodification act of the 2026 regular session of the general
 12 assembly is treated after the effective date of the new provision as
 13 a reference to the new provision.

14 (b) A citation reference in the recodification act of the 2026
 15 regular session of the general assembly to another provision of the
 16 recodification act of the 2026 regular session of the general
 17 assembly is treated as including a reference to the provision of the
 18 law concerning home loan practices that is substantively equivalent
 19 to the provision of the recodification act of the 2026 regular session
 20 of the general assembly that is referred to by the citation
 21 reference."

22 Page 303, delete lines 31 through 42, begin a new paragraph and
 23 insert:

24 "SECTION 99. [EFFECTIVE JULY 1, 2026] (a) As used in the
 25 recodification act of the 2026 regular session of the general
 26 assembly, a reference to rules adopted under any provision of
 27 IC 24-4.4, IC 24-4.5, IC 24-5.5, or IC 24-9 or under any other
 28 provision of the recodification act of the 2026 regular session of the
 29 general assembly refers to either:

30 (1) rules adopted under the recodification act of the 2026
 31 regular session of the general assembly; or

32 (2) rules adopted under the prior law until those rules have
 33 been amended, repealed, or superseded.

34 (b) Rules adopted under prior law continue in effect after June
 35 30, 2026, until the rules are amended, repealed, or suspended.

36 (c) Before January 1, 2028, the department of financial
 37 institutions and the secretary of state shall amend its rules to
 38 comply with the changes made by this act.

- 1 **(d) This SECTION expires June 30, 2028."**
