**Summary of Legislation:** The bill provides that a taxpayer who is covered by a health insurance plan may deduct from the taxpayer's adjusted gross income an amount equal to the total amount of premiums on the health insurance plan the taxpayer paid for coverage during the taxable year.

**Effective Date:** July 1, 2026.

**Explanation of State Expenditures:** *Department of State Revenue (DOR):* The DOR will incur expenses to put the bill's changes in place. The DOR should be able to make these changes within current resource levels.

**Explanation of State Revenues:** The deduction could reduce state General Fund revenue by an estimated \$114 M to \$176 M annually beginning in FY 2028.

**Additional Information** - The cost of health insurance premiums paid in Indiana in 2024 totaled approximately \$30.4 B. The estimate assumes that 13% to 20% of the premium total is paid by individuals and families, while 80% to 87% of the premium total is paid by employers. The estimate is based on a state income tax rate of 2.9%.

**Explanation of Local Revenues:** The deduction could reduce revenue from local income tax (LIT) by an estimated \$66 M to \$102 M beginning in FY 2028. The estimate is based on an average LIT rate of 1.68%.
