DIGEST OF SB 200 (Updated January 14, 2026 5:01 pm - DI 143)

**Citations Affected:** IC 20-26.

**Synopsis:** Public school matters. Provides that choice of law and certain indemnity provisions contained in contracts entered into, amended, or renewed after June 30, 2026, between a school and a vendor are against public policy and are void and unenforceable. Provides that an organization may submit a grievance to the department of education if a public school refuses to allow the organization to provide information to students under certain conditions.

**Effective:** July 1, 2026.

## SENATE BILL No. 200

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

1       SECTION 1. IC 20-26-5-4.1 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2026]: **Sec. 4.1. (a) This section applies to a vendor contract**  
4 **entered into, amended, or renewed after June 30, 2026.**

5       **(b) As used in this section, "choice of law provision" means a**  
6 **provision, a clause, a covenant, or an agreement that is contained**  
7 **in, collateral to, or affecting a vendor contract that purports to**  
8 **make the vendor agreement subject to the laws of another state.**

9       **(c) As used in this section, "indemnity provision" means a**  
10 **provision, a clause, a covenant, or an agreement that:**

11       **(1) is contained in, collateral to, or affecting a vendor**  
12 **contract; and**

13       **(2) purports to indemnify, defend, or hold harmless, or has the**  
14 **effect of indemnifying, defending, or holding harmless, a**  
15 **vendor against liability for loss or damage resulting from:**

16       **(A) negligence;**

17       **(B) intentional acts; or**

- 1 (C) omissions;  
 2 of the vendor or an agent, employee, servant, or independent  
 3 contractor that is directly responsible to the vendor.  
 4 (d) As used in this section, "vendor contract" means a contract  
 5 between a governing body of a school corporation and a vendor in  
 6 which the vendor promises to provide goods or services.  
 7 (e) Notwithstanding any other law, an indemnity provision in a  
 8 vendor contract under this section is:  
 9 (1) against public policy; and  
 10 (2) void and unenforceable.  
 11 (f) Notwithstanding any other law, a choice of law provision in  
 12 a vendor contract under this section is:  
 13 (1) against public policy; and  
 14 (2) void and unenforceable.  
 15 SECTION 2. IC 20-26-20-4, AS ADDED BY P.L.86-2020,  
 16 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 17 JULY 1, 2026]: Sec. 4. (a) Upon request by an organization under  
 18 section 3 of this chapter, a public school shall provide at least ~~one (1)~~  
 19 **time two (2) times** each school year, a day and time, which may be  
 20 during the school day **or at a time where a majority of students and**  
 21 **their families will be present on school property**, as approved by the  
 22 public school, for the representatives of the organization to provide  
 23 information to students on school property as described in section 3 of  
 24 this chapter.  
 25 (b) An organization may submit a grievance to the department,  
 26 in a manner prescribed by the department, if a public school  
 27 refuses to allow an organization to provide information to students  
 28 on school property as required by subsection (a).
