SENATE BILL No. 200

DIGEST OF SB 200 (Updated January 21, 2026 3:23 pm - DI 149)

Citations Affected: IC 20-26.

Synopsis: Public school matters. Provides that choice of law and certain indemnity provisions contained in contracts entered into, amended, or renewed after June 30, 2026, between a school, including a charter school, and a vendor are against public policy and are void and unenforceable. Provides that an organization may submit a grievance to the department of education if a public school refuses to allow the organization to provide information to students under certain conditions.

Effective: July 1, 2026.

SENATE BILL No. 200

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-26-5-4.1 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2026]: **Sec. 4.1. (a) This section applies to a vendor contract**
4 **entered into, amended, or renewed after June 30, 2026.**

5 **(b) As used in this section, "choice of law provision" means a**
6 **provision, a clause, a covenant, or an agreement that is contained**
7 **in, collateral to, or affecting a vendor contract that purports to**
8 **make the vendor agreement subject to the laws of another state.**

9 **(c) As used in this section, "indemnity provision" means a**
10 **provision, a clause, a covenant, or an agreement that:**

11 **(1) is contained in, collateral to, or affecting a vendor**
12 **contract; and**

13 **(2) purports to indemnify, defend, or hold harmless, or has the**
14 **effect of indemnifying, defending, or holding harmless, a**
15 **vendor against liability for loss or damage resulting from:**

16 **(A) negligence;**

 2 of the vendor or an agent, employee, servant, or independent
 3 contractor that is directly responsible to the vendor.
 4 (d) As used in this section, "vendor contract" means a contract
 5 between a governing body of a school corporation, including a
 6 charter school (as defined in IC 20-24-1-4), and a vendor in which
 7 the vendor promises to provide goods or services.
 8 (e) Notwithstanding any other law, an indemnity provision in a
 9 vendor contract under this section is:
 10 (1) against public policy; and
 11 (2) void and unenforceable.
 12 (f) Notwithstanding any other law, a choice of law provision in
 13 a vendor contract under this section is:
 14 (1) against public policy; and
 15 (2) void and unenforceable.
 16 SECTION 2. IC 20-26-20-4, AS ADDED BY P.L.86-2020,
 17 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 18 JULY 1, 2026]: Sec. 4. (a) Upon request by an organization under
 19 section 3 of this chapter, a public school shall provide at least ~~one (1)~~
 20 **time two (2) times** each school year, a day and time, which may be
 21 during the school day **or at a time where a majority of students and**
 22 **their families will be present on school property**, as approved by the
 23 public school, for the representatives of the organization to provide
 24 information to students on school property as described in section 3 of
 25 this chapter.
 26 (b) An organization may submit a grievance to the department,
 27 in a manner prescribed by the department, if a public school
 28 refuses to allow an organization to provide information to students
 29 on school property as required by subsection (a).
