MR. SPEAKER:

*Your Committee on Education, to which was referred Senate Bill 200, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1 Page 1, between lines 4 and 5, begin a new paragraph and insert:
- 2 **"(b) As used in this section, "automatic renewal provision"**
- 3 **means a provision in a vendor contract that provides for the**
- 4 **automatic renewal of the contract unless the governing body of a**
- 5 **school corporation or the equivalent authority for a charter school**
- 6 **gives notice to the vendor that the school corporation or charter**
- 7 **school intends to terminate the vendor contract at the end of the**
- 8 **contract term."**
- 9 Page 1, line 5, delete "(b)" and insert "(c)".
- 10 Page 1, line 8, delete "(c)" and insert "(d)".
- 11 Page 2, line 3, delete "(d)" and insert "(e)".
- 12 Page 2, line 4, delete ", including a" and insert "**or the equivalent**
- 13 **authority for a charter school"**.
- 14 Page 2, line 5, delete "charter school (as defined in IC 20-24-1-4),".

- 1 Page 2, line 7, delete "(e)" and insert "(f)".
 - 2 Page 2, line 11, delete "(f)" and insert "(g)".
 - 3 Page 2, between lines 15 and 16, begin a new paragraph and insert:
 - 4 **"(h) Notwithstanding any other law, an automatic renewal**
 - 5 **provision in a vendor contract under this section is:**
 - 6 **(1) against public policy; and**
 - 7 **(2) void and unenforceable.**
 - 8 SECTION 2. IC 20-26-5-48 IS ADDED TO THE INDIANA CODE
 - 9 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 - 10 1, 2026]: **Sec. 48. If a public school, including a charter school,**
 - 11 **allows a postsecondary educational institution to provide**
 - 12 **information regarding postsecondary education or training to**
 - 13 **students of the public school, the public school shall allow military**
 - 14 **personnel to provide, in the same manner as the postsecondary**
 - 15 **educational institution, information regarding educational**
 - 16 **opportunities and financial education benefits available for service**
 - 17 **in the armed forces, national guard, or reserve component of the**
 - 18 **armed forces or national guard."**
 - 19 Page 2, line 19, reset in roman "one (1)".
 - 20 Page 2, line 20, reset in roman "time".
 - 21 Page 2, line 20, delete "two (2) times".
 - 22 Renumber all SECTIONS consecutively.
