MR. SPEAKER:

I move that Engrossed Senate Bill 227 be amended to read as follows:

- 1 Page 4, after line 13, begin a new paragraph and insert:
- 2 "SECTION 3. IC 35-45-10-6, AS ADDED BY P.L.107-2017,
- 3 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2026]: Sec. 6. **(a)** A person who:
- 5 **(1)** operates an unmanned aerial vehicle in a manner that is
- 6 intended to subject another person to harassment;
- 7 **(2) operates an unmanned aerial vehicle over the property of**
- 8 **another person:**
- 9 **(A) without the consent of the other person; and**
- 10 **(B) with the intent to:**
- 11 **(i) harass, disturb, or injure an individual or animal; or**
- 12 **(ii) damage or disturb a crop;**
- 13 **on the other person's property;**
- 14 **(3) knowingly or intentionally disperses any substance from**
- 15 **an unmanned aerial vehicle onto the property of another**
- 16 **person without the consent of the other person;**
- 17 **(4) recklessly, knowingly, or intentionally flies an unmanned**
- 18 **aerial vehicle within one hundred (100) feet of an agricultural**
- 19 **building located on the property of another person without**
- 20 **the consent of the other person; or**
- 21 **(5) recklessly, knowingly, or intentionally operates an**
- 22 **unmanned aerial vehicle:**

1 **(A) over the property of another person; and**
 2 **(B) without the consent of the other person;**
 3 **in a manner that interferes with or endangers another**
 4 **aircraft or unmanned aerial vehicle;**
 5 commits remote aerial harassment, a Class A misdemeanor. However,
 6 the offense is a Level 6 felony if the person has a prior unrelated
 7 conviction under this section.
 8 **(b) It is a defense to a prosecution under this section that the**
 9 **prohibited act was:**
 10 **(1) the result of a mechanical or electronic failure; or**
 11 **(2) necessary to avoid a greater harm.**
 12 **(c) It is a defense to a prosecution under subsection (a)(3) that:**
 13 **(1) the substance came onto the property of a person owning**
 14 **or occupying adjacent property as the result of unintentional**
 15 **overspray; and**
 16 **(2) the person took reasonable good faith precautions to**
 17 **minimize the amount of overspray."**
 18 Renumber all SECTIONS consecutively.
