SENATE BILL No. 228

DIGEST OF SB 228 (Updated January 22, 2026 9:27 am - DI 140)

Citations Affected: IC 36-10.

Synopsis: Midwest continental divide commission. Makes the following changes to the law regarding the Midwest continental divide commission (commission): (1) Amends the definition of a "land use and zoning plan" (plan) to provide that it is a plan and not an overlay district. (2) Requires the commission to consider any change or variance in zoning to be consistent with the plan that is: (A) inconsistent with the plan; and (B) not more than 1/2 mile from a trail project approved by the commission and the eligible county or city.

Effective: July 1, 2026.

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-10-16-12, AS ADDED BY P.L.141-2025,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 12. As used in this chapter, "land use and zoning
4 plan" means the **land use and** zoning ~~overlay~~ **district plan** adopted by
5 the eligible county with the formation of the district.

6 SECTION 2. IC 36-10-16-17, AS ADDED BY P.L.141-2025,
7 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
8 JULY 1, 2026]: Sec. 17. (a) The commission may be established by the
9 legislative body of an eligible:

10 (1) county; and
11 (2) city;

12 upon the adoption of an ordinance approved by both bodies
13 establishing the commission.

14 (b) The ordinance establishing the commission shall designate the
15 boundaries of the Midwest continental divide district, if the legislative
16 bodies determine the following:

1 support development across jurisdictions.

2 (2) The district's efforts enhance the quality of life, create cultural

3 amenities, and preserve key land and natural resources in at least

4 one (1) eligible unit, a reservation site, and the surrounding

5 region.

6 (3) The existence of a development plan for the district that

7 includes the development of a trail project and that identifies the

8 trail project's objectives in a clearly focused and measurable

9 fashion.

10 (4) The district's designation would catalyze new developments

11 and attractions and improve tourism and the tourism industry in

12 the eligible county and Indiana.

13 (5) The district's efforts would enhance a state park and a state

14 nature preserve in the eligible county.

15 The commission, from time to time, may petition the legislative body

16 of the eligible county and eligible city, as applicable, to expand the

17 boundaries of the district inside the respective jurisdictions.

18 (c) The ordinance establishing the commission shall also:

19 (1) approve a land use and zoning plan for the district; and

20 (2) provide that any change or variance in ~~the land use and zoning~~

21 ~~that is:~~

22 (A) **inconsistent with the land use and zoning plan; and**

23 (B) **not more than one-half (1/2) mile from a trail project**

24 **approved by the commission and the eligible county or**

25 **city, as applicable;**

26 ~~plan requires shall be considered consistent with the land use~~

27 ~~and zoning plan by the approval of the commission.~~

28 (d) The commission shall notify the state budget agency in writing

29 promptly after the commission is established.
