DIGEST OF PROPOSED AMENDMENT

Study committee. Removes all language in the bill and urges the legislative council to assign to the interim study committee on education the task of studying the issue of South Bend Community school corporation governance.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

~~Sec. 1. As used in this chapter, "commission" means the governing body nominating commission established by section 7 of this chapter:~~

~~Sec. 2. As used in this chapter, "fiscal body" has the meaning set forth in IC 36-1-2-6:~~

~~Sec. 3. IC 20-23-8 does not apply to the South Bend Community school corporation or the governing body of the South Bend Community school corporation:~~

~~Sec. 4. (a) Beginning July 1, 2026, the governing body of the South Bend Community school corporation consists of seven (7) members appointed by the secretary of education from a list of individuals nominated under section 9 of this chapter:~~

~~(b) An individual appointed under this section serves a four (4) year term:~~

~~(c) A member of the governing body serves at the pleasure of the appointing authority:~~

~~(d) A member of the governing body may be reappointed to successive terms:~~

~~Sec. 5. The governing body serving on June 30, 2026, shall become on July 1, 2026, an advisory board to the governing body described in section 4 of this chapter. The members of the governing body serving on June 30, 2026, shall on July 1, 2026, become the members of the advisory board. Each member shall serve on the advisory board until the term for which the member was elected before July 1, 2026, expires or until the term terminates under section 6 of this chapter. When the terms of all members of the advisory board have expired, or terminated under section 6 of this chapter, the advisory board is abolished. The advisory board shall not possess any of the power and duties of the governing body. A member of the advisory board may receive compensation for serving on the advisory board:~~

~~Sec. 6. (a) If an individual seeks a nomination for appointment by the secretary of education to one (1) of the positions of the governing body described in section 4 of this chapter, the following apply:~~

~~(1) An individual seeking a nomination for appointment by the secretary of education to the governing body shall submit~~



~~a resume to the commission at a time and in a manner determined by the commission.~~

~~(2) An individual described in this subsection must reside within the boundaries of St. Joseph County.~~

~~(b) A member of the advisory board described in section 5 of this chapter may seek a nomination for appointment under subsection (a). However, an advisory board member's term shall immediately terminate upon seeking a nomination for appointment.~~

~~Sec. 7. (a) There is established a governing body nominating commission.~~

~~(b) The fiscal body shall provide all facilities, equipment, supplies, and services necessary for the administration of the duties imposed upon the commission. The members of the commission shall serve without compensation. However, the fiscal body shall reimburse members of the commission for their actual expenses incurred in performing their duties.~~

~~Sec. 8. (a) The commission consists of the following nine (9) members:~~

~~(1) One (1) member appointed by the mayor of South Bend, who resides within the boundaries of the South Bend Community school corporation.~~

~~(2) One (1) member appointed by the St. Joseph County board of commissioners.~~

~~(3) One (1) member appointed by the South Bend Education Alliance who resides within the boundaries of the South Bend Community school corporation.~~

~~(4) One (1) member appointed by the Community Foundation of St. Joseph County.~~

~~(5) One (1) member of the Ivy Tech Community College state board of trustees appointed by the Ivy Tech Community College state board of trustees.~~

~~(6) One (1) member appointed by the South Bend Regional Chamber of Commerce, who resides within the boundaries of the South Bend Community school corporation.~~

~~(7) One (1) member appointed by the South Bend-Elkhart Regional Partnership, who resides within the boundaries of the South Bend Community school corporation.~~

~~(8) One (1) member appointed by the Home Builders Association of St. Joseph Valley, who resides within the boundaries of the South Bend Community school corporation.~~
