A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 7.1-2-3-33, AS AMENDED BY P.L.49-2020,
2 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 33. The commission is authorized to:
4 (1) investigate a violation of; and
5 (2) enforce a penalty for a violation of;

9 SECTION 2. IC 7.1-5-7-18 IS ADDED TO THE INDIANA CODE

12 **police powers and duties may engage an individual who is:**

19 agent reasonably believed that the person was intoxicated or was
20 otherwise not entitled to be served an alcoholic beverage **or a product**
21 **containing THC (tetrahydrocannabinol).**

22 (c) After charges have been filed against a person for a violation
23 of subsection (a), the prosecuting attorney shall notify the commission

9 may not assert a claim for damages for personal injury or death against
10 a person who furnished an alcoholic beverage **or a product containing**

 11 **Sec. 5. As used in this article, "drug store" has the meaning set**
 12 **forth in IC 7.1-1-3-15.**
 13 **Sec. 6. As used in this article, "low THC hemp extract" has the**
 14 **meaning set forth in IC 35-48-1.1-27.**
 15 **Sec. 7. As used in this article, "restricted grocery store" means**
 16 **a retail establishment that:**
 17 **(1) is primarily engaged in the retail sale of a general food**
 18 **line that includes:**
 19 **(A) canned and frozen foods;**
 20 **(B) fresh fruits and vegetables;**
 21 **(C) fresh and prepared meat, fish, and poultry;**
 22 **(D) groceries or gourmet foods in combination with**
 23 **general lines of new merchandise, including apparel,**
 24 **furniture, and appliances; or**
 25 **(E) specialty or gourmet foods; and**
 26 **(2) has a retail premises that is at least three thousand five**
 27 **hundred (3,500) square feet.**
 28 **Chapter 1.5. Craft Hemp Permits**
 29 **Sec. 1. (a) The holder of a permit issued under this article shall**
 30 **keep and maintain all invoices of craft hemp that is purchased or**
 31 **acquired. Each invoice must contain the following information:**
 32 **(1) The permit numbers of each party in a transaction.**
 33 **(2) The transaction date or dates.**
 34 **(3) The expiration date or dates of each permit holder's**
 35 **permit or permits.**
 36 **(4) Each permit holder's address.**
 37 **(b) The holder of a permit issued under this article must:**
 38 **(1) keep the invoices described in subsection (a) on the**
 39 **permit holder's premises; and**
 40 **(2) make the invoices described in subsection (a) available for**
 41 **inspection by the commission.**

 2 **exchange for consideration craft hemp directly to a consumer for**
 3 **consumption off the permitted premises without a valid craft hemp**
 4 **retail permit issued by the commission.**

5 **(b) The commission may issue not more than twenty thousand**
 6 **(20,000) craft hemp retail permits.**

7 **(c) The commission may issue a restricted craft hemp retail**
 8 **permit to a drug store or restricted grocery store authorizing the**
 9 **sale of one (1) or more of the following:**

10 **(1) A product containing not more than three-tenths of one**
 11 **percent (0.3%) total THC (tetrahydrocannabinol).**

12 **(2) A beverage described in IC 35-31.5-2-68.9(a)(4)(C).**

13 **(d) The commission may issue a craft hemp retail permit to a**
 14 **convenience store.**

15 **(e) A craft hemp retail permit may be issued only to a person**
 16 **who owns or operates premises consisting of a permanent building**
 17 **or structure where the craft hemp is sold or distributed.**

18 **(f) A craft hemp retail permit holder may only purchase craft**
 19 **hemp from a craft hemp manufacturer permit holder or a craft**
 20 **hemp distributor permit holder.**

21 **(g) A person who is a craft hemp retail permit holder and a**
 22 **retail alcoholic beverage permit holder may serve craft hemp**
 23 **beverages in the original container for consumption on the**
 24 **permitted premises.**

25 **Sec. 2. (a) A person who desires a craft hemp retail permit**
 26 **under this chapter must provide the following to the commission:**

27 **(1) The applicant's name and mailing address and the**
 28 **address of the premises for which the permit is being issued.**

29 **(2) A fee of one thousand dollars (\$1,000) for each retail**
 30 **location.**

31 **(3) The name under which the applicant transacts or intends**
 32 **to transact business.**

33 **(4) The address of the applicant's principal place of business**
 34 **or headquarters, if any.**

35 **(5) The statement required under section 4 of this chapter.**

36 **(6) If the applicant is applying for a new permit under**
 37 **section 6 of this chapter, a copy of each of the following:**

38 **(A) If the new ownership of the business is a business**
 39 **entity, the articles of incorporation, articles of**
 40 **organization, or any other formation documents of the**

- either:
 - (i) the sales or purchase agreement; or
 - (ii) an affidavit signed by the applicant concerning the sale or purchase, on a form prescribed by the commission, that includes the name and address of the seller and purchaser.

(C) The permit held by the previous ownership of the business.

(b) A separate craft hemp retail permit is required for each location where the craft hemp is sold or distributed. A retail establishment may not hold more than one (1) active craft hemp retail permit for a retail location at any time.

(c) A craft hemp retail permit holder shall conspicuously display the holder's permit on the holder's premises where the craft hemp is sold or distributed.

(d) Any intentional misstatement or suppression of a material fact in an application filed under this section constitutes grounds for denial of the craft hemp retail permit.

(e) A craft hemp retail permit may be issued only to a person who meets the following requirements:

- (1) If the person is an individual, the person must be at least twenty-one (21) years of age.
- (2) The person must be authorized to do business in Indiana.
- (3) The person has not had an interest in a permit revoked by the commission for that business location within the preceding one (1) year.

(f) The fees collected under this section shall be deposited in the enforcement and administration fund under IC 7.1-4-10.

Sec. 3. (a) Subject to available resources, the commission shall not issue a craft hemp retail permit, except as otherwise authorized in this title and subject to the other restrictions contained in this title, to the following persons:

- (1) A person who does not have lawful status (as defined in IC 9-13-2-92.3).
- (2) A person who has been convicted within five (5) years before the date of application of:
 - (A) a federal crime having a sentence of at least one (1) year;
 - (B) a Level 1, Level 2, Level 3, Level 4, or Level 5 felony; or
 - (C) a crime in a state other than Indiana having a penalty equal to the penalty for an Indiana Level 1,

Level 2, Level 3, Level 4, or Level 5 felony.
 However, this subdivision does not apply to a conviction that has been expunged under IC 35-38-9.

(3) A person who does not meet at least one (1) of the following descriptions:

- (A) The person owns the premises to which the permit will be applicable.
- (B) The person has a valid lease on the premises:
 - (i) at the time of the application for a permit; and
 - (ii) for the duration of the period in which the person sells or distributes in the manner described in section 1 of this chapter.
- (C) The person has a franchise agreement with a franchisor:
 - (i) that owns the premises to which the permit will be applicable; or
 - (ii) that has a bona fide lease on the premises for the full period for which the permit is to be issued.

(4) A person whose place of business is conducted by a manager or agent, unless the manager or agent possesses the same qualifications required for the issuance of a craft hemp retail permit to the person.

(5) A minor.

(6) A person non compos mentis.

(7) A person who has held a permit under this article or a permit under this title and who has had that permit under this article or this title, as applicable, revoked within one (1) year prior to the date of application for a craft hemp retail permit.

(8) A person who has made an application for a permit under this article or a permit of any type under this title that has been denied less than one (1) year prior to the person's application for a craft hemp retail permit unless the first application was denied by reason of a procedural or technical defect.

(b) Subsection (a)(5) does not prevent a minor from being a stockholder in a corporation.

Sec. 4. An application for a craft hemp retail permit must contain the express statement of the applicant that the applicant consents for the duration of the permit term (if the commission issues the permit to the applicant) to the entrance, inspection, and search by an enforcement officer, without a warrant or other

 2 applicant is complying with the provisions of this title. The consent
 3 required by this section is renewed and continued by the retention
 4 of a permit or the permit's use by the applicant or the applicant's

6 **Sec. 5. (a) A craft hemp retail permit issued by the commission**
 7 **under this chapter must contain the following information:**

8 (1) The permit number.

9 (2) The permit holder's name.

10 (3) The permanent location of the business for which the
 11 permit is issued.

12 (4) The expiration date of the permit.

13 (b) A craft hemp retail permit is:

14 (1) valid for two (2) years after the date of issuance, unless
 15 the commission suspends the permit; and

16 (2) nontransferable.

17 (c) A craft hemp retail permit may be renewed. The fee for
 18 renewing a permit is one thousand dollars (\$1,000) for each retail
 19 location.

20 **Sec. 6. If the majority of the ownership of a business that is a**
 21 **craft hemp retail permit holder is sold or transferred:**

22 (1) the new ownership of the business must apply for a new
 23 permit under section 2 of this chapter; and

24 (2) the permit and the permit number held by the previous
 25 ownership of the business are void ninety (90) days after the
 26 date of the sale or transfer of the ownership of the business.

27 **Sec. 7. The commission may adopt rules under IC 4-22-2 to**
 28 **establish procedures for the issuance, renewal, and reinstatement**
 29 **of a craft hemp retail permit.**

30 **Sec. 8. (a) Subject to subsection (b), the commission may**
 31 **suspend the craft hemp retail permit of a person who fails to pay**
 32 **a civil penalty imposed by the commission.**

33 (b) Before enforcing the imposition of a civil penalty or
 34 suspending or revoking a craft hemp retail permit under this
 35 chapter, the commission shall provide written notice of the alleged
 36 violation to the permit holder and conduct a hearing. The
 37 commission shall provide written notice of the civil penalty or
 38 suspension or revocation of a permit to the permit holder.

39 (c) Subject to subsection (b), the commission shall revoke the
 40 craft hemp retail permit of a person upon a finding by a
 41 preponderance of the evidence that the person:

11 **(b) The failure to pay a civil penalty described in subsection (a)**

12 **is a Class B infraction.**

13 **(c) If a craft hemp retail permit has been revoked, the**

14 **commission may not reinstate or renew the permit for at least one**

15 **hundred eighty (180) days after the date of revocation. The**

16 **commission may reinstate or renew the permit only upon a**

17 **reasonable showing by the applicant that the applicant shall:**

- 18 (1) exercise due diligence in the sale of craft hemp on the
- 19 applicant's premises where the craft hemp is sold or
- 20 distributed; and
- 21 (2) properly supervise and train the applicant's employees or
- 22 agents in the handling and sale of craft hemp.

23 **If a permit is reinstated or renewed, the applicant of the permit**

24 **shall pay an application fee of one thousand dollars (\$1,000).**

25 **Sec. 10. The commission may mitigate civil penalties imposed**

26 **against a craft hemp retail permit holder for violating IC 7.1-8-5-2,**

27 **IC 7.1-8-8-2, IC 35-46-1-11.7, or any of the provisions of this**

28 **chapter if the permit holder provides a training program for the**

29 **permit holder's employees that includes at least the following**

30 **topics:**

- 31 (1) Laws governing the sale of craft hemp.
- 32 (2) Methods of recognizing and handling customers who are
- 33 less than twenty-one (21) years of age.
- 34 (3) Procedures for proper examination of identification cards
- 35 to verify that customers are less than twenty-one (21) years
- 36 of age.

37 **Sec. 11. A craft hemp retail permit holder shall exercise due**

38 **diligence in the supervision and training of the permit holder's**

39 **employees or agents in the handling and sale of craft hemp on the**

40 **permit holder's retail premises.**

41 **Sec. 12. (a) An employee of a craft hemp retail permit holder**

 25 or law enforcement officer, produce to the excise officer or law
 26 enforcement officer or to the office of the commission satisfactory
 27 evidence of a license or identification card issued to the employee
 28 that was valid at the time the employee was unable to show the

30 (d) If an employee who is unable to show a license,
 31 identification card, or copy to an excise officer or law enforcement
 32 officer fails to produce satisfactory evidence within five (5) days in

 34 impose a civil penalty on the permit holder.

35 Sec. 13. (a) If a craft hemp retail permit holder fails to attend
 36 or participate in a hearing without good cause, the hearing judge
 37 may recommend to the commission that the commission suspend
 38 or revoke the permit holder's permit or impose a fine on the permit
 39 holder of up to one thousand dollars (\$1,000).

40 (b) A hearing judge may grant a continuance of a hearing
 41 upon written motion showing good cause for the continuance.

 20 **retail location is within one thousand (1,000) feet of a private**

23 **(b) If a retailer provides the commission with documentation**
 24 **that establishes that craft hemp was offered for sale at a retail**
 25 **location before January 1, 2026, the retail location may sell craft**
 26 **hemp even if it is within one thousand (1,000) feet of a school.**

27 **Chapter 3. Craft Hemp Distributor Permits**

28 **Sec. 1. (a) A person may not distribute craft hemp to a retailer**
 29 **without a valid craft hemp distributor permit issued by the**
 30 **commission. A craft hemp distributor permit holder may sell craft**
 31 **hemp to a craft hemp retail permit holder.**

32 **(b) A craft hemp distributor permit does not authorize a**
 33 **person to sell craft hemp products directly to a consumer.**

34 **(c) A craft hemp distributor permit holder must purchase**
 35 **craft hemp from a craft hemp manufacturer permit holder or from**
 36 **an out-of-state craft hemp supplier permit holder.**

37 **(d) A craft hemp distributor permit may be issued only to a**
 38 **person who owns or operates premises consisting of a permanent**
 39 **building or structure from which the craft hemp is distributed.**

40 **Sec. 1.5. (a) A person located outside of Indiana may not**
 41 **distribute craft hemp to a person located within Indiana without**
 42 **a valid out-of-state craft hemp supplier permit issued by the**

Chapter 6. Manufacturing Facilities

Sec. 1. (a) A craft hemp manufacturer must submit any proposed craft hemp packaging to the commission for preapproval before delivering or causing delivery of craft hemp to a craft hemp retail establishment.

(b) If the commission does not issue a denial under subsection (a) within thirty (30) days, the packaging is deemed approved and eligible for sale.

Chapter 7. Advertising

Sec. 1. (a) The commission shall have the power to regulate and prohibit advertising, signs, displays, posters, and designs intended to advertise craft hemp or the place where craft hemp is sold.

(b) The commission shall not exercise the prohibition power contained in subsection (a) for any advertisement appearing in a newspaper which:

- (1) is published at least once a week;**
- (2) regularly publishes information of current news interest to the community; and**
- (3) circulates generally to the public in any part of Indiana, regardless of where printed.**

However, a newspaper shall not include publications devoted to special interests such as labor, religious, fraternal, society, or trade publications or journals or publications owned or issued by political organizations or parties.

(c) The commission shall not exercise the prohibition power contained in subsection (a) for any advertisement broadcast over duly licensed radio and television stations.

(d) All advertisements relating to craft hemp, whether published in a newspaper or broadcast over radio or television, shall conform to the rules and regulations of the commission.

(e) The commission shall not exercise the prohibition power contained in subsection (a) for advertising in the official program of the Indianapolis 500 Race or the Madison Regatta, Inc., Hydroplane Race.

(f) Notwithstanding any other law, the commission may not prohibit the use of an illuminated sign advertising craft hemp by brand name that is displayed within the interior or on the exterior of a premises covered by a craft hemp retail permit, regardless of whether the sign is illuminated constantly or intermittently. However, it is unlawful for a craft hemp distributor permit holder to sell, give, supply, furnish, or grant to, or maintain for, a craft

 21 product, or a substantially similar substance in another
 22 jurisdiction;

23 (B) cultivates, processes, distributes, dispenses, or sells
 24 marijuana;

25 (C) cultivates, processes, or distributes hemp; or

26 (D) processes, distributes, or sells low THC hemp
 27 extract (as defined in IC 35-48-1.1-27); and

28 (2) that is accredited as a testing laboratory under
 29 International Organization for Standardization (ISO) 17025
 30 by a third party accrediting body such as the American
 31 Association for Laboratory Accreditation (A2LA) or
 32 Assured Calibration and Laboratory Accreditation Select
 33 Services (ACLASS).

34 **Sec. 4. As used in this chapter, "tamper evident packaging"**
 35 **means a package having at least one (1) indicator or a barrier to**
 36 **entry that, if breached or missing, can reasonably be expected to**
 37 **provide visible evidence to consumers that tampering has occurred.**

38 **Sec. 5. (a) Before a person may distribute a craft hemp flower**
 39 **product, the distributor must have a certificate of analysis**
 40 **prepared by an independent testing laboratory showing the**
 41 **following:**

42 (1) That the craft hemp flower product is the product of a

- 28 **Sec. 6. A craft hemp flower product must be distributed in**
- 29 **tamper evident packaging that contains the following information:**
- 30 (1) A scannable bar code or QR code linked to a document
- 31 that contains information with respect to the craft hemp
- 32 flower product, including the:
- 33 (A) batch identification number;
- 34 (B) product name;
- 35 (C) batch date;
- 36 (D) expiration date, which must be not more than two
- 37 (2) years from the date of harvest;
- 38 (E) batch size;
- 39 (F) total quantity produced;
- 40 (G) ingredients used, including the:
- 41 (i) ingredient name;
- 42 (ii) name of the company that manufactured the

- 9 (4) The expiration date, which must be not more than two (2)
- 10 years from the date of harvest.
- 11 (5) The number of grams of craft hemp flower (as defined in
- 12 IC 35-31.5-2-68.8) contained in the craft hemp flower
- 13 product.
- 14 (6) The facility that produced the craft hemp flower product.
- 15 (7) The fact that the craft hemp flower product contains not
- 16 more than three-tenths of one percent (0.3%)
- 17 tetrahydrocannabinol (THC), by weight or volume.
- 18 Sec. 7. A craft hemp flower product may not be distributed if
- 19 a certificate of analysis prepared by an independent testing
- 20 laboratory shows any of the following:
- 21 (1) A concentration of metals that is more than any of the
- 22 following:
- 23 (A) Four-tenths (0.4) part per million of cadmium.
- 24 (B) Five-tenths (0.5) part per million of lead.
- 25 (C) Four-tenths (0.4) part per million of arsenic.
- 26 (D) Two-tenths (0.2) part per million of mercury.
- 27 (2) A concentration of microbiological units that is more
- 28 than any of the following:
- 29 (A) One (1) colony forming unit per gram of
- 30 Shiga-Toxin Escherichia coli.
- 31 (B) One (1) colony forming unit per gram of Salmonella
- 32 spp.
- 33 (C) Ten thousand (10,000) colony forming units of
- 34 culturable mold.
- 35 (3) A concentration of residual solvents and chemicals that
- 36 is more than any of the following:
- 37 (A) Five thousand (5,000) parts per million of butane.
- 38 (B) Two (2) parts per million of benzene.
- 39 (C) Five thousand (5,000) parts per million of heptane.
- 40 (D) Two hundred ninety (290) parts per million of

(F) One (1) part per million of total xylenes, including ortho-xylene, meta-xylene, and para-xylene.

Sec. 8. (a) A person who knowingly or intentionally distributes or sells a craft hemp flower product in violation of this chapter commits a Class B misdemeanor. However, the offense is a Class A misdemeanor if the person has a prior unrelated conviction for a violation of this chapter.

(b) The penalties in this section are in addition to any criminal penalties that may be imposed for unlawful possession or distribution of a controlled substance.
