### DIGEST OF INTRODUCED BILL

**Synopsis:** Indiana department of environmental management. Amends, repeals, or adds certain terms. Makes certain changes concerning the purpose, structure, and powers of the department of environmental management or the environmental rules board. Makes certain changes to various boards or funds. Eliminates or amends rulemaking provisions. Makes certain changes to hearing and permitting processes. Changes or eliminates certain reporting requirements. Makes various changes to the water pollution statutes. Makes various changes to the solid waste and hazardous waste management statutes. Moves the Indiana recycling market development board to Title 13. Repeals or amends various sections regarding: (1) hazardous substances; (2) the voluntary remediation programs; (3) regional water districts; and (4) citizen lawsuits. Makes conforming and technical changes.

**SENATE BILL \_\_\_\_\_**

A BILL FOR AN ACT to amend the Indiana Code concerning environmental law and to make an appropriation.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 4-3-23-5, AS AMENDED BY P.L.87-2024,  
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2026]: Sec. 5. The office shall administer the following:  
4 (1) The energy development fund under ~~IC 4-23-5.5-10~~ **section**  
5 **10 of this chapter.**  
6 (2) A low interest revolving loan program for certain energy  
7 efficiency or recycling projects under section 9 of this chapter.  
8 (3) The green industries fund under IC 5-28-34, in consultation  
9 with the Indiana economic development corporation.  
10 SECTION 2. IC 4-3-23-10 IS ADDED TO THE INDIANA CODE  
11 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
12 1, 2026]: **Sec. 10. (a) The energy development fund is established as**  
13 **a dedicated fund to be administered by the office. Money in the**  
14 **fund shall be expended by the office exclusively to effect the**  
15 **provisions of this chapter and may include administrative costs.**  
16 **(b) All money received by the office for deposit in the energy**  
17 **development fund shall be deposited in the fund.**



1           (c) No portion of the fund shall revert to the state general fund  
2 at the end of a state fiscal year. However, if the fund is abolished its  
3 contents shall revert to the state general fund.

4           (d) All money accruing to the fund is continuously appropriated  
5 for the purposes specified in this chapter.

6           SECTION 3. IC 4-3-23-11 IS ADDED TO THE INDIANA CODE  
7 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
8 1, 2026]: Sec. 11. (a) The Indiana energy efficiency loan fund is  
9 established for the purpose of assisting Indiana industries and  
10 governing bodies (as defined in IC 36-1-12.5-1.5) in undertaking  
11 energy efficiency projects. The fund shall be administered by the  
12 board.

13           (b) Sources of money for the fund consist of the following:

14               (1) Appropriations from the general assembly.

15               (2) Repayment proceeds, including interest, of loans made  
16 from the fund.

17               (3) Donations, gifts, and money received from any other  
18 source, including transfers from other funds or accounts.

19           (c) Money remaining in the fund at the end of a state fiscal year  
20 does not revert to the state general fund.

21           (d) The treasurer of state shall invest the money in the fund not  
22 currently needed to meet the obligations of the fund in the same  
23 manner as other public funds may be invested. Interest that  
24 accrues from these investments shall be deposited in the fund.

25           (e) The board shall establish:

26               (1) amounts, terms, and interest rates for loans under this  
27 section; and

28               (2) criteria for awarding loans under this section.

29           (f) A person, business, governing body, or manufacturer that  
30 wants a loan from the fund must file an application in the manner  
31 prescribed by the board.

32           SECTION 4. IC 4-22-2-28.1, AS AMENDED BY P.L.249-2023,  
33 SECTION 28, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
34 JULY 1, 2026]: Sec. 28.1. (a) The following definitions apply  
35 throughout this section:

36               (1) "Coordinator" refers to the small business regulatory  
37 coordinator assigned to a rule by an agency under subsection (b).

38               (2) "Director" refers to the director or other administrative head  
39 of an agency.

40               (3) "Small business" has the meaning set forth in IC 5-28-2-6.

41           (b) For each rulemaking action and rule finally adopted as a result  
42 of a rulemaking action by an agency, the agency shall assign one (1)



1 staff person to serve as the agency's small business regulatory  
 2 coordinator with respect to the proposed or adopted rule. The agency  
 3 shall assign a staff person to a rule under this subsection based on the  
 4 person's knowledge of, or experience with, the subject matter of the  
 5 rule. A staff person may serve as the coordinator for more than one (1)  
 6 rule proposed or adopted by the agency if the person is qualified by  
 7 knowledge or experience with respect to each rule. The first public  
 8 comment period notice published under section 23 of this chapter must  
 9 include the name, address, telephone number, and electronic mail  
 10 address of the small business coordinator for the proposed rule, the  
 11 name, address, telephone number, and electronic mail address of the  
 12 small business ombudsman designated under IC 5-28-17-6, and a  
 13 statement of the resources available to regulated entities through the  
 14 small business ombudsman designated under IC 5-28-17-6. In the case  
 15 of a rule finally adopted, the final rule, as published in the Indiana  
 16 Register, must include the name, address, telephone number, and  
 17 electronic mail address of the coordinator.

18 (c) This subsection applies to a rule adopted by the department of  
 19 environmental management or the board listed in IC 13-14-9-1. In  
 20 addition to the information required by subsection (b), the department  
 21 and a board shall include in the notice provided under section 23 of this  
 22 chapter and in the publication of the final rule in the Indiana Register:

23 (1) a statement of the resources available to regulated entities  
 24 through the technical and compliance assistance program  
 25 established under IC 13-28-3;

26 (2) the name, address, telephone number, and electronic mail  
 27 address of the ombudsman designated under IC 13-28-3-2; and

28 (3) if applicable, a statement of

29 (A) the resources available to small businesses through the  
 30 small business stationary source technical assistance program  
 31 established under ~~IC 13-28-5~~; and **IC 13-28-3-7**.

32 (B) ~~the name, address, telephone number, and electronic mail~~  
 33 ~~address of the ombudsman for small business designated under~~  
 34 ~~IC 13-28-5-2(3)~~.

35 The coordinator assigned to the rule shall work with the ombudsman  
 36 described in subdivision (2) ~~and the office of voluntary compliance~~  
 37 ~~established by IC 13-28-1-1~~ to coordinate the provision of services  
 38 required under subsection (d) and IC 13-28-3. If applicable, the  
 39 coordinator assigned to the rule shall work with the ombudsman  
 40 referred to in subdivision ~~(3)(B)~~ **(3)**. ~~to coordinate the provision of~~  
 41 ~~services required under this section and IC 13-28-5~~.

42 (d) The coordinator assigned to a rule shall serve as a liaison



1 between the agency and any small business subject to regulation under  
 2 the rule. The coordinator shall provide guidance to small businesses  
 3 affected by the rule on the following:

4 (1) Any requirements imposed by the rule, including any  
 5 reporting, record keeping, or accounting requirements.

6 (2) How the agency determines or measures compliance with the  
 7 rule, including any deadlines for action by regulated entities.

8 (3) Any penalties, sanctions, or fines imposed for noncompliance  
 9 with the rule.

10 (4) Any other concerns of small businesses with respect to the  
 11 rule, including the agency's application or enforcement of the rule  
 12 in particular situations. However, in the case of a rule adopted by  
 13 the department of environmental management or a board listed in  
 14 IC 13-14-9-1, the coordinator assigned to the rule may refer a  
 15 small business with concerns about the application or  
 16 enforcement of the rule in a particular situation to the ombudsman  
 17 designated under IC 13-28-3-2. ~~or, if applicable, under~~  
 18 ~~IC 13-28-5-2(3).~~

19 (e) The coordinator assigned to a rule shall provide guidance under  
 20 this section in response to questions and concerns expressed by small  
 21 businesses affected by the rule. The coordinator may also issue general  
 22 guidelines or informational pamphlets to assist small businesses in  
 23 complying with the rule. Any guidelines or informational pamphlets  
 24 issued under this subsection shall be made available:

25 (1) for public inspection and copying at the offices of the agency  
 26 under IC 5-14-3; and

27 (2) electronically through electronic gateway access.

28 (f) The coordinator assigned to a rule shall keep a record of all  
 29 comments, questions, and complaints received from small businesses  
 30 with respect to the rule. The coordinator shall deliver the record, along  
 31 with any accompanying documents submitted by small businesses, to  
 32 the director:

33 (1) not later than ten (10) days after the date on which the rule is  
 34 submitted to the publisher under section 35 of this chapter; and

35 (2) before July 15 of each year during which the rule remains in  
 36 effect.

37 The coordinator and the director shall keep confidential any  
 38 information concerning a small business to the extent that the  
 39 information is exempt from public disclosure under IC 5-14-3-4.

40 (g) Not later than November 1 of each year, the director shall:

41 (1) compile the records received from all of the agency's  
 42 coordinators under subsection (f);



- 1 (2) prepare a report that sets forth:  
 2 (A) the number of comments, complaints, and questions  
 3 received by the agency from small businesses during the most  
 4 recent state fiscal year, categorized by the subject matter of the  
 5 rules involved;  
 6 (B) the number of complaints or questions reported under  
 7 clause (A) that were resolved to the satisfaction of the agency  
 8 and the small businesses involved;  
 9 (C) the total number of staff serving as coordinators under this  
 10 section during the most recent state fiscal year;  
 11 (D) the agency's costs in complying with this section during  
 12 the most recent state fiscal year; and  
 13 (E) the projected budget required by the agency to comply  
 14 with this section during the current state fiscal year; and  
 15 (3) deliver the report to the legislative council in an electronic  
 16 format under IC 5-14-6 and to the small business ombudsman  
 17 designated under IC 5-28-17-6.

18 SECTION 5. IC 4-23-5.5-1, AS AMENDED BY P.L.34-2013,  
 19 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 20 JULY 1, 2026]: Sec. 1. As used in this chapter:

- 21 (1) "board" refers to the Indiana recycling market development  
 22 board created by this chapter; **and**  
 23 ~~(2) "division" refers to the division of pollution prevention~~  
 24 ~~established by IC 13-27-2-1; and~~  
 25 ~~(3) (2) "office" refers to the Indiana office of energy development~~  
 26 ~~established by IC 4-3-23-3.~~

27 SECTION 6. IC 4-23-5.5-2, AS AMENDED BY P.L.42-2024,  
 28 SECTION 38, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 29 JULY 1, 2026]: Sec. 2. (a) The Indiana recycling market development  
 30 board is created and constitutes a public instrumentality of the state.  
 31 The exercise by the board of the powers conferred by this chapter is an  
 32 essential governmental function.

- 33 (b) The board consists of nine (9) members, one (1) of whom shall  
 34 be the lieutenant governor or the lieutenant governor's designee and  
 35 eight (8) of whom shall be appointed by the governor for four (4) year  
 36 terms. The governor's appointees shall be chosen from among  
 37 representatives of:  
 38 (1) the waste management industry;  
 39 (2) the recycling industry;  
 40 (3) Indiana universities and colleges with expertise in recycling  
 41 research and development;  
 42 (4) industrial and commercial consumers of recycled feedstock;



1 (5) environmental groups; and

2 (6) private citizens with a special interest in recycling.

3 No more than four (4) appointed members shall be of the same political  
4 party.

5 (c) A vacancy in the office of an appointed member, other than by  
6 expiration, shall be filled in like manner as the original appointment for  
7 the remainder of the term of that retiring member. Appointed members  
8 may be removed by the governor for cause.

9 (d) The board shall have seven (7) ex officio advisory members as  
10 follows:

11 (1) The governor.

12 (2) The director of the department of natural resources.

13 (3) The commissioner of the department of environmental  
14 management.

15 (4) Two (2) members from the house of representatives of  
16 opposite political parties appointed by the speaker of the house of  
17 representatives for two (2) year terms that expire June 30 of each  
18 odd-numbered year.

19 (5) Two (2) members from the senate of opposite political parties  
20 appointed by the president pro tempore of the senate for two (2)  
21 year terms that expire June 30 of each odd-numbered year.

22 (e) The ~~division~~ **Indiana department of environmental**  
23 **management** shall serve as the staff of the board.

24 (f) An ex officio advisory member identified in subsection (d) may,  
25 in writing, designate a representative to serve in an advisory capacity  
26 when the ex officio member is unable to attend a board meeting.

27 (g) The terms of the members of the board appointed by the  
28 governor under subsection (b) expire as follows:

29 (1) For four (4) of the members, as determined by the governor,  
30 December 31, 2025, and every fourth year thereafter.

31 (2) For four (4) of the members, as determined by the governor,  
32 December 31, 2027, and every fourth year thereafter.

33 SECTION 7. IC 4-23-5.5-4, AS AMENDED BY P.L.204-2007,  
34 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
35 JULY 1, 2026]: Sec. 4. A representative appointed by the ~~division~~,  
36 **director of the Indiana department of environmental management**  
37 in consultation with the lieutenant governor or the lieutenant governor's  
38 designee, shall be the chief administrative officer for the board and  
39 shall direct and supervise the administrative affairs and technical  
40 activities of the board in accordance with rules, regulations, and  
41 policies established by the board. The ~~division~~ **director of the Indiana**  
42 **department of environmental management** may appoint the



1 employees as the board may require and the agents or consultants as  
 2 may be necessary for implementing this chapter. The ~~division~~ **director**  
 3 **of the Indiana department of environmental management** shall  
 4 prepare an annual administrative budget for review by the budget  
 5 agency and the budget committee.

6 SECTION 8. IC 4-23-5.5-6, AS AMENDED BY P.L.42-2024,  
 7 SECTION 41, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 8 JULY 1, 2026]: Sec. 6. (a) The board shall do the following:

9 (1) Adopt procedures for the regulation of its affairs and the  
 10 conduct of its business.

11 (2) Meet at the offices of the ~~division~~ **Indiana department of**  
 12 **environmental management** on call of the chairperson at least  
 13 once each calendar quarter. The meetings shall be upon ten (10)  
 14 days written notification, shall be open to the public, and shall  
 15 have official minutes recorded for public scrutiny.

16 (3) Report annually in an electronic format under IC 5-14-6 to the  
 17 legislative council concerning:

18 (A) the projects in which it has participated and is currently  
 19 participating with a complete list of expenditures for those  
 20 projects; and

21 (B) the information obtained through the recycling activity  
 22 reports submitted to the commissioner of the department of  
 23 environmental management under IC 13-20-25 concerning the  
 24 calendar year most recently ended.

25 (4) Annually prepare an administrative budget for review by the  
 26 budget agency and the budget committee.

27 (5) Keep proper records of accounts and make an annual report of  
 28 its condition to the state board of accounts.

29 (6) Receive petitions and make determinations under  
 30 IC 13-20.5-2-2.

31 (b) The board shall consider projects involving the creation of the  
 32 following:

33 (1) Markets for products made from recycled materials.

34 (2) New products made from recycled materials.

35 (c) The board may promote, fund, and encourage programs  
 36 facilitating the development and implementation of waste reduction,  
 37 reuse, and recycling in Indiana.

38 SECTION 9. IC 5-28-17-6, AS AMENDED BY P.L.249-2023,  
 39 SECTION 46, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 40 JULY 1, 2026]: Sec. 6. The corporation shall act as the small business  
 41 ombudsman. The small business ombudsman shall carry out the  
 42 following duties:



- 1 (1) Work with state agencies to permit increased enforcement  
 2 flexibility and the ability to grant common sense exemptions for  
 3 first time offenders of state rules and policies, including,  
 4 notwithstanding any other law, policies for the compromise of  
 5 interest and penalties related to a listed tax (as defined in  
 6 IC 6-8.1-1-1) and other taxes and fees collected or administered  
 7 by a state agency.
- 8 (2) Work with state agencies to seek ways to consolidate forms  
 9 and eliminate the duplication of paperwork, harmonize data, and  
 10 coordinate due dates.
- 11 (3) Coordinate with OMB (as defined in IC 4-3-22-3) to perform  
 12 cost benefit analyses.
- 13 (4) Work with state agencies to monitor any outdated, ineffective,  
 14 or overly burdensome information requests from state agencies to  
 15 small businesses.
- 16 (5) Carry out the duties specified under IC 4-22-2-28 and  
 17 IC 4-22-2.1 to review proposed rules and participate in  
 18 rulemaking actions that affect small businesses.
- 19 (6) Coordinate with the ombudsman designated under  
 20 IC 13-28-3-2 ~~and the office of voluntary compliance established~~  
 21 ~~by IC 13-28-1-1~~ to coordinate the provision of services required  
 22 under IC 4-22-2-28.1 and IC 13-28-3.
- 23 (7) Prepare written and electronic information for periodic  
 24 distribution to small businesses describing the small business  
 25 services provided by coordinators (as defined in  
 26 IC 4-22-2-28.1(a)) and work with the office of technology  
 27 established by IC 4-13.1-2-1 to place information concerning the  
 28 availability of these services on state websites that the small  
 29 business ombudsman or a state agency determines are most likely  
 30 to be visited by small business owners and managers.
- 31 (8) Assist in training agency coordinators who will be assigned to  
 32 rules under IC 4-22-2-28.1(b).
- 33 (9) Investigate and attempt to resolve any matter regarding  
 34 compliance by a small business with a law, rule, or policy  
 35 administered by a state agency, either as a party to a proceeding  
 36 or as a mediator.
- 37 State agencies shall cooperate with the small business ombudsman to  
 38 carry out the purpose of this section. The department of state revenue  
 39 and the department of workforce development shall establish a program  
 40 to distribute the information described in subdivision (7) to small
