1 A CONCURRENT RESOLUTION urging the Indiana
2 Department of Transportation to rename the portion of I-69
3 North beginning at mile marker 233 the "Gregg Winters
4 Memorial Mile".

5 *Whereas, Gregg William Winters was born on February 25,*
6 *1958, to Ezra "Zeke" and Beverly Snyder Winters in Muncie,*
7 *Indiana;*

8 *Whereas, A lifelong resident of Muncie, Gregg graduated*
9 *from Southside High School in 1976;*

10 *Whereas, Gregg worked for Wise's Food Market and*
11 *Motion Industries before joining the Muncie Police Department*
12 *in 1986 under Badge Number 167;*

13 *Whereas, Outside of his police work, Gregg attended*
14 *Shawnee Heights Baptist Church, was a member of the*
15 *Fraternal Order of Police, and was a devoted husband and*
16 *father to his wife and two young boys, Kyle and Brock;*

17 *Whereas, On December 28, 1990, Officer Winters was*
18 *dispatched to a traffic accident and observed an abandoned*
19 *utility truck;*

20 *Whereas, On the scene, officers located an intoxicated man,*
21 *arrested him for public intoxication, and placed him in Officer*
22 *Winters' police car for transport;*

23 *Whereas, Approximately one-eighth of a mile from the*

1 *county jail, the arrestee pulled out a concealed handgun and*
2 *shot Officer Winters five times;*

3 *Whereas, Officer Winters later succumbed to his injuries on*
4 *January 8, 1991;*

5 *Whereas, Following his death, Officer Winters' wife, Molly*
6 *Ann Keith Winters, became an outspoken advocate for*
7 *survivors of officers killed in the line of duty and went on to*
8 *become the national president of Concerns of Police Survivors*
9 *and trained federal employees to help survivors of those lost*
10 *during the September 2001 terrorist attacks; and*

11 *Whereas, It is fitting to honor Officer Winters' lifelong*
12 *service to the Muncie community and his ultimate sacrifice*
13 *while in the line of duty by renaming the portion of I-69 North*
14 *beginning at mile marker 233 the "Gregg Winters Memorial*
15 *Mile": Therefore,*

16 *Be it resolved by the Senate of the General Assembly*
17 *of the State of Indiana, the House of Representatives*
18 *concurring:*

19 SECTION 1. That the Indiana General Assembly urges the
20 Indiana Department of Transportation to rename the portion of
21 I-69 North beginning at mile marker 233 the "Gregg Winters
22 Memorial Mile".

23 SECTION 2. The Secretary of the Senate is hereby directed
24 to transmit copies of this Resolution to the Commissioner of the
25 Indiana Department of Transportation.
