## **SENATE RESOLUTION**

MR. PRESIDENT:

I offer the following resolution and move its adoption:

1       A SENATE RESOLUTION honoring Brad Eisenhart upon  
2       his retirement.

3       *Whereas, After more than three decades of dedicated  
4       service, Brad Eisenhart, the Great Lakes Area Director of  
5       Disposal Operations for Waste Management (WM), is  
6       embarking on a well-deserved retirement;*

7       *Whereas, Brad started at WM in May 1992 as an  
8       Engineering Intern at Suburban Landfill in Ohio, and by  
9       October of that year, he had accepted a Site Engineer position  
10      in Indiana;*

11      *Whereas, Brad's career progression at WM is a testament  
12      to his passion for learning and growth as evidenced by his  
13      trajectory through increasingly impactful roles, including  
14      District Manager at Twin Bridges Landfill and ultimately  
15      Director of Disposal Operations for Ohio and Indiana;*

16      *Whereas, A highlight of Brad's career was leading the  
17      development of the \$27 million Crossroads Rail Facility, where  
18      he managed the design, construction, and site operations of this  
19      pivotal project that positioned WM as an industry leader in*

3       *commitment to environmental stewardship has shone through*  
4       *his developing of the Indiana Master Naturalist Program at*  
5       *Twin Bridges to foster ecological awareness and education;*

6           *Whereas, Outside of his work, Brad is devoted to*  
7       *community services, having served on the Board of Directors*  
8       *for the Greater Danville Chamber of Commerce, the Parks*  
9       *Foundation of Hendricks County, the Hendricks County Parks*  
10       *& Recreation Board, and the Danville Optimist Youth Soccer*  
11       *League; and*

12       *Whereas, Brad also volunteers with the Hendricks County*  
13       *Solid Waste District Citizens Advisory Committee, Boy Scout*  
14       *Troop 302, Twin Bridges Skeet & Trap Club, and the Danville*  
15       *Optimist Club: Therefore,*

16           *Be it resolved by the Senate of the*  
17       *General Assembly of the State of Indiana:*

18       SECTION 1. That the Indiana Senate honors Brad Eisenhart  
19       upon his retirement and thanks him for his years of community
