MR. PRESIDENT:

I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION memorializing Alicia J.

4 *Whereas, Alicia June Barnett Collins was born on March*
5 *15, 1971, and passed away on October 18, 2025, at the age of*
6 *54;*

7 *Whereas, Alicia is survived by her loving family, including*
8 *her husband Tom Collins, Trajan S. Collins, and daughter*
9 *Blake A. Hall;*

10 *Whereas, Alicia dedicated her adult life to serving the Far*
11 *Eastside of Indianapolis, and leaves behind a legacy of*
12 *philanthropy, grassroots organizing, crime prevention, and*
13 *community development;*

14 *Whereas, Over the course of her thirty-year career, Alicia*
15 *worked for Making Connections, an initiative of the Annie E.*
16 *Casey Foundation, and the Central Indiana Community*
17 *Foundation, where she spent fourteen years on staff and*
18 *became Director of Community Leadership;*

19 *Whereas, In March 2022, Alicia took a leap of faith,*



1 *becoming an independent consultant and founding her own*
2 *company, 3-R Consulting, LLC, guided by the principle that*
3 *"Relationships + Resources = Results";*

4 *Whereas, Outside of her work, Alicia served as an*
5 *Indianapolis campaign representative for President Barack*
6 *Obama's campaigns and for his legacy advocacy group,*
7 *Organizing for Action (OFA);*

8 *Whereas, Alicia's passion for her work and belief in public*
9 *service was evident in all she did, and she aspired to instill that*
10 *passion in her daughter Blake, often taking her to community*
11 *meetings and giving her a firsthand example of servant*
12 *leadership; and*

13 *Whereas, The Far Eastside and Indiana Senate District 34*
14 *are a better place because of Alicia's important work, and she*
15 *will be fondly remembered by her family, friends, colleagues,*
16 *and community for all her contributions to our city: Therefore,*

17 *Be it resolved by the Senate of the*
18 *General Assembly of the State of Indiana:*

19 SECTION 1. That the Indiana Senate memorializes Alicia
20 June Barnett Collins.
