SENATE RESOLUTION _____

MR. PRESIDENT:

I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION honoring Greg Gordon upon
2 his retirement from the Indiana Senate.

3 *Whereas, Greg Gordon began his career with the Indiana*
4 *Senate in 1988 in the Senate duplicating office after proudly*
5 *graduating from Indiana University;*

6 *Whereas, Throughout his career, Greg has striven to*
7 *provide the best possible service within his office, always*
8 *ensuring that assistance is answered in an expedient manner,*
9 *and hand-delivering items within minutes of a request;*

10 *Whereas, Greg has remained a steady presence through*
11 *major Senate renovations and office moves, including getting*
12 *rid of the milk machine area, updating the 3A kitchen, moving*
13 *communications staff around the statehouse, and many other*
14 *moves;*

15 *Whereas, Outside of his time with the Senate, Greg spends*
16 *his time with his family, including his wife, Sue, and adult*
17 *children, Patrick and Emily, and plans to travel, continue*
18 *helping with Special Olympics, and spend time at Lake Winona;*



1 *Whereas, Always on the move, Greg played tennis for years*
2 *and recently picked up competitive pickleball, and he also has*
3 *a green thumb and consistently works in his incredible outdoor*
4 *space and garden;*

5 *Whereas, Greg is the longest serving full-time staff member*
6 *of the Indiana Senate, where he has been an employee longer*
7 *than any current Senator has been in their current office,*
8 *served through 39 regular sessions during the tenures of eight*
9 *governors and nine lieutenant governors, supported three*
10 *president pro tempores, and witnessed 8,230 bills become laws;*

12 *Whereas, Greg will be deeply missed by Senators, staff, and*
13 *all who have come to know him through his years of service to*
14 *the Senate: Therefore,*

15 *Be it resolved by the Senate of the*
16 *General Assembly of the State of Indiana:*

17 SECTION 1. That the Indiana Senate honors Greg Gordon
18 upon his retirement from the Indiana Senate after 38 years of
19 public service.
