Description of fiscal impact

SB 399 revises primary election laws, moves the date of the primary election from June to May, provides for separate primary and school election ballots, and requires that primary election ballots be counted before school election ballots. Although there is no fiscal impact to the state, there will be a fiscal impact to the counties to implement the requirements of this proposed legislation.

FISCAL ANALYSIS

Assumptions

Secretary of State's Office

1. SB 399 bill requires the Office of the Secretary of State to notify each federally recognized tribal government in Montana. While there may be a minimal fiscal impact, the office will absorb the costs associated with implementing this bill within the office's existing operating budget.

Effect on County or Other Local Revenues or Expenditures Montana Association of Counties

- 1. Approximately half of the counties currently conduct school elections, while the other half do not. This bill will increase costs for both.
- 2. Counties that currently conduct school elections will need additional FTE and/or need to pay overtime for current staff, because the staff will be running two elections on the same day.
- 3. Counties that do not conduct school elections will still have double the costs.
- 4. There will likely be additional equipment costs due to different ballot styles.
- 5. Per the cost survey conducted by the Office of the Secretary of State, the counties' total cost for the 2022 primary election was \$3,111,546.51.

- 6. It is estimated that this bill will add an additional \$1,555,773 (50% of the primary's cost) to the cost of the primary election.
- 7. This bill may require local governments to spend additional sums for which no specific means of financing are provided. Section 1-2-114, MCA, provides that bills that have such an impact may not be introduced.
