13	Section 1. Section 17-7-133, MCA, is amended to read:
14	"17-7-133. (Temporary) Montana local disaster resiliency fund. (1) There is statutorily
15	appropriated pursuant to 17-7-502 \$4 up to \$15 million per a year beginning in the fiscal year beginning July 1,
16	2023 2025, from the general Montana local disaster resiliency fund to the department of military affairs.
17	(2) Eligible uses of the money are:
18	(a) state and local mitigation projects that reduce or eliminate long-term risk to people and property
19	from future <u>natural</u> disasters;
20	(b) the nonfederal cost share for personnel and contracted resources performing mitigation
21	program management; and
22	(c) matching funds for grants for the purchase of hazardous material equipment and training to
23	increase local capacity to respond to incidents as defined in 10-3-1203 involving hazardous material training
24	and administrative resources.
25	(3) The appropriation is void in any year that there is a projected general fund budget deficit
26	pursuant to 17-7-140. (Terminates June 30, 2027-sec. 24, Ch. 722, L. 2023.)"

28	NEW SECTION. Section 2. Procedure for funding projects. (1) Prior to a legislative session, the

1	department of military affairs must receive proposals for projects requesting funding from 17-7-133 on a
2	continual basis. The department shall prepare and submit a list containing the recommended projects and the
3	recommended form and amount of financial assistance for each project to the governor, prioritized by the
4	department. Before making recommendations to the governor, the department may adjust the ranking of
5	projects by giving priority to urgent and serious public health or safety problems. The governor shall review the
6	projects recommended by the department and shall submit the lists of recommended projects and the
7	recommended financial assistance to the legislature.
8	(2) Money from the fund provided for in 17-7-133 may not be provided for projects until the
9	legislature has approved a list of projects for the biennium through legislation.

11	Section 3. Section 24, Chapter 722, Laws of 2023, is amended to read:
12	"Section 24. Termination. (1) [Section 1] terminates June 30, 2025.
13	(2) [Sections 6 and 7(3)] terminate June 30, 2027."

15	NEW SECTION. Section 4. Transfer of funds. (1) By June 30, 2025, the state treasurer shall
16	transfer \$50 million from the general fund to the local disaster resiliency fund provided for in 17-7-133, MCA.
17	(2) During the biennium ending June 30, 2027, the state treasurer shall transfer \$50 million from
18	the general fund to the local disaster resiliency fund provided for in 17-7-133, MCA.
19	
20	NEW SECTION. Section 5. Effective dates. (1) Except as provided in subsection (2), [this act] is
21	effective on passage and approval.
22	(2) [Section 2] is effective July 1, 2025.
23	
24	NEW SECTION. Section 6. Codification instruction. [Section 2] is intended to be codified as an
25	integral part of Title 17, chapter 7, part 1, and the provisions of Title 17, chapter 7, part 1, apply to [section 2].

27	NEW SECTION. Section 5. Effective date. [This act] is effective on passage and approval.
