8	A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS TO NARROW THE SCOPE OF
9	EXECUTIVE EXEMPTIONS TO PUBLIC RECORDS REQUESTS; PROVIDING FOR A LIMITED EXECUTIVE
10	EXEMPTION OVER CERTAIN DOCUMENTS IN STATUTE; PROVIDING FOR A WAIVER OF EXECUTIVE
11	EXEMPTION; PROVIDING THAT THE EXECUTIVE EXEMPTION EXPIRES AT A CERTAIN TIME;
12	REQUIRING THE AWARD OF COSTS AND REASONABLE ATTORNEY FEES FOR A PREVAILING PARTY
13	TO PUBLIC RECORDS LITIGATION; REVISING DEFINITIONS; AMENDING SECTIONS 2-6-1002, 2-6-1009,
14	AND 90-1-105, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

16	WHEREAS, the Montana Constitution has enshrined access to public information in the Right to Know
17	in Article II, section 9, which states that "No person shall be deprived of the right to examine documents or to
18	observe the deliberations of all public bodies or agencies of state government and its subdivisions, except in
19	cases in which the demand of individual privacy clearly exceeds the merits of public disclosure"; and
20	WHEREAS, the Right of Participation in Article II, section 8, of the Montana Constitution also ensures
21	that the public must be given a reasonable opportunity to participate in the operation of governmental agencies
22	prior to the final decision as may be provided by law; and
23	WHEREAS, these fundamental rights are the foundation on which every Montanan is able to exercise
24	the power to hold elected officials accountable for their actions and decisions; and
25	WHEREAS, the Montana Supreme Court recently issued a decision in O'Neill v. Gianforte, 2025 MT 2,
26	holding that the Governor enjoys a common law-based executive privilege, which protects certain
27	communications and information from public disclosure; and
28	WHEREAS, the Legislature holds the power to change the common law through the proper and valid

1 enactment of legislation; and 2 WHEREAS, the process outlined by the majority in O'Neill is unwieldy and cumbersome, requiring an in 3 camera review by a court of all documents for which an executive privilege is asserted, causing substantial 4 costs to Montanans seeking records and to the state, adding to the workload of an already burdened judicial 5 system, and stalling the ability of a Montana citizen to receive the public information about the workings of 6 government to which the citizen is otherwise entitled; and 7 WHEREAS, to the extent that a common law executive privilege exists, the Legislature intends to 8 replace the common law privilege with a statutory exemption defining the scope and limitations of the executive 9 exemption; and 10 WHEREAS, the Legislature finds that it is in the best interest of every Montanan and to further fidelity to 11 the Montana Constitution to better define and clarify the scope of the constitutional privacy protections and to 12 uphold the long and proud tradition of open government by providing access to the documents and 13 deliberations of state and local government while also increasing government accountability and transparency. 14 15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA: 16 17 <u>NEW SECTION.</u> Section 1. Limited executive exemption -- expiration of exemption. (1) The 18 governor may assert an executive exemption to withhold specific public information from a request for public 19 information under sections 2-6-1003 and 2-6-1006 only when the governor's individual privacy interest clearly 20 outweighs the merits of public disclosure. 21 (2)The assertion of an executive exemption must be narrowly tailored to apply to only the specific 22 information in which the governor is claiming a privacy interest. The information for which the governor is 23 asserting the executive exemption may be redacted, but only to the narrowest extent possible. A person who received public information with redaction may bring an action pursuant to 2-6-1009 alleging that the application 24 25 of an executive exemption is overly broad. The court shall review the redacted information and assess whether 26 the individual privacy interest clearly outweighs the merits of public disclosure. 27 (3) The duration for which the executive exemption lasts is only as long as the protection of the 28 exempted information serves its underlying purpose.

Written notice of denial -- failure to meet response deadline -- civil action -- costs to 5 prevailing party in certain actions to enforce constitutional or statutory rights. The department may accept 16 contributions and donations from individuals and organizations for the purposes of this subsection. 17 (8) explore the use of cooperative agreements, as provided in Title 18, chapter 11, part 1, for the 18 promotion and enhancement of economic opportunities on the Indian reservations in Montana; and 19 (9) assist the state-tribal economic development commission established in 90-1-131 in: 20 (a) identifying federal government and private sector funding sources for economic development 21 on Indian reservations in Montana; and 22 (b) fostering and providing assistance to prepare, develop, and implement cooperative 23 agreements, in accordance with Title 18, chapter 11, part 1, with each of the tribal governments in Montana." 24 25 NEW SECTION. Section 5. Codification instruction. [Section 1] is intended to be codified as an 26 integral part of Title 2, chapter 6, part 11, and the provisions of Title 2, chapter 6, part 11, apply to [section 1]. 27 28 NEW SECTION. Section 6. Effective date. [This act] is effective on passage and approval.
