10	Section 1. Section 28-2-724, MCA, is amended to read:		
11	"28-2-	724. Prohibition of contracts that restrict practice applicability exceptions. (1) A	
12	contract that creates or establishes the terms of employment, a partnership, or any other form of professional		
13	relationship with a health care provider described in subsection (2), may not restrict the right of the health care		
14	provider, AFTER THE TERMINATION OF THE EMPLOYMENT, PARTNERSHIP, OR OTHER FORM OF PROFESSIONAL		
15	RELATIONSHIP, to:		
16	(a)	practice or provide services for which the provider is licensed, in any geographic area and for	
17	any period, after the termination of the employment, partnership, or other form of professional relationship;		
18	(b)	treat, advise, consult with, or establish a provider-patient relationship with any current patient of	
19	the employer	or with a patient affiliated with a partnership or other form of professional relationship; or	
20	(c)	solicit or seek to establish a provider-patient relationship with any current patient of the	
21	employer or with a patient affiliated with a partnership or other form of professional relationship.		
22	(2)	The requirements of subsection (1) apply to contracts or agreements involving the following	
23	health care providers:		
24	(a)	a psychiatrist or addiction medicine PSYCHIATRIST OR ADDICTION MEDICINE physician licensed	
25	under Title 37, chapter 3;		
26	(b)	a psychologist licensed under Title 37, chapter 17;

28	(C)	A NATUROPATHIC PHYSICIAN LICENSED UNDER TITLE 37, CHAPTER 26;	



1	(c)(D) a social worker licensed under Title 37, chapter-22 39;		
2	(d)(E) a professional counselor licensed under Title 37, chapter-23_39;		
3	(e)(F) an addiction counselor licensed under Title 37, chapter 35 39;		
4	(f)(G) a marriage and family therapist licensed under Title 37, chapter 37 39; and		
5	(g)(H) a behavioral health peer support specialist licensed under Title 37, chapter 38 39;		
6	(h)(ı) a registered professional nurse or an advanced practice registered nurse licensed under Title,		
7	37, chapter 8; or		
8	(i)(J) a physician assistant licensed under Title 37, chapter 20.		
9	(3) This section does not apply to a contract in connection with the sale and purchase of a		
10	practice."
