13	Facility Access and Stabilization Act".

15	NEW SECTION. Section 2. Calculation of room and board costs for assisted livin	g facility	
16	services. (1) The department shall, at a minimum, annually adjust the amount that persons enrolled in the		
17	Montana medicaid program must pay for room and board when receiving assisted living facility services.		
18	(2) The room and board payment for a person who is categorically eligible for the pr	ogram must	
19	equal the person's monthly supplemental security income payment, minus a \$100 allowance to provide for		
20	personal needs funds.		
21	(3) (a) The room and board payment for a person who qualifies for the program pure	suant to 53-6-	
22	131(1)(e)(ii)(A) must equal the person's countable gross income, minus:		
23	(i) the amount of money the person must spend to qualify for medicaid; and		
24	(ii) \$100 to provide for personal needs funds.		
25	(b) After an initial adjustment made pursuant to subsection (3)(a), the department sl	nall adjust the	
26	room and board payments when the amount a person must spend to qualify for medicaid has been increased		
27	or decreased to maintain personal needs funds of \$100.

9	NEW SECTION. Section 4. Reporting requirements big sky waiver and community first	
10	<b>choice programs.</b> (1) Each quarter of the <u>2029</u> <u>2027</u> biennium, the department of public health and human	
11	services shall report the following information for the preceding quarter to the health and human services	
12	interim budget committee provided for in 5-12-501:	
13	(a) the average number of people served each month through the big sky waiver and the	
14	community first choice option administered by the division overseeing long-term care services;	
15	(b) the average number of people on the waiting list for the big sky waiver each month;	
16	(c) any changes in the number of providers participating in the community first choice option;	
17	(d) the average per-capita expenditures in the big sky waiver and the community first choice	
18	option; and	
19	(e) the average utilization rate of individual service plan allotments in the community first choice	
20	option.	
21	(2) The reports must be provided in electronic format and presented to the committee in person.

23	NEW SECTION. Section 5. Codification instruction. [Section 1] is intended to be codified as an	
24	integral part of Title 53, chapter 6, and the provisions of Title 53, chapter 6, apply to [section 1].

26	NEW SECTION. Section 6. Effective date. [This act] is effective July 1, 2027 2025.
