18 WHEREAS, a central bank digital currency has been defined by the Federal Reserve as a digital form  
19 of central bank money that is widely available to the general public; and

20 WHEREAS, central bank money refers to money that is a liability of the central bank and not of a  
21 commercial bank; and

22 WHEREAS, countries around the world, including the United States, are evaluating whether or not to  
23 issue and how to issue and operate a central bank digital currency; and

24 WHEREAS, a central bank digital currency would fundamentally reimagine our banking and financial  
25 system by changing the relationship between citizens and the Federal Reserve; and

26 WHEREAS, a central bank digital currency would severely undermine financial privacy for citizens; and

27 WHEREAS, the availability of a central bank digital currency in the United States would undermine the  
28 important role banks play in financial intermediation and limit credit availability because funds would move from

1 commercial banks to the Federal Reserve where they cannot be lent back into the economy; and

2 WHEREAS, a central bank digital currency would fundamentally rewire our banking and financial  
3 system by changing the relationship between citizens and the Federal Reserve.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

7 **Section 1.** Section 30-1-101, MCA, is amended to read:

8 **"30-1-101. Short titles -- scope of chapter.** (1) Chapters 1 through 9A and [sections 94 through 109]  
9 of this title may be cited as Uniform Commercial Code.

10 (2) As used in chapters 1 through 9A and [sections 94 through 109] of this title "code" means  
11 "Uniform Commercial Code" unless the context indicates otherwise.

12 (3) This chapter may be cited as the Uniform Commercial Code--General Provisions.

13 (4) This chapter applies to a transaction to the extent that it is governed by chapters 2 through 5,  
14 7, 8, ~~and 9A,~~ and [sections 94 through 109] of this title.

15 (5) Nothing in chapters 1 through 9A and [sections 94 through 109] of this title may be construed to  
16 support, endorse, create, or implement a national digital currency."

18 **Section 2.** Section 30-1-107, MCA, is amended to read:

19 **"30-1-107. Waiver or renunciation of claim or right after breach.** A claim or right arising out of an  
20 alleged breach may be discharged in whole or in part without consideration by agreement of the aggrieved  
21 party in ~~an authenticated~~ a signed record."

22

23 **Section 3.** Section 30-1-201, MCA, is amended to read:

24 **"30-1-201. General definitions.** (1) Unless the context requires otherwise, words or phrases defined  
25 in this section, or in the additional definitions contained in other chapters of the code that apply to particular  
26 chapters or parts of chapters, have the meanings stated.

27 (2) Subject to additional definitions contained in other chapters of this code that apply to specific  
28 chapters or parts of chapters:

1 (a) "Action" in the sense of a judicial proceeding includes recoupment, counterclaim, setoff, suit in  
2 equity, and any other proceeding in which rights are determined.

3 (b) "Aggrieved party" means a party entitled to pursue a remedy.

4 (c) "Agreement" means the bargain of the parties in fact, as found in their language or inferred  
5 from other circumstances, including course of performance, course of dealing, or usage of trade as provided in  
6 30-1-205.

7 (d) ~~"Authenticate" means to:~~

8 (i) ~~sign; or~~

9 (ii) ~~execute or adopt a symbol, or encrypt a record in whole or in part, with present intent to:~~

10 (A) ~~identify the authenticating party; and~~

11 (B) ~~adopt, accept, or establish the authenticity of a record or term.~~

12 ~~(e)~~ (d) "Bank" means any person engaged in the business of banking and includes a savings bank,  
13 savings and loan association, credit union, and trust company.

14 (f) (e) "Bearer" means a person in control of a negotiable electronic document of title or a person in  
15 possession of a negotiable instrument, negotiable tangible document of title, or certificated security payable to  
16 bearer or endorsed in blank.

17 ~~(g)~~ (f) (i) "Bill of lading" means a document of title evidencing the receipt of goods for shipment issued  
18 by a person engaged in the business of directly or indirectly transporting or forwarding goods.

19 (ii) The term does not include a warehouse receipt.

20 (h) (g) "Branch" includes a separately incorporated foreign branch of a bank.

21 (i) (h) "Burden of establishing" a fact means the burden of persuading the trier of fact that the  
22 existence of the fact is more probable than its nonexistence.

23 (j) (i) "Buyer in ordinary course of business" means a person that buys goods, in good faith, without  
24 knowledge that the sale violates the rights of another person in the goods, and in the ordinary course from a  
25 person, other than a pawnbroker, in the business of selling goods of that kind. A person buys goods in the  
26 ordinary course if the sale to the person comports with the usual or customary practices in the kind of business  
27 in which the seller is engaged or with the seller's own usual or customary practices. A person that sells oil, gas,  
28 or other minerals at the wellhead or minehead is a person in the business of selling goods of that kind. A buyer

1 in ordinary course of business may buy for cash, by exchange of other property, or on secured or unsecured  
 2 credit, and may acquire goods or documents of title under a preexisting contract for sale. Only a buyer that  
 3 takes possession of the goods or has a right to recover the goods from the seller under chapter 2 may be a  
 4 buyer in ordinary course of business. A person that acquires goods in a transfer in bulk or as security for or in  
 5 total or partial satisfaction of a money debt is not a buyer in ordinary course of business.

6 ~~(k)~~ (j) "Conspicuous", with reference to a term, means so written, displayed, or presented that, based  
 7 on the totality of the circumstances, a reasonable person against which it is to operate ought to have noticed it.

8 Whether a term is "conspicuous" or not is for decision by the court. ~~Conspicuous terms include the following:~~

9 ~~(i) — a heading in capitals equal to or greater in size than the surrounding text, or in contrasting type,~~  
 10 ~~font, or color to the surrounding text of the same or lesser size; and~~

11 ~~(ii) — language in the body of a record or display in larger type than the surrounding text, or in~~  
 12 ~~contrasting type, font, or color to the surrounding text of the same size, or set off from surrounding text of the~~  
 13 ~~same size by symbols or other marks that call attention to the language.~~

14 ~~(h)~~ (k) "Consumer" means an individual who enters into a transaction primarily for personal, family, or  
 15 household purposes.

16 ~~(m)~~ (l) "Contract" means the total legal obligation that results from the parties' agreement as affected  
 17 by this code and as supplemented by any other applicable rules of law.

18 ~~(n)~~ (m) "Creditor" includes a general creditor, a secured creditor, a lien creditor, and any representative  
 19 of creditors, including an assignee for the benefit of creditors, a trustee in bankruptcy, a receiver in equity, and  
 20 an executor or administrator of an insolvent debtor's or assignor's estate.

21 ~~(o)~~ (n) "Defendant" includes a person in the position of defendant in a counterclaim or third-party  
 22 claim.

23 ~~(p)~~ (o) "Delivery" with respect to an electronic document of title means voluntary transfer of control  
 24 and, with respect to ~~instruments, tangible documents of title, or an instrument, a tangible document of title, or~~  
 25 an authoritative tangible copy of a record evidencing chattel paper, means voluntary transfer of possession.

26 ~~(q)~~ (p) (i) "Document of title" means a record:

27 (A) that in the regular course of business or financing is treated as adequately evidencing that the  
 28 person in possession or control of the record is entitled to receive, control, hold, and dispose of the record and

1 the goods the record covers; and

2 (B) that purports to be issued by or addressed to a bailee and to cover goods in the bailee's  
3 possession which are either identified or are fungible portions of an identified mass.

4 (ii) The term includes a bill of lading, transport document, dock warrant, dock receipt, warehouse  
5 receipt, and order for delivery of goods. An electronic document of title is evidenced by a record consisting of  
6 information stored in an electronic medium. A tangible document of title is evidenced by a record consisting of  
7 information that is inscribed on a tangible medium.

8 (q) "Electronic" means relating to technology having electrical, digital, magnetic, wireless, optical,  
9 electromagnetic, or similar capabilities.

10 (r) "Fault" means wrongful act, omission, breach, or default.

11 (s) "Fungible goods" means:

12 (i) goods of which any unit, by nature or usage of trade, is the equivalent of any other like unit; or

13 (ii) goods which by agreement are treated as equivalent.

14 (t) "Genuine" means free of forgery or counterfeiting.

15 (u) "Good faith", except as otherwise provided in chapter 5, means honesty in fact and the  
16 observance of reasonable commercial standards of fair dealing.

17 (v) "Holder" means:

18 (i) the person in possession of a negotiable instrument that is payable either to bearer or to an  
19 identified person that is the person in possession;

20 (ii) ~~a~~the person in possession of a negotiable tangible document of title if the goods are  
21 deliverable either to bearer or to the order of the person in possession; or

22 (iii) ~~a~~the person in control, other than pursuant to 30-7-107(7) of a negotiable electronic document  
23 of title.

24 (w) "Insolvency proceedings" includes an assignment for the benefit of creditors or other  
25 proceeding intended to liquidate or rehabilitate the estate of the person involved.

26 (x) "Insolvent" means:

27 (i) having generally ceased to pay debts in the ordinary course of business other than as a result  
28 of bona fide dispute;

1 (ii) unable to pay debts as they become due; or

2 (iii) insolvent within the meaning of the federal bankruptcy law.

3 (y) "Money" means a medium of exchange that is currently authorized or adopted by a domestic or  
4 foreign government and is not in an electronic form. The term includes a monetary unit of account established  
5 by an intergovernmental organization or by pursuant to an agreement between two or more countries.

6 (z) "Organization" means a person other than an individual.

7 (aa) "Party", as distinct from "third party", means a person that has engaged in a transaction or  
8 made an agreement subject to this code.

9 (bb) "Person" means an individual, corporation, business trust, estate, trust, partnership, limited  
10 liability company, association, joint venture, government, governmental subdivision, agency, or instrumentality,  
11 ~~public corporation,~~ or any other legal or commercial entity. The term includes a protected series, however  
12 denominated, of an entity if the protected series is established under law other than this code that limits, or  
13 limits if conditions specified under the law are satisfied, the ability of a creditor of the entity or of any other  
14 protected series of the entity to satisfy a claim from assets of the protected series.

15 (cc) "Presumption" or "presumed" means that the trier of fact must find the existence of the fact  
16 presumed unless and until evidence is introduced which would support a finding of its nonexistence.

17 (dd) "Purchase" means taking by sale, lease, discount, negotiation, mortgage, pledge, lien, security  
18 interest, issue or reissue, gift, or any other voluntary transaction creating an interest in property.

19 (ee) "Purchaser" means a person that takes by purchase.

20 (ff) "Record" means information that is inscribed on a tangible medium or that is stored in an  
21 electronic or other medium and is retrievable in perceivable form.

22 (gg) "Remedy" means any remedial right to which an aggrieved party is entitled with or without  
23 resort to a tribunal.

24 (hh) "Representative" means any other person empowered to act for another, including an agent, an  
25 officer of a corporation or association, and a trustee, executor, or administrator of an estate.

26 (ii) "Right" includes a remedy.

27 (jj) "Security interest" means an interest in personal property or fixtures which secures payment or  
28 performance of an obligation. The term also includes any interest of a consignor and a buyer of accounts,

1 chattel paper, a payment intangible, or a promissory note in a transaction that is subject to chapter 9A. The  
 2 special property interest of a buyer of goods on identification of those goods to a contract for sale under 30-2-  
 3 401 is not a "security interest", but a buyer may also acquire a "security interest" by complying with chapter 9A.  
 4 Except as otherwise provided in 30-2-505, the right of a seller or lessor of goods under chapter 2 or 2A to retain  
 5 or acquire possession of the goods in not a "security interest", but a seller or lessor may also acquire a "security  
 6 interest" by complying with chapter 9A. The retention or reservation of title by a seller of goods notwithstanding  
 7 shipment or delivery to the buyer ( 30-2-401) is limited in effect to a reservation of a "security interest". Whether  
 8 a transaction in the form of a lease creates a "security interest" is determined pursuant to 30-1-211.

9 (kk) "Send" in connection with a ~~writing, record, or notice~~ notification means:

10 (i) to deposit in the mail, ~~or deliver for transmission, or transmit~~ by any other usual means of  
 11 communication, with postage or cost of transmission provided for, ~~and properly addressed, and in the case of~~  
 12 ~~an instrument, to an address specified thereon or otherwise agreed, or if there be none~~ addressed to any  
 13 address reasonable under the circumstances; or

14 (ii) ~~in any other way to cause to be received any record or notice within the time it would have~~  
 15 ~~arrived if properly sent~~ to cause the record or notification to be received within the time it would have been  
 16 received if properly sent under subsection (2)(kk)(i).

17 (ll) ~~(i) "Signed" includes any symbol executed or adopted with present intention to adopt or accept~~  
 18 ~~a writing.~~ "Sign" means, with present intent to authenticate or adopt a record:

19 (A) to execute or adopt a tangible symbol; or

20 (B) to attach to or logically associate with the record an electronic symbol, sound, or process.

21 (ii) "Signed", "signing", and "signature" have corresponding meanings.

22 (mm) "Surety" includes a guarantor or other secondary obligor.

23 (nn) "Term" means a portion of an agreement that relates to a particular matter.

24 (oo) "Unauthorized" signature means a signature made without actual, implied, or apparent  
 25 authority. The term includes a forgery.

26 (pp) "Warehouse receipt" means a document of title issued by a person engaged in the business of  
 27 storing goods for hire.

28 (qq) "Writing" includes printing, typewriting, or any other intentional reduction to tangible form.

1 "Written" has a corresponding meaning."

2

3 **Section 4.** Section 30-1-212, MCA, is amended to read:

4 **"30-1-212. Value.** Except as otherwise provided in chapters 3 through 5 and [sections 94 through  
5 109], a person gives value for rights if the person acquires them:

6 (1) in return for a binding commitment to extend credit or for the extension of immediately available  
7 credit, whether or not drawn upon and whether or not a charge-back is provided for in the event of difficulties in  
8 collection;

9 (2) as security for, or in total or partial satisfaction of, a preexisting claim;

10 (3) by accepting delivery under a preexisting contract for purchase; or

11 (4) in return for any consideration sufficient to support a simple contract."

12

13 **Section 5.** Section 30-1-301, MCA, is amended to read:

14 **"30-1-301. Territorial applicability -- parties power to choose applicable law.** (1) Except as  
15 otherwise provided in this section, when a transaction bears a reasonable relation to this state and also to  
16 another state or nation, the parties may agree that the law either of this state or of the other state or nation shall  
17 govern their rights and duties.

18 (2) In the absence of an agreement effective under subsection (1) and except as provided in  
19 subsection (3), this code applies to transactions bearing an appropriate relation to this state.

20 (3) If one of the following provisions of this code specifies the applicable law, that provision  
21 governs and a contrary agreement is effective only to the extent permitted by the law so specified:

22 (a) Section 30-2-402;

23 (b) Sections 30-2A-105 and 30-2A-106;

24 (c) Section 30-4-102;

25 (d) Section 30-4A-507;

26 (e) Section 30-5-136;

27 (f) Section 30-8-120;

28 (g) Sections 30-9A-301 through 30-9A-307;

1 (h) [Section 100]."

3 **Section 6.** Section 30-2-102, MCA, is amended to read:

4 **"30-2-102. Scope -- certain security and other transactions excluded from this chapter. (1)**

5 Unless the context otherwise requires, and except as provided in subsection (3), this chapter applies to  
6 transactions in goods; it does not apply to any transaction which although in the form of an unconditional  
7 contract to sell or present sale is intended to operate only as a security transaction nor does this chapter impair  
8 or repeal any statute regulating sales to consumers, farmers or other specified classes of buyers and, in the  
9 case of a hybrid transaction, it applies to the extent provided in subsection (2).

10 (2) In a hybrid transaction:

11 (a) if the sale-of-goods aspects do not predominate, only the provisions of this chapter that relate  
12 primarily to the sale-of-goods aspects of the transaction apply, and the provisions that relate primarily to the  
13 transaction as a whole do not apply;

14 (b) if the sale-of-goods aspects predominate, this chapter applies to the transaction but does not  
15 preclude application in appropriate circumstances of other law to aspects of the transaction that do not relate to  
16 the sale of goods.

17 (3) This chapter does not:

18 (a) apply to a transaction that, even though in the form of an unconditional contract to sell or  
19 present sale, operates only to create a security interest; or

20 (b) impair or repeal a statute regulating sales to consumers, farmers, or other specified classes of  
21 buyers."

22

23 **Section 7.** Section 30-2-106, MCA, is amended to read:

24 **"30-2-106. Definitions -- "contract" -- "agreement" -- "contract for sale" -- "sale" -- "present**

25 **sale" -- "conforming" to contract -- "termination" -- "cancellation" -- "hybrid transaction". (1)** In this  
26 chapter unless the context otherwise requires "contract" and "agreement" are limited to those relating to the  
27 present or future sale of goods. "Contract for sale" includes both a present sale of goods and a contract to sell  
28 goods at a future time. A "sale" consists in the passing of title from the seller to the buyer for a price ( 30-2-

1 401). A "present sale" means a sale which is accomplished by the making of the contract.

2 (2) Goods or conduct including any part of a performance are "conforming" or conform to the  
3 contract when they are in accordance with the obligations under the contract.

4 (3) "Termination" occurs when either party pursuant to a power created by agreement or law puts  
5 an end to the contract otherwise than for its breach. On "termination" all obligations which are still executory on  
6 both sides are discharged but any right based on prior breach or performance survives.

7 (4) "Cancellation" occurs when either party puts an end to the contract for breach by the other and  
8 its effect is the same as that of "termination" except that the canceling party also retains any remedy for breach  
9 of the whole contract or any unperformed balance.

10 (5) "Hybrid transaction" means a single transaction involving a sale of goods and:

11 (a) the provision of services;

12 (b) a lease of other goods; or

13 (c) a sale, lease, or license of property other than goods."

14

15 **Section 8.** Section 30-2-201, MCA, is amended to read:

16 **"30-2-201. Formal requirements -- statute of frauds.** (1) Except as otherwise provided in this  
17 section a contract for the sale of goods for the price of \$500 or more is not enforceable by way of action or  
18 defense unless there is ~~some writing~~ a record sufficient to indicate that a contract for sale has been made  
19 between the parties and signed by the party against whom enforcement is sought or by the party's authorized  
20 agent or broker. A ~~writing~~ record is not insufficient because it omits or incorrectly states a term agreed upon but  
21 the contract is not enforceable under this subsection beyond the quantity of goods shown in the writing record.

22 (2) Between merchants if within a reasonable time a writing record in confirmation of the contract  
23 and sufficient against the sender is received and the party receiving it has reason to know its contents, it  
24 satisfies the requirements of subsection (1) against the party unless ~~written notice~~ in a record of objection to its  
25 contents is given within 10 days after it is received.

26 (3) A contract which does not satisfy the requirements of subsection (1) but which is valid in other  
27 respects is enforceable:

28 (a) if the goods are to be specially manufactured for the buyer and are not suitable for sale to

1 others in the ordinary course of the seller's business and the seller, before notice of repudiation is received and  
2 under circumstances which reasonably indicate that the goods are for the buyer, has made either a substantial  
3 beginning of their manufacture or commitments for their procurement; or

4 (b) if the party against whom enforcement is sought admits in the party's pleading, testimony, or  
5 otherwise in court that a contract for sale was made, but the contract is not enforceable under this provision  
6 beyond the quantity of goods admitted; or

7 (c) with respect to goods for which payment has been made and accepted or which have been  
8 received and accepted ( 30-2-606)."

9

10 **Section 9.** Section 30-2-202, MCA, is amended to read:

11 **"30-2-202. Final written expression -- parol or extrinsic evidence.** Terms with respect to which the  
12 confirmatory memoranda of the parties agree or which are otherwise set forth in a ~~writing-record~~ intended by  
13 the parties as a final expression of their agreement with respect to such terms as are included therein may not  
14 be contradicted by evidence of any prior agreement or of a contemporaneous oral agreement but may be  
15 explained or supplemented:

16 (a) (1) by course of dealing or usage of trade ( 30-1-205) or by course of performance ( 30-2-208);

17 and

18 (b) (2) by evidence of consistent additional terms unless the court finds the writing to have been  
19 intended also as a complete and exclusive statement of the terms of the agreement."

20

21 **Section 10.** Section 30-2-203, MCA, is amended to read:

22 **"30-2-203. Seals inoperative.** The affixing of a seal to a ~~writing-record~~ evidencing a contract for sale  
23 or an offer to buy or sell goods does not constitute the ~~writing-record~~ a sealed instrument and the law with  
24 respect to sealed instruments does not apply to such a contract or offer."

25

26 **Section 11.** Section 30-2-205, MCA, is amended to read:

27 **"30-2-205. Firm offers.** An offer by a merchant to buy or sell goods in a signed ~~writing-record~~ which  
28 by its terms gives assurance that it will be held open is not revocable, for lack of consideration, during the time

1 stated or if no time is stated for a reasonable time, but in no event may such period of irrevocability exceed 3  
2 months; but any such term of assurance on a form supplied by the offeree must be separately signed by the  
3 offeror."

4

5 **Section 12.** Section 30-2-209, MCA, is amended to read:

6 **"30-2-209. Modification, rescission and waiver.** (1) An agreement modifying a contract within this  
7 chapter needs no consideration to be binding.

8 (2) A signed agreement which excludes modification or rescission except by a signed writing or  
9 other signed record cannot be otherwise modified or rescinded, but except as between merchants such a  
10 requirement on a form supplied by the merchant must be separately signed by the other party.

11 (3) The requirements of the statute of frauds section of this chapter ( 30-2-201) must be satisfied if  
12 the contract as modified is within its provisions.

13 (4) Although an attempt at modification or rescission does not satisfy the requirements of  
14 subsection (2) or (3) it can operate as a waiver.

15 (5) A party who has made a waiver affecting an executory portion of the contract may retract the  
16 waiver by reasonable notification received by the other party that strict performance will be required of any term  
17 waived, unless the retraction would be unjust in view of a material change of position in reliance on the waiver."

18

19 **Section 13.** Section 30-2A-102, MCA, is amended to read:

20 **"30-2A-102. Scope.** (1) This chapter applies to any transaction, regardless of form, that creates a  
21 lease and, in the case of a hybrid lease, this chapter applies to the extent provided in subsection (2).

22 (2) In a hybrid lease:

23 (a) if the lease-of-goods aspects do not predominate:

24 (i) only the provisions of this chapter that relate primarily to the lease-of-goods aspects of the  
25 transaction apply, and the provisions that relate primarily to the transaction as a whole do not apply;

26 (ii) 30-2A-209 applies if the lease is a finance lease; and

7 attached to or logically associated with the electronic copy and readily available for review, expressly provides  
8 that the chattel paper is governed by the law of a particular jurisdiction, that jurisdiction is the chattel paper's  
9 jurisdiction.

10 (d) If subsections (2)(a), (2)(b), and (2)(c) do not apply and the rules of the system in which the

6 (a) that the debtor has defaulted in connection with an obligation secured by specified collateral;

7 (b) that the secured party has exercised its postdefault remedies with respect to the collateral;

8 (c) that, by reason of the exercise, a transferee has acquired the rights of the debtor in the  
9 collateral; and

10 (d) the name and mailing address of the secured party, debtor, and transferee.

11 (2) A transfer statement entitles the transferee to the transfer of record of all rights of the debtor in  
12 the collateral specified in the statement in any official filing, recording, registration, or certificate of title system  
13 covering the collateral. If a transfer statement is presented with the applicable fee and request form to the  
14 official or office responsible for maintaining the system, the official or office shall:

15 (a) accept the transfer statement;

16 (b) promptly amend its records to reflect the transfer; and

17 (c) if applicable, issue a new appropriate certificate of title in the name of transferee.

18 (3) A transfer of the record or legal title to collateral to a secured party under subsection (2) or  
19 otherwise is not of itself a disposition of collateral under this chapter and does not of itself relieve the secured  
20 party of its duties under this chapter."

21

22 **Section 90.** Section 30-9A-620, MCA, is amended to read:

23 **"30-9A-620. Acceptance of collateral in full or partial satisfaction -- compulsory disposition of**  
24 **collateral.** (1) Except as otherwise provided in subsection (7), a secured party may accept collateral in full or  
25 partial satisfaction of the obligation it secures only if:

26 (a) the debtor consents to the acceptance under subsection (3);

27 (b) the secured party does not receive, within the time set forth in subsection (4), a notification of

- 5 the debtor consents to the acceptance; and
- 6 (d) subsection (5) does not require the secured party to dispose of the collateral.

- 8 (a) the secured party consents to the acceptance in ~~an authenticated~~ a signed record or sends a
- 9 proposal to the debtor; and
- 10 (b) the conditions of subsection (1) are met.
- 11 (3) For purposes of this section:
- 12 (a) a debtor consents to an acceptance of collateral in partial satisfaction of the obligation it
- 13 secures only if the debtor agrees to the terms of the acceptance in a record ~~authenticated~~ signed after default;
- 14 and
- 15 (b) a debtor consents to an acceptance of collateral in full satisfaction of the obligation it secures
- 16 only if the debtor agrees to the terms of the acceptance in a record ~~authenticated~~ signed after default or the
- 17 secured party:
- 18 (i) sends to the debtor after default a proposal that is unconditional or subject only to a condition
- 19 that collateral not in the possession of the secured party be preserved or maintained;
- 20 (ii) in the proposal, proposes to accept collateral in full satisfaction of the obligation it secures; and
- 21 (iii) does not receive a notification of objection ~~authenticated~~ signed by the debtor within 20 days
- 22 after the proposal is sent.
- 23 (4) To be effective under subsection (1)(b), a notification of objection must be received by the
- 24 secured party:
- 25 (a) in the case of a person to which the proposal was sent pursuant to 30-9A-621, within 20 days
- 26 after notification was sent to that person; and
- 27 (b) in other cases:
- 28 (i) within 20 days after the last notification was sent pursuant to 30-9A-621; or

1 (ii) if a notification was not sent, before the debtor consents to the acceptance under subsection

2 (3).

3 (5) A secured party that has taken possession of collateral shall dispose of the collateral pursuant  
4 to 30-9A-610 within the time specified in subsection (6) if:

5 (a) 60% of the cash price has been paid in the case of a purchase-money security interest in  
6 consumer goods; or

7 (b) 60% of the principal amount of the obligation secured has been paid in the case of a  
8 nonpurchase-money security interest in consumer goods.

9 (6) To comply with subsection (5), the secured party shall dispose of the collateral:

10 (a) within 90 days after taking possession; or

11 (b) within any longer period to which the debtor and all secondary obligors have agreed in an  
12 agreement to that effect entered into and signed after default by authenticating a record including a statement to  
13 that effect after default.

14 (7) In a consumer transaction, a secured party may not accept collateral in partial satisfaction of  
15 the obligation it secures."

17 **Section 91.** Section 30-9A-621, MCA, is amended to read:

18 **"30-9A-621. Notification of proposal to accept collateral.** (1) A secured party that desires to accept  
19 collateral in full or partial satisfaction of the obligation it secures shall send its proposal to:

20 (a) any person from which the secured party has received, before the debtor consented to the  
21 acceptance, ~~an authenticated~~ a signed notification of a claim of an interest in the collateral;

22 (b) any other secured party or lienholder that, 10 days before the debtor consented to the  
23 acceptance, held a security interest in or other lien on the collateral perfected by the filing of a financing  
24 statement that:

25 (i) identified the collateral;

26 (ii) was indexed under the debtor's name as of that date; and

27 (iii) was filed in the office or offices in which to file a financing statement against the debtor

1 (c) any other secured party that, 10 days before the debtor consented to the acceptance, held a  
2 security interest in the collateral perfected by compliance with a statute, regulation, or treaty described in 30-

4 (2) A secured party that desires to accept collateral in partial satisfaction of the obligation it  
5 secures shall send its proposal to any secondary obligor in addition to the persons described in subsection (1)."

7 **Section 92.** Section 30-9A-624, MCA, is amended to read:

8 **"30-9A-624. Waiver.** (1) A debtor or secondary obligor may waive the right to notification of  
9 disposition of collateral under 30-9A-611 only by ~~authenticating~~ an agreement to that effect entered into and

11 (2) A debtor may waive the right to require disposition of collateral under 30-9A-620(5) only by an  
12 agreement to that effect entered into and ~~authenticated~~ signed after default.

14 redeem collateral under 30-9A-623 only by an agreement to that effect entered into and signed after default."

9 secured party's belief is based on its reasonable reliance on:

10 (a) a debtor's representation concerning the purpose for which collateral was to be used, acquired,  
11 or held; or

12 (b) an obligor's representation concerning the purpose for which a secured obligation was  
13 incurred.

14 (4) A secured party is not liable to any person under 30-9A-625(3)(b) for its failure to comply with  
15 30-9A-616.

16 (5) A secured party is not liable under 30-9A-625(3)(b) more than once with respect to any one  
17 secured obligation.

18 (6) Subsections (1) and (2) do not apply to limit the liability of a secured party to a person if, at the  
19 time the secured party obtains control of collateral that is a controllable account, controllable electronic record,  
20 or controllable payment intangible or at the time the security interest attaches to the collateral, whichever is  
21 later:

22 (a) the person is a debtor or obligor; and

23 (b) the secured party knows that the information in subsection (2)(a)(i), (2)(a)(ii), or (2)(a)(iii)  
24 relating to the person is not provided by the collateral, a record attached to or logically associated with the  
25 collateral, or the system in which the collateral is recorded."

2           **NEW SECTION. Section 95. Definitions.** (1) As used in [sections 94 through 100], the following

4           (a)     (i) “Controllable electronic record” means a record stored in an electronic medium that can be

6           (ii)     The term does not include a controllable account, a controllable payment intangible, a deposit  
7 account, an electronic copy of a record evidencing chattel paper, an electronic document of title, investment  
8 property, a transferable record, or an electronic record that is currently authorized or adopted by a domestic or  
9 foreign government and is not a medium of exchange that was recorded and transferable in a system that  
10 existed and operated for the medium of exchange before the medium of exchange was authorized or adopted  
11 by a government.

12           (b)     “Qualifying purchaser” means a purchaser of a controllable electronic record or an interest in a  
13 controllable electronic record that obtains control of the controllable electronic record for value, in good faith,  
14 and without notice of a claim of a property right in the controllable electronic record.

15           (c)     “Transferable record” has the meaning provided for that term in:

16           (i)     Section 201(a)(1) of the Electronic Signatures in Global and National Commerce Act, 15 U.S.C.  
17 Section 7021(a)(1); or

18           (ii)     30-18-115(1).

19           (d)     “Value” has the meaning provided in 30-3-303(1), as if references in that subsection to an  
20 “instrument” were references to a controllable account, controllable electronic record, or controllable payment  
21 intangible.

22           (2)     The definitions in Title 30, chapter 9A, of “account debtor”, “controllable account”, “controllable  
23 payment intangible”, “chattel paper”, “deposit account”, and “investment property” apply to [sections 94 through  
24 100].

25           (3)     Title 30, chapter 1, contains general definitions and principles of construction and interpretation  
26 applicable throughout [sections 94 through 100].

27  
28           **NEW SECTION. Section 96. Relation to Title 30, chapter 9A, and consumer laws.** (1) If there is

1 conflict between Title 30, chapter 9A, and [sections 94 through 100], Title 30, chapter 9A, governs.

2 (2) A transaction subject to [sections 94 through 100] is subject to any applicable rule of law that  
3 establishes a different rule for consumers, Title 30, chapter 14, part 1, Title 31, chapter 1, and Title 32, chapter  
4 6, part 1.

5  
6 **NEW SECTION. Section 97. Rights in controllable account, controllable electronic record, and**  
7 **controllable payment intangible.** (1) This section applies to the acquisition and purchase of rights in a  
8 controllable account or controllable payment intangible, including the rights and benefits under subsections (3),  
9 (4), (5), (7), and (8) of a purchaser and qualifying purchaser, in the same manner this section applies to a  
10 controllable electronic record.

11 (2) To determine whether a purchaser of a controllable account or a controllable payment  
12 intangible is a qualifying purchaser, the purchaser obtains control of the account or payment intangible if it  
13 obtains control of the controllable electronic record that evidences the account or payment intangible.

14 (3) Except as provided in this section, law other than [sections 94 through 100] determines  
15 whether a person acquires a right in a controllable electronic record and the right the person acquires.

16 (4) A purchaser of a controllable electronic record acquires all rights in the controllable electronic  
17 record that the transferor had or had power to transfer, except that a purchaser of a limited interest in a  
18 controllable electronic record acquires rights only to the extent of the interest purchased.

19 (5) A qualifying purchaser acquires its rights in the controllable electronic record free of a claim of  
20 a property right in the controllable electronic record.

21 (6) Except as provided in subsections (1) and (5) for a controllable account and a controllable  
22 payment intangible or law other than [sections 94 through 100], a qualifying purchaser takes a right to payment,  
23 right to performance, or other interest in property evidenced by the controllable electronic record subject to a  
24 claim of a property right in the right to payment, right to performance, or other interest in property.

25 (7) An action may not be asserted against a qualifying purchaser based on both a purchase by the  
26 qualifying purchaser of a controllable electronic record and a claim of a property right in another controllable  
27 electronic record, whether the action is framed in conversion, replevin, constructive trust, equitable lien, or other  
28 theory.

1 (8) Filing of a financing statement under Title 30, chapter 9A, is not notice of a claim of a property  
2 right in a controllable electronic record.

3  
4 **NEW SECTION. Section 98. Control of controllable electronic record.** (1) A person has control of  
5 a controllable electronic record if the electronic record, a record attached to or logically associated with the  
6 electronic record, or a system in which the electronic record is recorded:

7 (a) gives the person:

8 (i) power to avail itself of substantially all the benefit from the electronic record; and

9 (ii) exclusive power, subject to subsection (2), to:

10 (A) prevent others from availing themselves of substantially all the benefit from the electronic  
11 record; and

12 (B) transfer control of the electronic record to another person or cause another person to obtain  
13 control of another controllable electronic record as a result of the transfer of the electronic record; and

14 (b) enables the person readily to identify itself in any way, including by name, identifying number,  
15 cryptographic key, office, or account number, as having the powers specified in subsection (1)(a).

16 (2) Subject to subsection (3), a power is exclusive under subsection (1)(a)(ii)(A) and (1)(a)(ii)(B)  
17 even if:

18 (a) the controllable electronic record, a record attached to or logically associated with the  
19 electronic record, or a system in which the electronic record is recorded limits the use of the electronic record or  
20 has a protocol programmed to cause a change, including a transfer or loss of control or a modification of  
21 benefits afforded by the electronic record; or

22 (b) the power is shared with another person.

23 (3) A power of a person is not shared with another person under subsection (2)(b) and the  
24 person's power is not exclusive if:

25 (a) the person can exercise the power only if the power also is exercised by the other person; and

26 (b) the other person:

27 (i) can exercise the power without exercise of the power by the person; or

28 (ii) is the transferor to the person of an interest in the controllable electronic record or a

1 controllable account or controllable payment intangible evidenced by the controllable electronic record.

2 (4) If a person has the powers specified in subsections (1)(a)(ii)(A) and (1)(a)(ii)(B), the powers are  
3 presumed to be exclusive.

4 (5) A person has control of a controllable electronic record if another person, other than the  
5 transferor to the person of an interest in the controllable electronic record or a controllable account or  
6 controllable payment intangible evidenced by the controllable electronic record:

7 (a) has control of the electronic record and acknowledges that it has control on behalf of the  
8 person; or

9 (b) obtains control of the electronic record after having acknowledged that it will obtain control of  
10 the electronic record on behalf of the person.

11 (6) A person that has control under this section is not required to acknowledge that it has control  
12 on behalf of another person.

13 (7) If a person acknowledges that it has or will obtain control on behalf of another person, unless  
14 the person otherwise agrees or a law other than Title 30, chapter 9A, or [sections 94 through 100] otherwise  
15 provides, the person does not owe any duty to the other person and is not required to confirm the  
16 acknowledgment to any other person.

17

18 **NEW SECTION. Section 99. Discharge of account debtor on controllable account or**

19 **controllable payment intangible.** (1) An account debtor on a controllable account or controllable payment  
20 intangible may discharge its obligation by paying:

21 (a) the person having control of the controllable electronic record that evidences the controllable  
22 account or controllable payment intangible; or

23 (b) except as provided in subsection (2), a person that formerly had control of the controllable  
24 electronic record.

25 (2) Subject to subsection (4), the account debtor may not discharge its obligation by paying a  
26 person that formerly had control of the controllable electronic record if the account debtor receives a notification  
27 that:

28 (a) is signed by a person that formerly had control or the person to which control was transferred;

1 (b) reasonably identifies the controllable account or controllable payment intangible;

2 (c) notifies the account debtor that control of the controllable electronic record that evidences the  
3 controllable account or controllable payment intangible was transferred;

4 (d) identifies the transferee, in any reasonable way, including by name, identifying number,  
5 cryptographic key, office, or account number; and

6 (e) provides a commercially reasonable method by which the account debtor is to pay the  
7 transferee.

8 (3) After receipt of a notification that complies with subsection (2), the account debtor may  
9 discharge its obligation by paying in accordance with the notification and may not discharge the obligation by  
10 paying a person that formerly had control.

11 (4) Subject to subsection (8), notification is ineffective under subsection (2):

12 (a) unless, before the notification is sent, the account debtor and the person that, at that time, had  
13 control of the controllable electronic record that evidences the controllable account or controllable payment  
14 intangible agree in a signed record to a commercially reasonable method by which a person may furnish  
15 reasonable proof that control has been transferred;

16 (b) to the extent an agreement between the account debtor and seller of a payment intangible  
17 limits the account debtor's duty to pay a person other than the seller and the limitation is effective under law  
18 other than [sections 94 through 100]; or

19 (c) at the option of the account debtor, if the notification notifies the account debtor to:

20 (i) divide a payment;

21 (ii) make less than the full amount of an installment or other periodic payment; or

22 (iii) pay any part of a payment by more than one method or to more than one person.

23 (5) Subject to subsection (8), if requested by the account debtor, the person giving the notification  
24 under subsection (2) seasonably shall furnish reasonable proof, using the method in the agreement referred to  
25 in subsection (4)(a), that control of the controllable electronic record has been transferred. Unless the person  
26 complies with the request, the account debtor may discharge its obligation by paying a person that formerly had  
27 control, even if the account debtor has received a notification under subsection (2).

28 (6) A person furnishes reasonable proof under subsection (5) that control has been transferred if

1 the person demonstrates, using the method in the agreement referred to in subsection (4)(a), that the  
2 transferee has the power to:

3 (a) avail itself of substantially all the benefit from the controllable electronic record;

4 (b) prevent others from availing themselves of substantially all the benefit from the controllable  
5 electronic record; and

6 (c) transfer the powers specified in subsections (6)(a) and (6)(b) to another person.

7 (7) Subject to subsection (8), an account debtor may not waive or vary its rights under subsections  
8 (4)(a) and (5) or its option under subsection (4)(c).

9 (8) This section is subject to law other than [sections 94 through 100] which establishes a different  
10 rule for an account debtor who is an individual and who incurred the obligation primarily for personal, family, or  
11 household purposes.

12

13 **NEW SECTION. Section 100. Governing law.** (1) (1) Except as provided in subsection (2), the local  
14 law of a controllable electronic record's jurisdiction governs a matter covered by [sections 94 through 100].

15 (2) For a controllable electronic record that evidences a controllable account or controllable  
16 payment intangible, the local law of the controllable electronic record's jurisdiction governs a matter covered by  
17 [section 99] unless an effective agreement determines that the local law of another jurisdiction governs.

18 (3) The following rules determine a controllable electronic record's jurisdiction under this section:

19 (a) If the controllable electronic record, or a record attached to or logically associated with the  
20 controllable electronic record and readily available for review, expressly provides that a particular jurisdiction is  
21 the controllable electronic record's jurisdiction for purposes of this code or [sections 94 through 100], that  
22 jurisdiction is the controllable electronic record's jurisdiction.

23 (b) If subsection (3)(a) does not apply and the rules of the system in which the controllable  
24 electronic record is recorded are readily available for review and expressly provide that a particular jurisdiction  
25 is the controllable electronic record's jurisdiction for purposes of this code or [sections 94 through 100], that  
26 jurisdiction is the controllable electronic record's jurisdiction.

27 (c) If subsections (3)(a) and (3)(b) do not apply and the controllable electronic record, or a record  
28 attached to or logically associated with the controllable electronic record and readily available for review,

1 expressly provides that the controllable electronic record is governed by the law of a particular jurisdiction, that  
2 jurisdiction is the controllable electronic record's jurisdiction.

3 (d) If subsections (3)(a) through (3)(c) do not apply and the rules of the system in which the  
4 controllable electronic record is recorded are readily available for review and expressly provide that the  
5 controllable electronic record or the system is governed by the law of a particular jurisdiction, that jurisdiction is  
6 the controllable electronic record's jurisdiction.

7 (e) If subsections (3)(a) through (3)(d) do not apply, the controllable electronic record's jurisdiction  
8 is the District of Columbia.

9 (4) (a) If subsection (3)(e) applies and [sections 94 through 100] are not in effect in the District of  
10 Columbia without material modification, the governing law for a matter covered by [sections 94 through 100] is  
11 the law of the District of Columbia as though [sections 94 through 100] were in effect in the District of Columbia  
12 without material modification.

13 (b) In this subsection (4), "[sections 94 through 100]" means Article 12 of Uniform Commercial  
14 Code Amendments (2022).

15 (5) To the extent subsections (1) and (2) provide that the local law of the controllable electronic  
16 record's jurisdiction governs a matter covered by [sections 94 through 100], that law governs even if the matter  
17 or a transaction to which the matter relates does not bear any relation to the controllable electronic record's  
18 jurisdiction.

19 (6) The rights acquired under [section 95] by a purchaser or qualifying purchaser are governed by  
20 the law applicable under this section at the time of purchase.

21  
22 **NEW SECTION. Section 101. Title.** [Sections 101 through 109] may be cited as the "Transitional  
23 Provisions for Uniform Commercial Code Amendments (2022)".

24  
25 **NEW SECTION. Section 102. Definitions.** (1) In [sections 101 through 109], the following definitions  
26 apply:

27 (a) "Adjustment date" means July 1, 2025, or the date that is 1 year after [the effective date of this  
28 act], whichever is later.

1 (b) “[Sections 94 through 100]” means Chapter 12 of the Uniform Commercial Code.

2 (c) “Chapter 12 property” means a controllable account, controllable electronic record, or  
3 controllable payment intangible.

4 (2) The following definitions in other articles of the Uniform Commercial Code apply to [sections  
5 101 through 109]:

6 (a) “Controllable account”. 30-9A-102.

7 (b) “Controllable electronic record”. [Section 95].

8 (c) “Controllable payment intangible”. 30-9A-102.

9 (d) “Financing statement”. 30-9A-102.

10 (3) Title 30, chapter 1, contains general definitions and principles of construction and interpretation  
11 applicable throughout [sections 101 through 109].

12

13 **NEW SECTION. Section 103. Savings clause.** Except as provided in [sections 102 through 107], a  
14 transaction validly entered into before [the effective date of this act] and the rights, duties, and interests flowing  
15 from the transaction remain valid thereafter and may be terminated, completed, consummated, or enforced as  
16 required or permitted by law other than the Uniform Commercial Code or, if applicable, the Uniform Commercial  
17 Code, as though [this act] had not taken effect.

18

19 **NEW SECTION. Section 104. Savings clause.** (1) Except as provided in [sections 102 through 107],  
20 Title 30, chapter 9A, as amended by [this act] and [sections 94 through 100] apply to a transaction, lien, or  
21 other interest in property, even if the transaction, lien, or interest was entered into, created, or acquired before  
22 [the effective date of this act].

23 (2) Except as provided in subsection (3) and [sections 103 through 107]:

24 (a) a transaction, lien, or interest in property that was validly entered into, created, or transferred  
25 before [the effective date of this act] and was not governed by the Uniform Commercial Code, but would be  
26 subject to Title 30, chapter 9A, as amended by [this act] or [sections 94 through 100] if it had been entered into,  
27 created, or transferred on or after [the effective date of this act], including the rights, duties, and interests  
28 flowing from the transaction, lien, or interest, remains valid on and after [the effective date of this act]; and

1 (b) the transaction, lien, or interest may be terminated, completed, consummated, and enforced as  
2 required or permitted by [this act] or by the law that would apply if [this act] had not taken effect.

3 (3) [This act] does not affect an action, case, or proceeding commenced before [the effective date  
4 of this act].

5  
6 **NEW SECTION. Section 105. Security interest perfected before effective date.** (1) A security  
7 interest that is enforceable and perfected immediately before [the effective date of this act] is a perfected  
8 security interest under [this act] if, on [the effective date of this act], the requirements for enforceability and  
9 perfection under [this act] are satisfied without further action.

10 (2) If a security interest is enforceable and perfected immediately before [the effective date of this  
11 act], but the requirements for enforceability or perfection under [this act] are not satisfied on [the effective date  
12 of this act], the security interest:

13 (a) is a perfected security interest until the earlier of the time perfection would have ceased under

16 enforceability under 30-9A-203, as amended by [this act], before the adjustment date; and

17 (c) remains perfected thereafter only if the requirements for perfection under [this act] are satisfied  
18 before the time specified in subsection (2)(a).

19  
20 **NEW SECTION. Section 106. Security interest unperfected before effective date.** A security  
21 interest that is enforceable immediately before [the effective date of this act] but is unperfected at that time:

22 (1) remains an enforceable security interest until the adjustment date;

23 (2) remains enforceable thereafter if the security interest becomes enforceable under 30-9A-203,  
24 as amended by [this act], on [the effective date of this act] or before the adjustment date; and

25 (3) becomes perfected:

26 (a) without further action, on [the effective date of this act] if the requirements for perfection under  
27 [this act] are satisfied before or at that time; or

28 (b) when the requirements for perfection are satisfied if the requirements are satisfied after that

1 time.

2

3 **NEW SECTION. Section 107. Effectiveness of actions taken before effective date.** (1) If action,  
4 other than the filing of a financing statement, is taken before [the effective date of this act] and the action would  
5 have resulted in perfection of the security interest had the security interest become enforceable before [the  
6 effective date of this act], the action is effective to perfect a security interest that attaches under [this act] before  
7 the adjustment date. An attached security interest becomes unperfected on the adjustment date unless the  
8 security interest becomes a perfected security interest under [this act] before the adjustment date.

9 (2) The filing of a financing statement before [the effective date of this act] is effective to perfect a  
10 security interest on [the effective date of this act] to the extent the filing would satisfy the requirements for  
11 perfection under [this act].

12 (3) The taking of an action before [the effective date of this act] is sufficient for the enforceability of  
13 a security interest on [the effective date of this act] if the action would satisfy the requirements for enforceability  
14 under [this act].

15  
16 **NEW SECTION. Section 108. Priority.** (1) Subject to subsections (2) and (3), [this act] determines  
17 the priority of conflicting claims to collateral.

18 (2) Subject to subsection (3), if the priorities of claims to collateral were established before [the  
19 effective date of this act], Title 30, chapter 9A, as in effect before [the effective date of this act] determines  
20 priority.

21 (3) On the adjustment date, to the extent the priorities determined by Title 30, chapter 9A, as  
22 amended by [this act], modify the priorities established before [the effective date of this act], the priorities of  
23 claims to [sections 94 through 100] property established before [the effective date of this act] cease to apply.

24  
25 **NEW SECTION. Section 109. Priority of claims when priority rules of Title 30, chapter 9A, do**  
26 **not apply.** (1) Subject to subsections (2) and (3), [sections 94 through 100] determine the priority of conflicting  
27 claims to [sections 94 through 100] property when the priority rules of Title 30, chapter 9A, as amended by [this  
28 act] do not apply.

1           (2)     Subject to subsection (3), when the priority rules of Title 30, chapter 9A, as amended by [this  
2 act] do not apply and the priorities of claims to [sections 94 through 100] property were established before [the  
3 effective date of this act], law other than [sections 94 through 100] determines priority.

4           (3)     When the priority rules of Title 30, chapter 9A, as amended by [this act] do not apply, to the  
5 extent the priorities determined by [this act] modify the priorities established before [the effective date of this  
6 act], the priorities of claims to [sections 94 through 100] property established before [the effective date of this  
7 act] cease to apply on the adjustment date.

8

9           **Section 110.** Section 71-3-125, MCA, is amended to read:

10           **"71-3-125. Filing of agricultural lien statements.** (1) Unless a statement of an agricultural lien has  
11 been filed in the office of the secretary of state as provided in this chapter, a buyer who, in ordinary course of  
12 business as defined in 30-1-201(2)(j) (2)(i), buys a farm product takes it free of any lien created by this chapter  
13 even though the lien is otherwise perfected.

14           (2)     A statement of an agricultural lien is sufficient if it:

15           (a)     gives the names and addresses of the debtor and lienor;

16           (b)     describes the type of lien and its statutory authority;

17           (c)     describes the collateral;

18           (d)     contains the notation by the secretary of state of the date of filing and filing number;

19           (e)     is signed by the lienor;

20           (f)     describes the service or product furnished. If the collateral is farm products, the statement must  
21 state the county in which the farm products are located, designated by type of farm product.

22           (g)     states the price or wage agreed upon or, if the price or wage was not agreed upon, the  
23 reasonable value of the service or product furnished;

24           (h)     states the amount remaining unpaid;

25           (i)     states the terms and period of employment if it is a farm laborer's lien filed pursuant to part 4 of  
26 this chapter;

27           (j)     describes the land upon which seed or grain was or will be sown, planted, or used if it is a lien  
28 for seed or grain filed pursuant to part 7 of this chapter;

1 (k) describes the land upon which the grain or crops were grown and the place the grain or crops  
2 are presently stored if it is a thresher's lien filed pursuant to part 8 of this chapter;

3 (l) describes the land upon which the service was performed if it is a lien for spraying or dusting  
4 filed pursuant to part 9 of this chapter; and

5 (m) states the starting date of insurance coverage if it is a lien filed pursuant to part 7 of this  
6 chapter.

7 (3) The agricultural lien statement must be in the form prescribed by the secretary of state.

8 (4) The secretary of state shall:

9 (a) record the agricultural lien statement on the centralized computer system as set forth in 30-9A-  
10 501; and

11 (b) establish fees for such recordings as set forth in 30-9A-525.

12 (5) For the purposes of this section, an agricultural lien means a lien under part 4, 7, 8, or 9 of this  
13 chapter.

14 (6) A statement of an agricultural lien or continuation statement that has been filed at the office of  
15 the county clerk and recorder lapses on March 31, 1990, unless prior to that date there is filed in the office of  
16 the secretary of state a certified copy of the statement and all related documents on file with the county clerk  
17 and recorder."

18  
19 **NEW SECTION. Section 111. Central bank digital currency -- approval by state.** As applicable in  
20 this state, the term "money" does not include any central bank digital currency or any requirement to accept or  
21 use a central bank digital currency, unless the central bank digital currency is specifically recognized and  
22 approved by Montana law.

23  
24 **NEW SECTION. Section 112. Codification instruction.** (1) [Section 48] is intended to be codified as  
25 30-9A-107A, and the provisions of Title 30, chapters 1 through 9A, apply to [section 48].

26 (2) [Section 49] is intended to be codified as 30-9A-107B, and the provisions of Title 30, chapters 1  
27 through 9A, apply to [section 49].

28 (3) [Section 59] is intended to be codified as 30-9A-306A, and the provisions of Title 30, chapters 1

1 through 9A, apply to [section 59].

2 (4) [Section 60] is intended to be codified as 30-9A-306B, and the provisions of Title 30, chapters 1  
3 through 9A, apply to [section 60].

4 (5) [Section 65] is intended to be codified as 30-9A-314A, and the provisions of Title 30, chapters 1  
5 through 9A, apply to [section 65].

6 (6) [Section 70] is intended to be codified as 30-9A-326A, and the provisions of Title 30, chapters 1  
7 through 9A, apply to [section 70].

8 (7) [Sections 94 through 100] are intended to be codified as a new part in Title 30, chapter 12A,  
9 and the provisions of Title 30, chapters 1 through 9A, apply to [sections 94 through 100].

10 (8) [Sections 101 through 109] are intended to be codified as a new part in Title 30, chapter 12A,  
11 and the provisions of Title 30, chapters 1 through 9A, apply to [sections 101 through 109].

12 (9) [Sections 102 through 107] are intended to be codified as a new part in Title 30, chapter 9A,  
13 and the provisions of Title 30, chapters 1 through 9A, apply to [sections 102 through 107].

14 (10) [Section 110] is intended to be codified as a new part in Title 30, chapter 14, and the provisions  
15 of Title 30, chapter 14, apply to [section 110].

16

17 NEW SECTION. Section 113. Directions to code commissioner. The code commissioner is  
18 instructed to strike the reference to "tangible chattel paper" in 30-9A-338(2).

19

20 NEW SECTION. Section 114. Severability. If a part of [this act] is invalid, all valid parts that are  
21 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,  
22 the part remains in effect in all valid applications that are severable from the invalid applications.
