9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 7-3-1345, MCA, is amended to read:
12	"7-3-1345. Fire department. (1)(1) The fire department of the municipality is in the charge of a
13	director, who shall be chief thereof and must have a director of fire service or a fire chief who shall manage and
14	control the department in the manner prescribed by the ordinances of the municipality.
15	(2) A RIGHT OR BENEFIT OF ANY MEMBER OF A VOLUNTEER FIRE DISTRICT, COMPANY, OR DEPARTMENT
16	CREATED PURSUANT TO THE PROVISIONS OF TITLE 7, CHAPTER 33, IN A RETIREMENT OR PENSION PLAN OR PAYMENTS
17	PROVIDED UNDER TITLE 19, CHAPTER 17, MAY NOT BE ABROGATED BY THE ADOPTION OF A CITY-COUNTY CONSOLIDATED
18	LOCAL GOVERNMENT UNLESS OTHERWISE SPECIFICALLY PROVIDED BY CHARTER.
19	(2) (a) Notwithstanding any other provision of law, the adoption of a consolidated county municipal
20	government shall have no effect on the existence, rights, or duties of any voluntary fire department or fire
21	district created and legally in existence pursuant to the provisions of parts 21 and 23 of chapter 33.
22	(b) Nothing in this part or part 12 shall be construed to prohibit the creation of voluntary fire
23	departments or fire districts pursuant to the provisions of parts 21 and 23 of chapter 33 within consolidated
24	county municipalities.
25	(c) Voluntary fire departments or fire districts within consolidated county municipalities may only be
26	organized, created, supported, financed, dissolved, and managed and their boundaries may only be changed
27	pursuant to the provisions of parts 21 and 23 of chapter 33. These organizations may enter mutual aid
28	agreements as provided by 7-33-2108."
