4	A BILL FOR AN ACT ENTITLED: "AN ACT ESTABLISHING KILL SWITCH LAWS; PROHIBITING AN ENTITY
5	FROM REMOTELY ACTIVATING A KILL SWITCH WITHOUT A WARRANT; PROVIDING AN EXCEPTION
6	EXCEPTIONS; PROVIDING DAMAGES; AND PROVIDING AN EFFECTIVE DATE."

8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
9	
10	NEW SECTION. Section 1. Kill switches in electronic consumer products on PERSONALLY OWNED
11	PROPERTY warrant required exceptions definitions. (1) An entity may not activate a kill switch on an
12	individual's electronic consumer product PERSONALLY OWNED PROPERTY without a court order or a warrant
13	issued pursuant to Title 46, chapter 5, part 2.
14	(2) This section does not apply to:
15	
16	(A) subscriptions, memberships, and other recurring-payment programs or to leased electronic
17	consumer products OR TO MOTOR VEHICLES SUBJECT TO COLLECTIONS. In the event an individual neglects to make
18	regular payments, the entity may activate a kill switch to turn off the individual's subscribed services.
19	(B) A MECHANISM OR FEATURE THAT:
20	(I) ADDRESSES AN IMMINENT CRITICAL SAFETY ISSUE IMPACTING A MECHANICAL OR SOFTWARE
21	COMPONENT OF A MOTOR VEHICLE;
22	(II) ACTIVATES WHEN A DRIVE OF A MOTOR VEHICLE IS INCAPACITATED, SUFFERS A MEDICAL EMERGENCY,
23	OR EXPERIENCES A LOSS OF CONSCIOUSNESS;
24	(III) TAKES CORRECTIVE ACTION IN A MOTOR VEHICLE WITH AN ENGAGED PARTIAL DRIVING AUTOMATION
25	FEATURE IF THE DRIVER IS NOT ATTENTIVE OR ENGAGED IN THE DRIVING TASK AND DOES NOT RESPOND TO WARNINGS;
26	(IV) BRINGS A MOTOR VEHICLE WITH AN ENGAGED AUTOMATED DRIVING SYSTEM TO A MINIMAL RISK
27	CONDITION; OR
28	(V) AUTOMATICALLY SHUTS OFF THE ENGINE OR MOTOR OF AN IDLING MOTOR VEHICLE THAT HAS BEEN



	1	LEFT ON FOR AN EXTENDED PERIOD OF TIME WHILE IN THE PARK POSITION.
	2	(3) As used in [sections 1 and 2], the following definitions apply:
	3	(a) "Electronic consumer product" includes electronic devices as defined in 45-6-310 as well as
	4	motor vehicles as defined in 61-1-101.
I	5	(b) (A) "Entity" means a company that manufactures or distributes an electronic consumer product
	6	PERSONALLY OWNED PROPERTY or that provides service for an electronic consumer product's ITS functionality.
	7	(c) (B) "Hard reset" means the restoration of an electronic consumer product PERSONALLY OWNED
	8	PROPERTY to the state the electronic consumer product IT was in when it left the factory. Other terms commonly
	9	used are "factory reset" and "master reset".
	10	(d) (C) "Individual" means a natural person.
	11	(e) (D) "Kill switch" means a mechanism that may be engaged remotely, regardless of the owner's
	12	consent, and is used to:
	13	(i) shut down or perform a hard reset on an electronic consumer product <u>PERSONALLY OWNED</u>
	14	PROPERTY;
	15	(ii) hasten the battery drainage of an electronic consumer product <u>PERSONALLY OWNED PROPERTY</u> ;
	16	or
	17	(iii) shorten the software lifespan of an electronic consumer product PERSONALLY OWNED PROPERTY.

	19	NEW SECTION. Section 2. Enforcement damages. (1) A violation of [section 1] is a violation of
	20	30-14-103.
	21	(2) The department of justice may bring an action to restrain any unlawful act pursuant to the
	22	provisions of Title 30, chapter 14, part 1.
	23	(3) An individual whose electronic consumer product <u>PERSONALLY OWNED PROPERTY</u> has a kill
	24	switch activated in violation of [section 1] may bring an action pursuant to 30-14-133, except that:
	25	(a) the individual needs to show only a violation of [section 1] for that individual's electronic
	26	consumer product PERSONALLY OWNED PROPERTY and is not required to show any other ascertainable loss of
	27	money or property; and
	28	(b) the individual is entitled to statutory damages of \$10,000 for each violation of [section 1] in

1	addition to any other damages or monetary award pursuant to 30-14-133.

3	NEW SECTION. Section 3. Codification instruction. [Sections 1 and 2] are intended to be codified
4	as a new part in Title 30, chapter 14, and the provisions of Title 30, chapter 14, apply to [sections 1 and 2].
5	
6	NEW SECTION. Section 4. Effective date. [This act] is effective October 1, 2025.
