10	NEW SECTION. Section 1. Kill switches in electronic consumer products on PERSONALLY OWNED				
11	PROPERTY warrant required exceptions definitions. (1) An entity may not activate a kill switch on an				
12	individual's electronic consumer product PERSONALLY OWNED PROPERTY without a court order or a warrant				
13	issued pursuant to Title 46, chapter 5, part 2.				
14	(2) This section does not apply to:				
15	(A) subscriptions, memberships, and other recurring-payment programs or to leased electronic				
16	consumer products OR TO MOTOR VEHICLES SUBJECT TO COLLECTIONS. In the event an individual neglects to make				
17	regular payments, the entity may activate a kill switch to turn off the individual's subscribed services.				
18	(B) A MECHANISM OR FEATURE THAT:				
19	(I) ADDRESSES AN IMMINENT CRITICAL SAFETY ISSUE IMPACTING A MECHANICAL OR SOFTWARE				
20	COMPONENT OF A MOTOR VEHICLE;				
21	(II) ACTIVATES WHEN A DRIVER OF A MOTOR VEHICLE IS INCAPACITATED, SUFFERS A MEDICAL EMERGENCY,				
22	OR EXPERIENCES A LOSS OF CONSCIOUSNESS;				
23	(III) TAKES CORRECTIVE ACTION IN A MOTOR VEHICLE WITH AN ENGAGED PARTIAL DRIVING AUTOMATION				
24	FEATURE IF THE DRIVER IS NOT ATTENTIVE OR ENGAGED IN THE DRIVING TASK AND DOES NOT RESPOND TO WARNINGS;				
25	(IV) BRINGS A MOTOR VEHICLE WITH AN ENGAGED AUTOMATED DRIVING SYSTEM TO A MINIMAL RISK				
26	CONDITION; OR				
27	(V) AUTOMATICALLY SHUTS OFF THE ENGINE OR MOTOR OF AN IDLING MOTOR VEHICLE THAT HAS BEEN				
28	LEFT ON FOR AN EXTENDED PERIOD OF TIME WHILE IN THE PARK POSITION.

18		<u>NEW S</u>	ECTION. Section 2. Enforcement damages. (1) A violation of [section 1] is a violation of	
19	30-14-1	103.		
20		(2)	The department of justice may bring an action to restrain any unlawful act pursuant to the	
21	provisions of Title 30, chapter 14, part 1.			
22		(3)	An individual whose electronic consumer product PERSONALLY OWNED PROPERTY has a kill	
23	switch activated in violation of [section 1] may bring an action pursuant to 30-14-133, except that:			
24		(a)	the individual needs to show only a violation of [section 1] for that individual's electronic	
25	consum	ner prodi	uct PERSONALLY OWNED PROPERTY and is not required to show any other ascertainable loss of	
26	money or property; and			
27		(b)	the individual is entitled to statutory damages of \$10,000 for each violation of [section 1] in	
28	additior	n to any	other damages or monetary award pursuant to 30-14-133.
