7 A BILL FOR AN ACT ENTITLED: "AN ACT PROVIDING TAX CREDITS FOR CHILDREN AND CHILD CARE;
8 PROVIDING FOR A CHILD TAX CREDIT; PROVIDING FOR AN INCOME TAX CREDIT FOR CHILD-CARE
9 WORKERS; PROVIDING FOR AN EMPLOYER TAX CREDIT FOR DEPENDENT CARE ASSISTANCE;
10 PROVIDING THAT THE CREDITS ARE ADJUSTED FOR INFLATION; PROVIDING DEFINITIONS;
11 PROVIDING RULEMAKING AUTHORITY; AMENDING SECTION 15-30-2303, MCA; AND PROVIDING AN
12 APPLICABILITY DATE."

14 WHEREAS, nearly 60% of Montana's counties are classified as child-care deserts; and
15 WHEREAS, Montana's total child care capacity meets only 44% of the estimated demand, and infant
16 capacity meets only 34% of the estimated demand; and

17 WHEREAS, the average cost of child care for children under 5 years of age in Montana is
18 approximately \$20,000 a year; and

19 WHEREAS, Montana's child care crisis is preventing thousands of Montanans from entering or
20 returning to the workforce.

22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

23
24 **NEW SECTION. Section 1. Child tax credit.** (1) Except as provided in subsection (3), a resident
25 taxpayer who is permitted a child tax credit under section 24 of the Internal Revenue Code, 26 U.S.C. 24, is
26 allowed a credit against the taxes imposed by this chapter for each qualifying child of the taxpayer.

27 (2) Subject to subsection (5), the amount of the credit is \$1,200 for each qualifying child.

28 (3) To claim the credit, a taxpayer must have:

25 **NEW SECTION. Section 2. Credit for child-care workers -- rulemaking.** (1) A resident taxpayer is
26 allowed a credit against the tax imposed by this chapter for employment as a child-care worker.
27 (2) The amount of the credit is equal to \$1,600.
28 (3) To be eligible for the credit under this section, a child-care worker must have been employed

1 for at least 6 months of the tax year and worked a minimum of 20 hours a week.

2 (4) The taxpayer is entitled to a refund equal to the amount by which the credit exceeds the
3 taxpayer's liability or, if the taxpayer has no tax liability under this chapter, a refund equal to the amount of the
4 credit. The credit may be claimed by filing a Montana income tax return.

5 (5) The department may adopt rules to administer this credit.

6 (6) The department shall annually adjust the credit provided for in this section by the inflation factor
7 for the following tax year and round to the nearest \$100.

8 (7) For the purposes of this section, the following definitions apply:

9 (a) "Child-care worker" means a person listed in the department of public health and human
10 services' child care ~~under the big sky system licensing data system, a tribal child care development fund~~
11 ~~administered program, or a head start or early head start program~~ who:

12 (i) owns or is employed in a licensed, ~~tribally licensed~~, or registered day-care center, day-care
13 facility, family day-care home, or group day-care home as those terms are defined in 52-2-703; ~~or~~

14 (ii) ~~owns or is employed by a head start or early start program; or~~

15 (iii) works as an early childhood teacher, early childhood assistant, school-age teacher, or director
16 or owner of a center or facility provided for in subsection (7)(a)(i) ~~or (7)(a)(ii)~~.

17 (b) "Inflation factor" means a number determined for each tax year by dividing the consumer price
18 index for June of the previous tax year by the consumer price index for June 2025.

19
20 **NEW SECTION. Section 3. Business-supported dependent care credit.** (1) There is a credit
21 against the taxes otherwise due under Title 15, chapter 31, and this chapter for an employer for amounts paid
22 or incurred during the tax year by the employer for dependent care assistance actually provided to or on behalf
23 of an employee.

24 (2) (a) The amount of the credit allowed under subsection (1) is equal to the amount paid or
25 incurred by the employer during the tax year, but the credit may not exceed \$5,000 of dependent care
26 assistance actually provided to or on behalf of the employee.

27 (b) In the case of an onsite facility, the amount on which the credit allowed under subsection (1) is
28 based, with respect to a dependent, must be based on utilization and the value of the services provided.

1 (b) "Inflation factor" means a number determined for each tax year by dividing the consumer price
2 index for June of the previous tax year by the consumer price index for June 2025.

3
4 **NEW SECTION.** **Section 4. Business-supported dependent care credit.** There is a credit against
5 the taxes otherwise due under this chapter for an employer for amounts paid or incurred during the tax year by
6 the employer for dependent care assistance actually provided to or on behalf of an employee as provided in
7 [section 3].

9 Section 5. Section 15-30-2303, MCA, is amended to read:

10 **"15-30-2303. Tax credits subject to review by interim committee.** (1) The following tax credits
11 must be reviewed during the biennium commencing July 1, 2021, and during each biennium commencing 8
12 years thereafter:

13 (a) the credit for donations to innovative educational programs provided for in 15-30-2334, 15-30-
14 3110, and 15-31-158;

15 (b) the credit for donations to a student scholarship organization provided for in 15-30-2335, 15-
16 30-3111, and 15-31-159; and

17 (c) the adoption tax credit provided for in 15-30-2321; and

18 (d) the child tax credit provided for in [section 1];

19 (e) the credit for child-care workers provided for in [section 2]; and

20 (f) the business-supported dependent care credit provided for in [sections 3 and 4].

21 (2) The following tax credits must be reviewed during the biennium commencing July 1, 2023, and
22 during each biennium commencing 8 years thereafter:

23 (a) the credit for infrastructure use fees provided for in 17-6-316;

24 (b) the credit for contributions to a qualified endowment provided for in 15-30-2327 through 15-30-
25 2329, 15-31-161, and 15-31-162;

26 (c) the credit for property to recycle or manufacture using recycled material provided for in Title 15,
27 chapter 32, part 6; and

28 (d) the credit for preservation of historic buildings provided for in 15-30-2342 and 15-31-151.

3 (a) the residential property tax credit for the elderly provided for in 15-30-2337 through 15-30-
4 2341:

5 (b) the credit for unlocking state lands provided for in 15-30-2380;

6 (c) the job growth incentive tax credit provided for in 15-30-2361 and 15-31-175; and

7 (d) the credit for trades education and training provided for in 15-30-2359 and 15-31-174.

(4) The following tax credits must be reviewed during the biennium commencing July 1, 2027, and during each biennium commencing 8 years thereafter:

(a) the credit for hiring a registered apprentice or veteran apprentice provided for in 15-30-2357

11 and 15-31-173;

12 (b) the earned income tax credit provided for in 15-30-2318;

13 (c) the media production and postproduction credits provided for in 15-31-1007 and 15-31-1009;

14 and

15 (d) the credit for contractor's gross receipts provided for in 15-50-207.

16 (5) The revenue interim committee shall review the tax credits scheduled for review and make
17 recommendations in accordance with 5-11-210 at the conclusion of the full review to the legislature about
18 whether to eliminate or revise the credits. The committee shall also review any tax credit with an expiration date
19 or termination date that is not listed in this section in the biennium before the credit is scheduled to expire or
20 terminate.

(6) The revenue interim committee shall review the credits using the following criteria:

22 (a) whether the credit changes taxpayer decisions, including whether the credit rewards decisions
23 that may have been made regardless of the existence of the tax credit;

(b) to what extent the credit benefits some taxpayers at the expense of other taxpayers;

25 (c) whether the credit has out-of-state beneficiaries;

(d) the timing of costs and benefits of the credit and how long the credit is effective;

27 (e) any adverse impacts of the credit or its elimination and whether the benefits of continuance or
28 elimination outweigh adverse impacts; and

1 (f) the extent to which benefits of the credit affect the larger economy. (Subsection (3)(c)
2 terminates December 31, 2028--sec. 4, Ch. 391, L. 2023; subsection (3)(d) terminates December 31, 2028--
3 sec. 2, Ch. 576, L. 2023; subsection (1)(c) terminates December 31, 2031--sec. 6, Ch. 493, L. 2023.)"

5 **NEW SECTION.** **Section 6. Codification instruction.** (1) [Sections 1 through 3] are intended to be
6 codified as an integral part of Title 15, chapter 30, and the provisions of Title 15, chapter 30, apply to [sections
7 1 through 31].

8 (2) [Section 4] is intended to be codified as an integral part of Title 15, chapter 31, part 1, and the
9 provisions of Title 15, chapter 31, part 1, apply to [section 4].

11 **NEW SECTION. Section 7. Applicability.** [This act] applies to income tax years beginning after
12 December 31, 2025.
