8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	NEW SECTION. Section 1. Kill switches in electronic consumer products on PERSONALLY OWNED			
11	PROPERTY warrant required exceptions definitions. (1) An entity may not activate a kill switch on an			
12	individual's electronic consumer product PERSONALLY OWNED PROPERTY without a court order or a warrant			
13	issued pursuant to Title 46, chapter 5, part 2.			
14	(2) This section does not apply to:			
15	(A) subscriptions, memberships, and other recurring-payment programs, or to leased electronic			
16	consumer products ELECTRONIC DEVICES USED TO ENFORCE RETAIL INSTALLMENT SALE AGREEMENTS, LEASE			
17	AGREEMENTS, RENTAL AGREEMENTS, AND OTHER SECURED CREDITOR AGREEMENTS, OR TO MOTOR VEHICLES SUBJECT			
18	TO COLLECTIONS. In the event an individual neglects to make regular payments, the entity may activate a kill			
19	switch to turn off the individual's subscribed services.			
20	(B) A MECHANISM OR FEATURE THAT:			
21	(I) ADDRESSES AN IMMINENT CRITICAL SAFETY ISSUE IMPACTING A MECHANICAL OR SOFTWARE			
22	COMPONENT OF A MOTOR VEHICLE;			
23	(II) ACTIVATES WHEN A DRIVER OF A MOTOR VEHICLE IS INCAPACITATED, SUFFERS A MEDICAL EMERGENCY,			
24	OR EXPERIENCES A LOSS OF CONSCIOUSNESS;			
25	(III) TAKES CORRECTIVE ACTION IN A MOTOR VEHICLE WITH AN ENGAGED PARTIAL DRIVING AUTOMATION			
26	FEATURE IF THE DRIVER IS NOT ATTENTIVE OR ENGAGED IN THE DRIVING TASK AND DOES NOT RESPOND TO WARNINGS;			
27	(IV) BRINGS A MOTOR VEHICLE WITH AN ENGAGED AUTOMATED DRIVING SYSTEM TO A MINIMAL RISK			
28	CONDITION; OR

3	(3)	As used in [sections 1 and 2 THROUGH 3], the following definitions apply:	
4	(a)	"Electronic consumer product" includes electronic devices as defined in 45-6-310 as well as	
5	motor vehicles	as defined in 61-1-101.	
6	(b) (A)	"Entity" means a company that manufactures or distributes an electronic consumer product	
7	PERSONALLY OV	VNED PROPERTY or that provides service for an electronic consumer product's ITS functionality.	
8	(с)<u>(</u>В)	"Hard reset" means the restoration of an electronic consumer product PERSONALLY OWNED	
9	PROPERTY to th	e state the electronic consumer product $I\underline{T}$ was in when it left the factory. Other terms commonly	
10	used are "facto	ry reset" and "master reset".	
11	(d) (c)	"Individual" means a natural person.	
12	(e) (D)	"Kill switch" means a mechanism that may be engaged remotely, regardless of the owner's	
13	consent, and is used to:		
14	(i)	shut down or perform a hard reset on an electronic consumer product PERSONALLY OWNED	
15	PROPERTY;		
16	(ii)	hasten the battery drainage of an electronic consumer product PERSONALLY OWNED PROPERTY;	
17	or		
18	(iii)	shorten the software lifespan of an electronic consumer product PERSONALLY OWNED PROPERTY.

20	<u>NEW S</u>	SECTION. Section 2. Enforcement damages. (1) A violation of [section 1] is a violation of	
21	30-14-103.		
22	(2)	The department of justice may bring an action to restrain any unlawful act pursuant to the	
23	provisions of Title 30, chapter 14, part 1.		
24	(3)	An individual whose electronic consumer product PERSONALLY OWNED PROPERTY has a kill	
25	switch activated in violation of [section 1] may bring an action pursuant to 30-14-133, except that:		
26	(a)	the individual needs to show only a violation of [section 1] for that individual's electronic	
27	consumer prod	luct PERSONALLY OWNED PROPERTY and is not required to show any other ascertainable loss of	
28	money or property; and		



1	(b) the individual is entitled to statutory damages of \$10,000 for each violation of [section 1] in
2	addition to any other damages or monetary award pursuant to 30-14-133.
3	
4	NEW SECTION. SECTION 3. USER CONSENT. A KILL SWITCH MAY BE ACTIVATED ON STOLEN PERSONALLY
5	OWNED PROPERTY WITH CONSENT OF THE PROPERTY OWNER.
6	
7	NEW SECTION. Section 4. Codification instruction. [Sections 1 and 2 THROUGH 3] are intended to
8	be codified as a new part in Title 30, chapter 14, and the provisions of Title 30, chapter 14, apply to [sections 1
9	and 2 THROUGH 3].

11	NEW SECTION. Section 5. Effective date. [This act] is effective October 1, 2025.
