7 A BILL FOR AN ACT ENTITLED: "AN ACT PROVIDING TAX CREDITS FOR CHILDREN AND CHILD CARE;  
8 PROVIDING FOR A CHILD TAX CREDIT; PROVIDING FOR AN INCOME TAX CREDIT FOR CHILD-CARE  
9 WORKERS; PROVIDING FOR AN EMPLOYER TAX CREDIT FOR DEPENDENT CARE ASSISTANCE;  
10 PROVIDING THAT THE CREDITS ARE ADJUSTED FOR INFLATION; PROVIDING DEFINITIONS;  
11 PROVIDING RULEMAKING AUTHORITY; AMENDING SECTION 15-30-2303, MCA; AND PROVIDING AN  
12 APPLICABILITY DATE."

13  
14 WHEREAS, nearly 60% of Montana's counties are classified as child-care deserts; and  
15 WHEREAS, Montana's total child care capacity meets only 44% of the estimated demand, and infant  
16 capacity meets only 34% of the estimated demand; and

17 WHEREAS, the average cost of child care for children under 5 years of age in Montana is  
18 approximately \$20,000 a year; and

19 WHEREAS, Montana's child care crisis is preventing thousands of Montanans from entering or  
20 returning to the workforce.

22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

24 **NEW SECTION. Section 1. Child tax credit.** (1) Except as provided in subsection (3), a resident  
25 taxpayer who is permitted a child tax credit under section 24 of the Internal Revenue Code, 26 U.S.C. 24, is  
26 allowed a credit against the taxes imposed by this chapter for each qualifying child of the taxpayer.

27 (2) Subject to subsection (5), the amount of the credit is \$1,200 ~~\$600~~ \$1,200 for each qualifying

2 (3) To claim the credit, a taxpayer must have:

3 (a) proof of earned income; AND

4 ~~(b) investment of income of less than \$10,300; and~~

5 ~~(c)(B)~~ a valid social security number for each child claimed.

6 (4) The taxpayer is entitled to a refund equal to the amount by which the credit exceeds the  
7 taxpayer's tax liability or, if the taxpayer has no tax liability under this chapter, a refund equal to the amount of  
8 the credit. The credit may be claimed by filing a Montana income tax return.

9 (5) The credit in subsection (2) is reduced at a rate of \$50 for each \$1,000 of the taxpayer's federal  
10 adjusted gross income in excess of:

11 (a) \$40,000 for a single or head of household taxpayer OR A MARRIED INDIVIDUAL WHO DOES NOT  
MAKE A JOINT RETURN; and

13 (b) \$80,000 for a married taxpayer filing jointly OR A SURVIVING SPOUSE.

14 (6) The department shall annually adjust the credit amount in subsection (2) and the adjusted  
15 gross income amounts in subsections (5)(a) and (5)(b) by the inflation factor for the following tax year and  
16 round to the nearest \$100.

17 (7) For the purposes of this section, the following definitions apply:

18 (a) "Earned income" means earned income as defined in section 32 of the Internal Revenue Code,  
19 26 U.S.C. 32.

20 (b) "Inflation factor" means a number determined for each tax year by dividing the consumer price  
21 index for June of the previous tax year by the consumer price index for June 2025.

22 ~~(c) "Investment income" means "disqualified income" as defined in section 32 of the Internal~~  
23 ~~Revenue Code, 26 U.S.C. 32.~~

1 allowed a credit against the tax imposed by this chapter for employment as a child-care worker.

2 (2) The amount of the credit is equal to ~~\$1,600~~ \$1,000.

3 (3) To be eligible for the credit under this section, a child-care worker must have been employed

4 for at least 6 months of the tax year and worked a minimum of 20 hours a week.

5 (4) The taxpayer is entitled to a refund equal to the amount by which the credit exceeds the

6 taxpayer's liability or, if the taxpayer has no tax liability under this chapter, a refund equal to the amount of the

7 credit. The credit may be claimed by filing a Montana income tax return.

8 (5) The department may adopt rules to administer this credit.

9 (6) The department shall annually adjust the credit provided for in this section by the inflation factor

10 for the following tax year and round to the nearest \$100.

11 (7) For the purposes of this section, the following definitions apply:

12 (a) "Child-care worker" means a person listed in the department of public health and human

13 services' child care ~~under the big sky system~~ LICENSING DATA SYSTEM, A TRIBAL CHILD CARE DEVELOPMENT FUND

14 ADMINISTERED PROGRAM, OR A HEAD START OR EARLY HEAD START PROGRAM who:

15 (i) owns or is employed in a licensed TRIBALLY LICENSED, or registered day-care center, day-care

16 facility, family day-care home, or group day-care home as those terms are defined in 52-2-703; or

17 (ii) OWNS OR IS EMPLOYED BY A HEAD START OR EARLY START PROGRAM; OR

18 (iii) works as an early childhood teacher, early childhood assistant, school-age teacher, or director

19 or owner of a center or facility provided for in subsection (7)(a)(i) OR (7)(A)(II).

20 (b) "Inflation factor" means a number determined for each tax year by dividing the consumer price

21 index for June of the previous tax year by the consumer price index for June 2025.

23 **NEW SECTION. Section 3. Business-supported dependent care credit.** (1) There is a credit

24 against the taxes otherwise due under Title 15, chapter 31, and this chapter for an employer for amounts paid

25 or incurred during the tax year by the employer for dependent care assistance actually provided to or on behalf

26 of an employee.

27 (2) (a) The amount of the credit allowed under subsection (1) is equal to the amount paid or

1 incurred by the employer during the tax year, but the credit may not exceed ~~\$5,000~~ \$2,500 of dependent care  
2 assistance actually provided to or on behalf of the employee.

3 (b) In the case of an onsite facility, the amount on which the credit allowed under subsection (1) is  
4 based, with respect to a dependent, must be based on utilization and the value of the services provided.

5 (3) An amount paid or incurred by an employer to provide dependent care assistance to or on  
6 behalf of an employee does not qualify for the credit allowed under subsection (1):

7 (a) to the extent the amount is paid or incurred pursuant to a salary reduction plan; or  
8 (b) if the amount is paid or incurred for services not performed within this state.

9 (4) If the credit allowed under subsection (1) is claimed, the amount of a deduction allowed or  
10 allowable under this chapter for the amount that qualifies for the credit or on which the credit is based must be  
11 reduced by the dollar amount of the credit allowed. The election to claim a credit allowed under this section  
12 must be made at the time of filing the tax return.

13 (5) The amount on which the credit allowed under subsection (1) is based may not be included in  
14 the gross income of the employee to whom the dependent care assistance is provided. However, the amount  
15 excluded from the income of an employee under this section may not exceed the limitations provided in section  
16 129(b) of the Internal Revenue Code, 26 U.S.C. 129(b). For the purposes of Title 15, chapter 30, part 25, with  
17 respect to an employee to whom dependent care assistance is provided, "wages" does not include an amount  
18 excluded under this subsection.

19 (6) The credit allowed by this section may be refunded if the taxpayer has a tax liability less than  
20 the amount of the credit.

21 (7) If the taxpayer is an S. corporation, as defined in section 1361 of the Internal Revenue Code,  
22 26 U.S.C. 1361, OR A PARTNERSHIP and the taxpayer elects to take tax credit relief, the election may be made on  
23 behalf of the corporation's shareholders OR THE PARTNERS. A shareholder's OR PARTNER'S credit must be  
24 computed using the shareholder's pro rata share of the corporation's costs that qualify for the credit. In all other  
25 respects, the effect of the tax credit applies to the corporation OR PARTNERSHIP as otherwise provided by law.

26 (8) The department shall annually adjust the credit provided for in this section by the inflation factor  
27 for the following tax year and round to the nearest \$100.

1 (9) For the purposes of the credit allowed under subsection (1), the definitions and special rules  
2 contained in section 129(e) of the Internal Revenue Code, 26 U.S.C. 129(e), apply to the extent applicable.

3 (10) For the purposes of this section, the following definitions apply:

4 (a) "Employer" means an employer carrying on a business, trade, occupation, or profession in this  
5 state.

6 (b) "Inflation factor" means a number determined for each tax year by dividing the consumer price  
7 index for June of the previous tax year by the consumer price index for June 2025.

9        **NEW SECTION.** **Section 4. Business-supported dependent care credit.** There is a credit against  
10 the taxes otherwise due under this chapter for an employer for amounts paid or incurred during the tax year by  
11 the employer for dependent care assistance actually provided to or on behalf of an employee as provided in  
12 [section 3].

14       **Section 5.** Section 15-30-2303, MCA, is amended to read:

15       **"15-30-2303. Tax credits subject to review by interim committee.** (1) The following tax credits  
16       must be reviewed during the biennium commencing July 1, 2021, and during each biennium commencing 8  
17       years thereafter:

18 (a) the credit for donations to innovative educational programs provided for in 15-30-2334, 15-30-  
19 3110, and 15-31-158;

20 (b) the credit for donations to a student scholarship organization provided for in 15-30-2335, 15-  
21 30-3111, and 15-31-159; and AND

22 (c) the adoption tax credit provided for in 15-30-2321; and

23 (d) the child tax credit provided for in [section 1];

24 (e) the credit for child care workers provided for in [section 2]; and

25 (f) the business-supported dependent care credit provided for in [sections 3 and 4].

26 (2) The following tax credits must be reviewed during the biennium commencing July 1, 2013.
