8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	Section 1. Section 13-27-302, MCA, is amended to read:
11	"13-27-302. Certification of signatures. (1) An affidavit, in substantially the following form, must be
12	attached to each sheet or section submitted to the county official:
13	I, (name of person who is the signature gatherer), swear that I gathered the signatures on the petition
14	to which this affidavit is attached on the stated dates, that I believe the signatures on the petition are genuine,
15	are the signatures of the persons whose names they purport to be, and are the signatures of Montana electors
16	who are registered at the address or have the telephone number following the person's signature, and that the
17	signers knew the contents of the petition before signing the
18	petition(Date on which the first signature was
19	gathered)(Signature of petition signature
20	gatherer)(Address of petition signature gatherer)
21	Subscribed and sworn to before me this day of, 20
22	Seal(Person authorized to take
23	oaths)(Title or notarial information)
24	(2) (a) (i) The FOR AN AFFIDAVIT PROVIDED FOR IN SUBSECTION (1) THAT IS ATTACHED TO A SIGNATURE
25	SHEET WITH A COLLECTED SIGNATURE DATED 287 DAYS OR MORE PRIOR TO THE FINAL DATE PROVIDED IN 13-27-104
26	FOR FILING THE PETITION, THE SIGNATURE GATHERER OR AN AGENT OF THE GROUP GATHERING SIGNATURES SHALL
27	SUBMIT THE AFFIDAVIT AND THE SIGNATURE SHEET OR THE SECTION TO WHICH THE AFFIDAVIT IS ATTACHED TO THE
28	COUNTY ELECTION ADMINISTRATOR BY 273 DAYS BEFORE THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE

2	(II) FOR AN AFFIDAVIT PROVIDED FOR IN SUBSECTION (1) THAT IS ATTACHED TO A SIGNATURE SHEET WITH
3	A COLLECTED SIGNATURE DATED 196 DAYS OR MORE PRIOR TO THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE
4	PETITION, THE SIGNATURE GATHERER OR AN AGENT OF THE GROUP GATHERING SIGNATURES SHALL SUBMIT THE
5	AFFIDAVIT AND THE SIGNATURE SHEET OR THE SECTION TO WHICH THE AFFIDAVIT IS ATTACHED TO THE COUNTY
6	ELECTION ADMINISTRATOR BY 182 DAYS BEFORE THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE PETITION.
7	(III) FOR AN AFFIDAVIT PROVIDED FOR IN SUBSECTION (1) THAT IS ATTACHED TO A SIGNATURE SHEET WITH
8	A COLLECTED SIGNATURE DATED 126 DAYS OR MORE PRIOR TO THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE
9	PETITION, THE SIGNATURE GATHERER OR AN AGENT OF THE GROUP GATHERING SIGNATURES SHALL SUBMIT THE
10	AFFIDAVIT AND THE SIGNATURE SHEET OR THE SECTION TO WHICH THE AFFIDAVIT IS ATTACHED TO THE COUNTY
11	ELECTION ADMINISTRATOR BY 112 DAYS BEFORE THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE PETITION.
12	(IV) FOR AN AFFIDAVIT PROVIDED FOR IN SUBSECTION (1) THAT IS ATTACHED TO A SIGNATURE SHEET WITH
13	A COLLECTED SIGNATURE DATED 98 DAYS OR MORE PRIOR TO THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE
14	PETITION, THE signature gatherer or an agent of the group gathering signatures shall submit the affidavit
15	provided for in subsection (1) and the signature sheet or the section to which the affidavit is attached to the
16	county election administrator within 4 weeks of the first collected signature covered by the affidavit BY 84 DAYS
17	BEFORE THE FINAL DATE PROVIDED IN 13-27-104 FOR FILING THE PETITION.
18	(B) ONCE THE AFFIDAVIT PROVIDED FOR IN SUBSECTION (1) IS SUBMITTED, THE ELECTION ADMINISTRATOR
19	SHALL DATE AND TIME STAMP THE AFFIDAVIT, REGISTER IT IN A LOG, AND PROVIDE A RECEIPT OF SUBMISSION TO THE
20	SIGNATURE GATHERER OR AGENT OF THE GROUP GATHERING SIGNATURES.
21	(b)(c) If the affidavit and the signature sheet or the section to which the affidavit is attached are
22	SUBJECT TO THE A DEADLINE IN SUBSECTION (2)(A) AND ARE not submitted within 4 weeks of the earliest signature
23	covered by the affidavit THE TIMELINE REQUIRED UNDER SUBSECTION (2)(A), the county election administrator shall
24	reject the filing and may not process it further."
