

## CONCURRENCE IN SENATE AMENDMENTS

AB 3175 (Levine)

As Amended August 13, 2020

2/3 vote. Urgency

**SUMMARY:**

Provides that an age-eligible minor in the entertainment industry, accompanied by a parent or legal guardian, shall complete a sexual harassment prevention and retaliation training using the online training developed by the Department of Fair Employment and Housing, prior to obtaining a work permit.

**The Senate Amendments:**

- 1) Make minor and clarifying changes.
- 2) Delete the provision that the training be conveyed by a parent or legal guardian to the minor and instead state that the minor shall be accompanied by a parent or legal guardian during the training.
- 3) Add an urgency clause.
