

CONCURRENCE IN SENATE AMENDMENTS

AB 557 (Muratsuchi)

As Amended June 21, 2022

Majority vote

SUMMARY

Creates the Hate Crime Vertical Prosecution Grant Pilot Program, subject to an appropriation by the Legislature, to help prosecuting agencies create, support, or expand vertical prosecution units for hate crime cases.

Senate Amendments

Delete the Assembly version of this bill and instead:

- 1) Create the Hate Crime Vertical Prosecution Grant Pilot Program to be administered by the Department of Justice (DOJ), which will award grants to prosecutorial agencies for the purpose of creating, supporting, or expanding vertical prosecution units for the prosecution of hate crimes.
- 2) Provide that the one-time grants will be made on a competitive basis and that the DOJ will determine the amount of the grants.
- 3) Specify the duties of DOJ in administering the grant program.
- 4) Require each grant recipient to submit a report, as specified, to DOJ by July 1, 2028, and the DOJ to submit a report to the Legislature by January 1, 2029.
- 5) Define "prosecuting agency" as a district attorney, city attorney, or other government entity responsible for the prosecution of crimes within a local jurisdiction.
- 6) Define "vertical prosecution" as having the same individual prosecutor assigned to a case from the time charges are reviewed through sentencing.
- 7) Sunset the grant program on July 1, 2029.

COMMENTS

As passed by the Assembly, this bill:

- 1) Required the establishment of hotlines and online portals to be operated by local agencies and community based organizations, funded through grants provided by DOJ for the purpose of:
 - a) Reporting hate crimes and connecting with local law enforcement agencies;
 - b) Connecting people who experienced or witnessed a hate crime or hate incident to other appropriate local resources;
 - c) Sharing information about the characteristics of hate crimes, and hate incidents, classes of individuals protected under California hate crimes law, civil remedies that may be available for victims of hate crimes, and reporting options.

- 2) Required the hotlines and online portals be accessible to people with disabilities, and people who do not speak English.
- 3) Stated that in awarding grants, DOJ should give preference to community based organizations that represent Asian and Pacific Islander, Black, Latino, Jewish, LGBTQ (lesbian, gay, bisexual, transgender, queer), and Muslim communities.
- 4) Required DOJ to collaborate with grant recipients to develop uniform intake forms and online submission forms, and to provide standardized training to grant recipients regarding the intake, response to, and review of, hate crimes and related incidents.
- 5) Required the grant recipients to provide statistical data regarding hate crimes and related incidents reported to them to the DOJ, and DOJ to compile that information and prepare an annual report to be made available to the public.

According to the Author

"Over the last two years, there has been a dramatic spike in verbal and physical assaults against Asian Americans. According to the latest report from Stop AAPI Hate, over 10,000 anti-Asian hate incidents have occurred nationwide between March 2020 and December 2021 with over 4,000 of those occurring in California. The California Attorney General's Office recommends prosecuting hate crimes vertically – meaning a single prosecutor handles a case from start to finish – to both promote accurate and consistent prosecution and provide continuity for the victim. This bill establishes a pilot grant program for District Attorney offices to create or expand vertical prosecution units for hate crimes. In addition to assigning a single prosecutor to each hate crime case, these units will also connect victims with victim advocates."

Arguments in Support

According to the *Los Angeles County District Attorney's Office*, "The Attorney General's latest report on hate crimes in California recommends that hate crime be prosecuted vertically. Vertical prosecution means a single prosecutor handles a case from start to finish – to both promote accurate and consistent prosecution and provide continuity for the victim."

"AB 557 will help implement this recommendation by establishing a pilot grant program for District Attorney offices to create or expand vertical prosecution units for hate crimes. In addition to assigning a single prosecutor to each hate crime case, these units will also connect victims with victim advocates."

"Vertical prosecution of cases involving vulnerable victims has numerous benefits, each with the potential to improve public safety. With vertical prosecution, victims are able to work with the same prosecutor and investigator from the time potential charges are first reviewed through the sentencing of the offender. Vertical prosecution has shown to improve conviction rates, reduce victim trauma, and provide more consistent, appropriate sentencing. It is therefore considered best practice."

Arguments in Opposition

None submitted.

FISCAL COMMENTS

According to the Senate Appropriations Committee, the DOJ reports costs of approximately \$1 million annually until 2028-29 to establish the Hate Crime Vertical Prosecution Pilot Grant Program (HCVP), for the purpose of creating, supporting, or expanding vertical prosecution units for the prosecutions of hate crimes (General Fund). Staff notes unknown cost pressures, potentially in the millions to tens of millions to the General Fund in 2023-24 and ongoing through 2028-29.
