## SUMMARY

Makes a technical change to proposed SB 2 (Bradford) of the 2021-2022 legislative session to correct a drafting error regarding the collateral estoppel provision, if that bill becomes operative.

### According to the Author

SB 586 fixes a drafting error made by Legislative Counsel to SB 2 (Bradford). The amendment to SB 2, which is the language being corrected by this bill, clarifies that existing law regarding collateral estoppel applies to prior appeal proceedings having preclusive effect on the decertification proceedings created by SB 2. This language was placed in the incorrect section in SB 2, and due to a technical issue we were unable to correct this error by amending SB 2. SB 586 does not substantively change this language, it only moves it to the correct section if SB 2 is enacted.
