

SENATE THIRD READING
SB 105 (Skinner)
As Amended September 11, 2023
Majority vote. Budget Bill Appropriation Takes Effect Immediately

SUMMARY

Amends the 2023 and 2022 budget acts to reflect changes necessary to update the 2023 budget agreement.

Major Provisions

- 1) Removes \$3 million provided to the Department of Industrial Relations to resume the operations of the Industrial Welfare Commission;
- 2) Includes funding authority for federal American Rescue Plan funding provided for afterschool programs;
- 3) Removes an unneeded reappropriation of a 2021 legislative priority administered by the Natural Resources Agency;
- 4) Provides the Energy Commission with spending authority for approximately \$102.8 million in additional federal grant funds;
- 5) Reappropriates federal funds budgeted for the Energy Commission in the 2018 budget Act; and
- 6) Corrects provisional language related to the reappropriation of facilities development funding at the Department of Health Care Access and Information.

COMMENTS

The Legislature typically revisits the June budget package at the end of the legislative session to finalize budget details and address technical issues. The Assembly passed SB 104 (Skinner) on September 8, 2023, which amended the 2022 and 2023 budget acts for this purpose. Subsequent to this action, further changes to the budget bill were requested, specifically to remove \$3 million included in the 2023 budget act to restart the Industrial Welfare Commission's activities. This bill is intended to amend the budget act, assuming the prior adoption and chaptering of SB 104.

Beyond the change to the Industrial Welfare Commission funding, the other provisions of the bill are technical and either correct errors or make it easier for the state to accept federal funding.

This bill amends the budget to remove funding for the Industrial Welfare Commission.
