AB 104 (Gabriel)

As Amended July 14, 2025

Majority vote. Budget Bill Appropriation Takes Effect Immediately

SUMMARY

This Budget Bill makes technical and conforming changes to the Budget Act of 2025-26.

Senate Amendments

Deletes the previous contents of the bill and instead inserts the following provisions:

- 1) Authorizes the California Health Facilities Financing Authority (CHFFA) to extend the repayment period, up to 60 months, for loans issued under the Nondesignated Public Hospital Loan Program. These loans are issued to hospitals that CHFFA determines as unable to meet the repayment deadline specified in their loan and security agreement;
- 2) Reappropriates up to \$5 million from the General Fund and up to \$5 million from the Inmate Welfare Fund, as provided in the Budget Act of 2024, for the California Department of Corrections and Rehabilitation's CARE, Victim Impact, and Innovative Programming Grants, due to delayed disbursements in 2024–25;
- 3) Reappropriates funding provided in the Budget Act of 2022 for the California Conservation Corps Greenwood residential center;
- 4) Reappropriates funding provided for the California School for the Deaf-Riverside: Athletic Complex Replacement and Expansion to avoid pausing the project due to delayed project schedule;
- 5) Aligns Department of Social Services federal funds authority with anticipated federal funds;
- 6) Clarifies that funds provided for the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy are available for encumbrance and expenditure until June 30, 2028;
- 7) Specifies that funds provided for the Children's Holistic Immigration Representation Project and for licensed foster family agencies experiencing increased liability insurance costs are available for encumbrance and expenditure until June 30, 2027;
- 8) Implements the California Tahoe Conservancy's request for reduction in reimbursement authority;
- 9) Includes the list of Community College mandates that are suspended due to the use of the Community College mandates block grant that was incorrectly omitted in the budget act; and

- 10) Makes a variety of corrections including but not limited to the following: correcting the misspelling of "Portsmouth" under 0540-103-0001; correcting project number "008390" under Mather: Headquarters Checkpoint Security Enhancements; and changing "RT" to "ET" 3790-111-0557.

COMMENTS

This bill makes routine technical changes to the 2025 Budget Act to correct and update the bill based upon a careful review of the Department of Finance and Legislative staff. On June 13, 2025, the Legislature approved SB 101 (Wiener), Chapter 4, Statutes of 2025, which represented the Legislature's version of the budget. On June 27, 2025, the Legislature approved AB 102 (Gabriel), Chapter 5, Statutes of 2025, which made changes to SB 101 to reflect the final budget agreement between the Legislature and the Governor. Both bills were signed by the Governor on June 27, 2025.
