Majority vote. Budget Bill Appropriation Takes Effect Immediately

**SUMMARY**

The Budget Act of 2026.

**Senate Amendments**

Amends the bill to include the provisions of the Legislative budget agreement between the Assembly and Senate.

**COMMENTS**

Given the size of the 2026 budget, by custom, the Assembly Budget Committee publishes a comprehensive summary of the budget package in its Floor Report document. This document can be found on the Assembly Budget Committee website.

This bill reflects an agreement between the Senate and Assembly on the 2026 budget package. Assuming this bill's passage, the bill will be sent to the Governor. Typically, the Governor will request amendments to this bill, in lieu of using his line-item veto authority, and a second companion budget bill will accompany this bill when it is chaptered.
