**SUBJECT:** Financial institutions

**DIGEST:** This bill makes nonsubstantive changes to two sections of the Financial Code.

**ANALYSIS:**

Existing State Law:

- 1) Requires a money transmitter to post a notice on the premises of each branch office that gives a customer information on how to submit a complaint to the Department of Financial Protection and Innovation (DFPI) related to money transmission activities conducted at the branch.
- 2) Requires DFPI, on December 1, 2007, to report to the Governor and the Legislature information related to deferred deposit transactions (aka “payday loans”).

This bill

- 1) Updates the address of DFPI in the notice required by the Money Transmission Law related to customer complaints.

2) Deletes the section requiring a report be made on December 1, 2007, by DFPI related to deferred deposit transactions.
