Majority vote. Budget Bill Appropriation Takes Effect Immediately

## **SUMMARY**

This bill exemptions regulations adopted to implement two recent emissions disclosure laws from the California Environmental Quality Act.

#### **Senate Amendments**

Senate amendments gut the bill and replace it with:

- 1) California Environmental Quality Act Exemption. Exempts regulations adopted to implement two recent emissions disclosure laws, SB 253 (Chapter 382, Statutes of 2023) and SB 261 (Chapter 383, Statutes of 2023) from the California Environmental Quality Act, consistent with existing case law.
- 2) *Emission Disclosure Law Funding*. Appropriates \$1,000 from the Greenhouse Gas Reduction Fund to the State Air Resources Board for the implementation of SB 253 (Chapter 382, Statutes of 2023) and SB 261 (Chapter 383, Statutes of 2023).
