AB 170 (Committee on Budget)

As Amended June 26, 2026

Majority vote. Budget Bill Appropriations Takes Effect Immediately

SUMMARY

This bill is housing trailer bill for the 2026-27 Budget. The bill contains various statutory changes related to the Governor's Reorganization Plan (GRP) No. 1 of 2025 necessary to implement the Budget Act of 2026. Specifically, this bill:

Senate Amendments

- 1) Deletes the current contents of the bill, and instead:
- 2) Enacts the statutory changes necessary to reflect portions of the changes in law made by the Governor's Reorganization Plan (GRP) No. 1 of 2025, including:
 - a) Assigning and reorganizing the functions of state government among executive officers and agencies by eliminating the Business, Consumer Services and Housing (BCSH) Agency as of July 1, 2026.
 - b) Establishing the Business and Consumer Services Agency and the California Housing and Homelessness Agency, composed of specified departments that are currently within BCSH, effective July 1, 2026.
- 3) Appropriates \$300,000 to the Department of Housing and Community Development for the purpose of supplementing existing contracts pursuant to statutory requirements to translate specified guidelines.

COMMENTS

- 1) The bill contains various statutory changes related to housing necessary to implement the Budget Act of 2026.
- 2) Additional provisions codifying GRP No. 1 are contained in AB/SB 179.
