SUBJECT: CalFresh: federal government shutdowns

DIGEST: This bill requires the California Department of Social Services (CDSS) to create a landing page on its website that informs the public about the status of CalFresh during a government shutdown that affects CalFresh benefits and requires CDSS to work with stakeholders to create a communications plan for CalFresh recipients and public officials during a government shutdown. This bill also requires CDSS to create a benefit issuance mechanism that allows the department to quickly issue CalFresh benefits during a federal government shutdown that affects CalFresh benefit disbursement.

Assembly Amendments amend the findings and declarations, make the requirement to create a benefit issuance mechanism that allows CDSS to issue CalFresh benefits during a federal government shutdown operative upon appropriation by the Legislature, and increases the timeline for required updates from CDSS.

ANALYSIS:

Existing law:

- 1) Establishes CalFresh as California's implementation of the federal Supplemental Nutrition Assistance Program (SNAP) program. (Welfare and Institutions Code (WIC) § 18900.)
- 2) Declares that every human being has the right to access sufficient affordable and healthy food. (WIC § 18700(a)(1).)
- 3) Establishes the State Emergency Food Assistance Program, administered by CDSS, to provide food and funding for the provision of emergency food to food banks established pursuant to the federal Emergency Food Assistance Program whose ongoing primary function is to facilitate the distribution of food to low-income households. (WIC § 18995.)
- 4) Requires relevant state agencies to develop and implement a statewide electronic benefits transfer (EBT) system to allow recipients of federal or state financial and food assistance because of their economic circumstances or social condition to access their benefits through electronic systems like automated teller machines, point-of-sale devices, or other devices that accept EBT transactions. (WIC § 10065-10072.)
- 5) Requires the Office of Technology and Solutions Integration to implement a statewide automated welfare system (SAWS) for CalWORKs, CalFresh, Medi-Cal, the foster care program, the refugee program, and county medical services programs. (WIC § 10823.)
- 6) Requires the development of SAWS's enrollment and eligibility functionality, case management systems, ancillary services, public portals, and mobile applications to include the goal of minimizing the burden of the overall eligibility process for enrollment and retention of benefits for low-income Californians and streamlining interactions for both clients and eligibility workers and facilitating applicant and client submission of feedback. (WIC § 10823.3.)

This bill:

- 1) Makes findings and declarations regarding the impact of the 2025 federal government shutdown on CalFresh recipients.
- 2) Requires CDSS to maintain a clearly marked landing page on the department's website to provide public information about how CalFresh benefits will be impacted during a government shutdown that affects CalFresh. The website must include at least all of the following:
 - a) The status of the federal government shutdown and the availability of benefits.
 - b) To the extent possible, a timeline with the most updated information possible, including when benefits will be disrupted and which beneficiaries will be affected, as well as when benefits will be disbursed.
 - c) A "Frequently Asked Questions" section addressing questions and misinformation about the availability of benefits.
 - d) Information about where the public can find emergency food assistance including their local food banks.
 - e) Any relevant litigation being pursued by the State of California or other entities related to CalFresh benefits and the federal government shutdown.
- 3) Requires CDSS to consider information gathered from previous federal government shutdowns and information provided by local governments and stakeholders when developing the website landing page.
- 4) Requires CDSS to make accommodations for accessibility and language services for the landing page.
- 5) Requires CDSS to update the landing page at least every 72 hours until CalFresh benefits have been fully dispersed and the government has been restored.
- 6) Requires CDSS to create a strategic communications plan for use during a federal government shutdown that impacts the disbursement of CalFresh benefits in coordination with stakeholders. The communications plan must include at least the following:
 - a) Updates to the landing page on the department's internet website and deployment of social media posts within 72 hours of the department being

notified by the Food and Nutrition Service of the United States Department of Agriculture (USDA) that there will be a disruption in CalFresh disbursement.

- b) Regular updates that includes, but are not limited to:
 - i) The current status of benefit disbursement.
 - ii) How to check their accessible CalFresh benefit balance.
 - iii) Whether the past month's benefit balances are available for use.
 - iv) Where to find factual, updated information on the federal government shutdown and the impacts on the disbursement of CalFresh benefits.
 - v) Where to find emergency food resources.
- c) Emergency response briefings as needed for local and state officials, local government agencies, community organizations, and participating retailers that include:
 - i) The current status of benefit disbursement.
 - ii) Whether the past month's benefit balances are available for use.
 - iii) Pertinent updates on court filings and decisions regarding benefit availability.
 - iv) Where to find factual, updated information to share with the public on the federal government shutdown and the impacts on the disbursement of CalFresh benefits.
 - v) Emergency actions the state is taking, including, but not limited to, additional funding and staffing for food banks.
- 7) Requires CDSS to issue guidance to county human services agencies for use during a federal government shutdown.
- 8) Requires, after the date that the department notifies the Legislature that the Statewide Automated Welfare System can perform the necessary automation to implement this section, CDSS to develop a benefit issuance mechanism that allows the department to rapidly provide nutrition benefits on an emergency basis in response to a federal government shutdown that impacts the disbursement of CalFresh benefits.

- 9) Requires the benefit issuance mechanism to issue nutrition benefits through the EBT system and in a manner that can target various populations depending on the purpose of the specific benefit.
- 10) Requires the mechanism to comply with all applicable state and federal law governing privacy and confidentiality.

Comments

According to the author, “Over 5 million Californians rely on SNAP benefits, known as CalFresh in California. Frequent changes at the federal level, including last year’s government shutdown, have led to rapidly changing information and disruption in CalFresh benefit disbursement. Californians deserve quick and reliable information about essential benefits they rely on to meet their basic needs. SB 1077 will strengthen access to timely, accurate information by requiring CDSS to develop a strategic communications plan in response to federal shutdowns that disrupt the disbursement of CalFresh benefits. The lessons learned from last year’s events can serve as a starting point for building stronger communications systems with all impacted entities. Furthermore, the federal shutdown revealed that the state lacks the necessary infrastructure to issue state-funded benefits to CalFresh recipients on an emergency basis. SB 1077 will address this gap by requiring CDSS to create a mechanism for disbursing state benefits to CalFresh recipients during a future federal shutdown that impacts the disbursement of these benefits, if the Legislature appropriated funds for this purpose.”

CalFresh. CalFresh is California’s version of federal SNAP, an entitlement program that provides eligible households with federally funded monthly benefits to purchase food. Currently, CalFresh food benefits are 100% federally funded, but recent changes in federal law will require states to pay a portion of the benefit. CalFresh administration costs are funded with 50% federal funds, 35% General Fund, and 15% county funds, except for state-mandated program changes. Benefits are delivered through an EBT card which cardholders can use at point-of-sale terminals authorized by the USDA. Grocers and other retailers are paid directly by the federal government for the dollar value of purchases made with CalFresh food benefits. Monthly benefits per household vary based on household size, income, and deductible living expenses—with larger households generally receiving more benefits than smaller households and relatively higher-income households generally receiving fewer benefits than lower-income households. The average benefit in 2025–26 is approximately \$333 a month for all households.

CalFresh is the state’s largest anti-hunger program. In a study on income instability, the Public Policy Institute of California found that CalFresh helped

families get through times of economic instability by providing a stable resource that was most impactful for families if they apply as quickly as possible after their income first becomes unstable versus applying after they have used up all of their savings and still need help.

2025 Federal Government Shutdown. Starting on October 1, 2025, after a failure to pass a continuing resolution to fund the government's operations, the federal government entered a shutdown. This meant many federal employees were furloughed and only essential government operations were allowed to continue. Later that month, the USDA sent a memo to state agencies saying that there was not enough money available to fund CalFresh benefits in November 2025. The USDA also ordered states not to take any action to prepare benefits to be delivered to EBT cards. Specifically, CalSAWS could not transmit the issuance file to the state's EBT vendor as it usually would. However, the USDA did announce they could use contingency reserves, if needed, to fund the benefit. The contingency reserve was created to provide for beneficiaries in circumstances like a federal shutdown. Most recently, in 2024, Congress approved \$3 billion in contingency funds to be available for two years to cover any lapse in SNAP payments. The USDA did not confirm funding for administrative activities, but CDSS did confirm that funding was available to counties. After a policy reversal, the USDA did not use the contingency fund and the federal government did not fund SNAP benefits at the beginning of the month for the first time in the program's history. Several lawsuits were filed against the USDA including one co-led by California Attorney General Rob Bonta. A full discussion of the lawsuits is below.

In addition to filing lawsuits, states across the country, including California, responded to the lapse in federal funding on their own. California, which has approximately 5.2 million SNAP recipients, allocated \$80 million to food banks and deployed the National Guard to distribute food. Actions were also taken locally by counties and school districts to provide emergency meals, provide gift cards, and other supports to CalFresh recipients.

2025 Federal Government Shutdown Timeline. In addition to the uncertainty created by the government shutdown, a significant amount of uncertainty was created by multiple memos from the USDA contradicting earlier advisories and in response to court actions. For CalFresh recipients, learning about the changes through the news led to additional distress and confusion causing them to seek information wherever they could. The benefit pause was also an unprecedented event for state agencies and officials that oversee the program that required a higher level of communication, strategy and nimbleness. This bill requires CDSS to create a communications plan that updates a government shutdown related

webpage and brief officials and stakeholders daily during a government shutdown. It also requires CDSS to create a mechanism to distribute CalFresh benefits if a government shutdown delays the normal disbursement of benefits.

Related/Prior Legislation

AB 2072 (Solache, 2026) would create the CalFresh and Women, Infants, and Children Program Contingency Fund solely for the purpose of maintaining continuity of CalFresh or Women, Infants and Children Program benefits during a federal government shutdown or other federal appropriations lapse would require the departments to seek federal reimbursement for expenditures made from the fund or for loan repayments. The bill was held on the Assembly Appropriations Suspense file.

AB 2309 (Bains, 2026) would, in the event of a federal funding lapse that results in the withholding, suspension, or delay of federally funded CalFresh benefits, require the State Department of Social Services to utilize state funds to ensure that CalFresh benefits continue to be issued to existing recipients. The bill was held on the Assembly Appropriations Suspense file.

According to the Assembly Appropriations Committee:

- 1) “One-time General Fund (GF) automation costs of approximately \$400,000 to \$500,000 for changes to the California Statewide Automated Welfare System (CalSAWS) and the Electronic Benefit Transfer (EBT) system to create a benefits issuance mechanism. CDSS indicates the system changes will require 12 months to implement.
- 2) Minor and absorbable costs to establish a strategic communication plan, issue guidance to counties, and maintain a landing page on the department’s website during a federal government shutdown.
- 3) Future GF cost pressures during each federal government shutdown of an unknown amount but potentially in the low millions of dollars, to implement the initial notification components of the strategic communications plan, including costs for printing, mass mailers, and electronic communication charges.
